Use this document to request an agent assurance code. You need a code if you're a UK-regulated agent that is completing verification checks for overseas entities registering, updating information or applying for removal with Companies House.

An agent assurance code confirms that the UK-regulated agent has authorisation to carry out verification checks on an overseas entity. The agent needs to provide this code when the overseas entity is being registered, or updating information or applying for removal.

If the UK-regulated agent is an organisation, you only need to request one code for the whole organisation. This code can then be used for every overseas entity that the agent carries out verification checks for. You should not share this code with anyone outside your organisation.
