FIGURES ON THE REPORTED AND RECORDED USES OF TASER BY POLICE FORCES IN ENGLAND AND WALES

The reports attached detail TASER usage for the following periods and incident types:

Reports on the use of TASER are broken down into four tables:

- 1. All uses of TASER in England and Wales since introduction in April 2004 up to 31 March 2010 on a cumulative basis (Table 1).**
- 2. All uses of TASER in England and Wales from 1 April 2009 to 31 March 2010 broken down by quarter (Table 2).**
- 3. TASER use by specially trained units from 1 September 2007 to 31 March 2010 on a cumulative basis (Table 3).**
- 4. TASER use by specially trained units from 1 April 2009 to 31 March 2010 broken down by quarter (Table 4).**

NOTES FOR TABLES:

- a) The tables detail the number of uses of TASER – only the highest level of ‘use’ for each TASER deployment is recorded. TASER use as defined by Association of Chief Police Officers (ACPO): TASER Operational Guidance December 2008 policy section 5.2 (available at <http://www.westmercia.police.uk/about-us/acpo-armed-policing.html>)
- b) The tables show the number of TASER ‘uses’ as opposed to the number of TASER ‘incidents’. This is designed to ensure full transparency on TASER deployment as there may be more than one ‘use’ of TASER at an ‘incident’.
- c) Direct comparisons between forces should be drawn with caution for the following reasons:
- Not all forces have participated in the use of TASER during all the periods. For example, this is why not all forces are currently represented in table 3 and 4.
 - The population and size and demographic within each force area varies considerably.
 - TASER deployment forms are not always received in a timely fashion or in chronological order.
 - We cannot be certain that historically all forces have recorded TASER usage in the same way, although this has been mitigated by ACPO issuing clear instructions to forces on reporting procedures (Latest Circular Nov 2008).
- d) All figures are based on forms detailing TASER deployments between the stated dates and submitted by police forces to the Home Office Scientific Development Branch before 01st June 2010. Forms from incidents prior to the reporting period received after the aforementioned date will be included in subsequent reports, thus there may be discrepancies between figures reported each period. Data validation methods include inter-observer reliability and comparative checks of previous reports to assess any anomalies in trends.
- e) In 2004, following a trial in five forces, it was agreed to allow chief officers of all police forces in England and Wales to make **TASER** available to authorised firearms officers. The Home Office announced on 19 July 2007 that authorised police firearms officers in England and Wales would be able to use **TASER** (from 20 July 2007) in a greater set of circumstances. These officers are now able to deploy **TASER** in operations or incidents where the use of firearms is not authorised, but where they are facing violence or threats of violence of such severity that they would need to use force to protect the public, themselves or the subject.

It was also announced in July 2007 that the deployment of **TASER** by specially trained police units who are not firearms officers, but who are facing similar threats of violence, would be trialled in ten police forces.

The 12-month trial commenced on 1 September 2007 and finished on 31 August 2008. It took place in the following forces: Avon & Somerset, Devon & Cornwall, Gwent, Lincolnshire, Merseyside, Metropolitan Police, Northamptonshire, Northumbria, North Wales and West Yorkshire.

Following the success of the trial, from 1 December 2008, **TASER** use was extended to specially trained units in accordance with current Association of Chief Police Officers (ACPO) policy and guidance. This sets out that **TASER** can only be used where officers would be facing violence or threats of violence of such severity that they would need to use force to protect the public, themselves and/or the subject(s).
