## Introduction

This report presents the key trends on the latest twelve months (October 2011 to September 2012) of activity in the Criminal Justice System (CJS) for England and Wales.

All data for January to September 2012 are provisional.
Alongside the publication is a technical document titled "Criminal Justice Statistics: Background, Definitions and Measurement". This document provides users with detailed information on the concepts and methods used in compiling this bulletin, including the quality of the data. Where appropriate, comparisons are made between different sources covering activity in the Criminal Justice System (CJS). In particular, comparisons are made to numbers of crimes recorded by the police (often the starting point for crimes dealt with by other CJS agencies) rather than estimates from the Crime Survey for England and Wales (CSEW). The CSEW provides robust estimates of trends in crimes against the population resident in households, including those never reported to the police, but excludes other crimes such as those against businesses or socalled 'victimless' crime. Therefore police recorded crime provides a more meaningful comparison for measures relating to the wider CJS. Findings from the CSEW and recorded crime are published together in statistical bulletins by the Office for National Statistics.

The data provides users with information about proven offending and its outcomes in England and Wales. The contents of this bulletin will be of interest to government policy makers in the development of policy and their subsequent monitoring and evaluation. Others will be interested in the way different crimes are dealt with in the Criminal Justice System.

Information about statistical revisions, forthcoming changes and the symbols and conventions used in the bulletin are given in the explanatory notes section.

## Main findings

## Overview of the Criminal Justice System in the 12 months ending September 2012

In the 12 months ending September 2012, there were 1.86 million individuals ${ }^{1}$ given an out of court disposal or proceeded against at court. This compares with 2.03 million individuals in the 12 months ending September 2011, a decline of 8.4 per cent. This included a 13.0 per cent fall in the use of out of court disposals (from 444,400 to 386,900 ) - continuing the fall in the use of out of court disposals since the peak in the 12 months ending September $2007(673,800)$.

There was also a 7.1 per cent fall in the number of defendants proceeded against at court (from 1,471,300 to $1,583,400$ ) in the 12 months ending September 2012 from the previous year. This continues the decrease observed since the peak in 12 months ending September 2004, which has been mainly driven by falls in prosecutions for summary offences, which have fallen by 31.1 per cent during this period.

Since the 12 months ending September 2004, convictions for summary offences have fallen largely in line with trends in prosecutions (down 26.1 per cent). Convictions for indictable offences have not followed this pattern however, and since the 12 months ending September 2002 have fluctuated with a high of 344,700 and a low of 307,400 .

## Out of Court Disposals

Since the 12 months ending September 2008, the use of out of court disposals has decreased by 38.0 per cent (from 624,400 to 386,900 in 12 months ending September 2012). The decline in the use of out of court disposals coincided with the replacement in April 2008 of a target to increase offences brought to justice, with one placing more emphasis on bringing serious crime to justice. The latter target was subsequently removed in May 2010.

## Police cautions

There were 205,700 cautions administered in the 12 months ending September 2012 (including juveniles given a reprimand or warnings), representing a 12.5 per cent decrease compared with the 12 months ending September 2011 (235,000). This continues the downward trend in the use of cautions observed since a peak in the 12 months ending September 2007 (367,300). The 12 months ending September 2012 figure represents a 44.0 per cent decrease compared to this peak.

The decrease in cautions between the 12 months ending September 2011 and the 12 months ending September 2012 was largely driven by the decline in cautions administered for indictable offences. In particular, the largest relative decreases observed were for the indictable offence groups robbery and violence against the person, which fell by 31.1 per cent and 24.5 per cent respectively (from 2,700 to 1,800 and 17,800 to 13,500 respectively).

Four in every five cautions issued for indictable offences are for violence against the person, theft and handling stolen goods or drug offences.

## Penalty Notices for Disorder (PNDs) and cannabis warnings

There were 109,600 PNDs issued in the 12 months ending September 2012, a decrease of 15.8 per cent compared with the 12 months ending September 2011 $(130,300)$. Similar to cautions, this continues the downward trend in issues of PNDs observed since a peak in the 12 months ending September 2007. The 12 months ending September 2012 figure represents a 48.9 per cent decrease compared with the 12 months ending September $2007(214,400)$.

PNDs issued for possession of cannabis have risen year-on-year since coming into effect in 2009. There was a less than one per cent increase in the 12 months ending September 2012 compared with the 12 months ending September 2011, suggesting the large increases seen in previous years since their introduction may be levelling off. However, cannabis warnings decreased by 7,600 (from 79,200 to 71,600, a 9.6 per cent decline) over the same period.

## Court proceedings and sentencing

In the 12 months ending September 2012 there were 1.47 million defendants proceeded against in magistrates' courts and 1.23 million offenders convicted of a criminal offence at all courts. Prosecutions and convictions peaked in the 12 months ending September 2004, and both have since fallen by 28.6 per cent and 21.5 per cent respectively. These falls have largely been driven by declines in proceedings for summary non motoring and summary motoring offences.

For the more serious indictable offences, prosecutions have fallen by 26.5 per cent since September 2002, but the number of convictions remained broadly flat over the same period. As a result, the conviction ratio for indictable offences increased from 65.3 per cent in September 2002 to 82.6 per cent in the 12 months ending September 2012 - the highest ratio in 11 years.

Looking over the past year, there were 7.1 per cent fewer proceedings in the 12 months ending September 2012 (compared to 1.58 million in the previous 12 month period). This in turn resulted in a decrease of 6.8 per cent in offenders convicted and sentenced.

In the 12 months ending September 2012, there were:

- 377,000 prosecutions and 311,600 convictions for indictable offences - a decrease of 10.9 and 9.5 per cent compared with the previous 12 month period.
- 578,200 prosecutions and 470,200 convictions for summary non-motoring offences - a decrease of 3.6 per cent and 4.0 per cent respectively compared with the previous 12 month period.
- 516,100 prosecutions and 447,200 convictions for summary motoring offences - a decrease of 7.9 per cent and 7.8 per cent respectively compared with the previous 12 month period.

## Immediate custody

In the 12 months ending September 2012, there were 97,500 persons sentenced to immediate custody, a decrease of 4.7 per cent from 102,300 persons in the same period a year earlier and 12.6 per cent lower than the peak over the last 11 years of 111,500 persons sentenced to immediate custody in the 12 months ending September 2002.

While absolute numbers of persons sentenced to immediate custody have decreased in recent years, the immediate custody rate (the proportion of those sentenced who are sentenced to immediate custody) has risen from a low of 6.6 per cent in the 12 months ending September 2007 to 8.0 per cent in the 12 months ending September 2012. This illustrates that, since 2007, the overall number of offenders sentenced at court has decreased faster than the number of persons sentenced to immediate custody.

In the 12 months ending September 2012, there were 1,218 indeterminate sentences (either a life sentence or an Indeterminate sentence for Public Protection - an IPP) handed down, a 1.1 per cent decrease from 1,232 in the same period a year earlier. This continued the fall since the Criminal Justice and Immigration Act (CJIA) 2008 was introduced, which restricted the use of IPPs. Within this group, the number of life sentences increased from 365 in the 12 months ending September 2011 to 426 in the 12 months ending September 2012. The decrease in indeterminate sentences has coincided with an increase in longer determinate sentences. In the 12 months ending September 2012, there were 690 custodial sentences of over 10 years and less than life handed down, a 10.2 per cent increase from 626 in the same period a year earlier.

In the 12 months ending September 2012, the Average Custodial Sentence Length (ACSL) was 14.9 months, an increase of 0.6 months compared to the 12 months ending September 2011, and an increase of 2.5 months compared to the 12 months ending September 2002. In addition to the increase in determinate sentences of over ten years and less than life, the rise in ACSL has been driven by the change in the case mix of people getting custodial sentences and longer sentences for indictable offences:

- In the 12 months ending September 2002, summary motoring offences accounted for 15.3 per cent of immediate custodial sentences, with an ACSL of 3.4 months. By the 12 months ending September 2012, they accounted for just 3.0 per cent of immediate custodial sentences, with a reduction in ACSL to 3.1 months.
- In the 12 months ending September 2002, indictable offences accounted for 76.2 per cent of immediate custodial sentences, with an ACSL of 15.2 months. By the 12 months ending September 2012, they accounted for 83.2 per cent of immediate custodial sentences, with an increase in ACSL to 17.4 months. In particular, sexual offences saw a rise in ACSL from 39.6 months in the 12 months ending September 2004 to 54.2 months in the 12 months ending September 2012, following the implementation of the Sexual Offences Act 2003.

Fines
Fines are the most common sentence passed at court, accounting for around twothirds of all sentences handed down by the criminal courts ( 66.5 per cent in the 12 months ending September 2012). In the 12 months ending September 2012, there were 816,600 fines handed down ( 99.8 per cent of these being issued at magistrates' courts), a decrease of 5.2 per cent from the same period a year earlier and the lowest number of fines handed out over the last 11 years.

The majority of fines issued in the 12 months ending September 2012 were for summary offences, with only 6.6 per cent issued for indictable offences.

The fine rate of 66.5 per cent is broadly consistent with that seen in the same period a year earlier, and has declined from a peak of 70.3 per cent in the 12 months ending September 2004. The decline has been due to a decline in prosecutions and subsequent conviction for summary motoring offences - the offence type for which fines are most commonly given.

## Suspended Sentences and Community Orders

In the 12 months ending September 2012, 153,900 people (or 12.5 per cent of persons sentenced) were given a Community Sentence, a decrease of 14.0 per cent from the same period a year earlier.

In the 12 months ending September 2012, 44,400 people (or 3.6 per cent of persons sentenced) were given a Suspended Sentence Order, a decrease of 8.8 per cent from the same period a year earlier.

## Offending histories

This section provides an overview of the changing structure of the known offending population with information on the breakdown of offences committed by new offenders and repeat offenders, the trends in new entrants to the criminal justice system, and breakdowns of the criminal histories of cautioned and sentenced offenders.

Key points in the 12 months ending September 2012:

- There were 187,700 first time entrants to the criminal justice system (offenders who received their first conviction or caution). This is down 12.8 per cent from the year ending September 2011 and 43.6 per cent from the peak of 332,800 first time entrants in the year ending September 2007.
- The reduction in the number of first time entrants seen over the last five years has been much sharper for juveniles, down 71.5 per cent since the year ending September 2007, than for adults, down 29.7 per cent in the same period.
- The rate of first time entrants per head of population has also fallen substantially amongst juveniles, down from a little over 2,000 per 100,000 population in the 12 months ending September 2007 to an equivalent figure of 595 in the most recent period. However, although the gap is narrowing, the rate still remains higher for juveniles than for adults (353 per 100,000).
- Around four times as many juvenile first time entrants receive a reprimand or warning from the police than are convicted by a criminal court. Amongst adult first time entrants, the proportions receiving a caution and being convicted are roughly equal.
- 15.0 per cent of juveniles sentenced for indictable offences were first time entrants, while 64.5 per cent had between one and six previous convictions, reprimands or warnings and 4.3 per cent had 15 or over previous convictions, reprimands or warnings. For adults, 9.3 per cent were first time entrants, while 36.3 per cent had 15 or more previous convictions or cautions.
- The proportion of juveniles sentenced for indictable offences with 15 or more previous convictions, reprimands or warnings has fallen slightly compared to the 12 months ending September 2011, but has increased by 2.7 per cent since the 12 months ending 2002. For adults, the proportion with 15 or more previous convictions or cautions has increased 13.5 per cent since the 12 months ending 2002.
- 39.2 per cent of offenders sentenced for indictable offences with 15 or more previous convictions or cautions were sentenced to immediate custody while 19.9 per cent were given a community sentence. This compares to 25.6 per cent and 34.6 per cent respectively for those first time entrants sentenced.

## Offences

This section differs from the previous section in that it considers the total number of notifiable ${ }^{2}$ offences.

Much of the activity in the Criminal Justice System starts with the police, when a crime is reported, investigated and detected. The Home Office report on the police activity and the crimes they deal with. In the 12 months ending September 2012, recorded crime decreased by 7.1 per cent, from 4.05 million in the 12 months ending September 2011, to 3.76 million offences.

Over the same period, for the equivalent notifiable offences, the use of out of court disposals decreased by 12.2 per cent. Specifically, Penalty Notices for Disorder (PNDs) were down 17.7 per cent, cautions decreased 11.1 per cent and cannabis warnings reduced by 9.6 per cent. Convictions for notifiable offences also decreased, by 6.0 per cent.

## Out of court disposals

## Penalty Notices for Disorder

Penalty Notices for Disorder (PNDs) are more commonly known as 'on the spot fines'. PNDs are a fixed penalty of $£ 50$ or $£ 80$ designed to tackle low-level, anti-social and nuisance offending for offenders aged 16 or over and are issued for a range of minor offences.

There were 109,600 PNDs issued for the 12 months ending September 2012, a decrease of 15.8 per cent compared with the 12 months ending September 2011 and a fall of 48.9 per cent when compared with the peak of 214,400 PNDs issued in the 12 months ending September 2007.

Four offences accounted for 88.9 per cent of all PNDs issued in the 12 months ending September 2012, namely:

- 'Drunk and disorderly' - 30.7 per cent ( 33,600 );
- 'Retail theft of goods' - 26.6 per cent of all PNDs issued $(29,200)$;
- 'Behaviour likely to cause harassment, alarm or distress' -17.2 per cent $(18,900)$
- 'Possession of cannabis' - 14.4 per cent $(15,800)$ of all PNDs issued.

There has been a year-on-year decrease in PNDs since their peak in the 12 months ending September 2007. This decreasing trend has been observed in all offence groups except possession of cannabis, which has increased year-on-year since coming into effect in 2009. However, the decrease in cannabis warnings over the same period suggests that the use of out of court disposals for those in possession of cannabis has remained constant, but with an increased usage of PNDs rather than cannabis warnings.

In the 12 months ending September 2012, 105,200 (95.9 per cent) of PNDs were issued to persons aged 18 and over (adults), with 4,500 (4.1 per cent) issued to persons aged 16 to 17 . The proportion of PNDs issued to adults has increased year on year since 2007, due to larger decreases in issues of PNDs for the main offence categories listed above for persons aged 16 to 17 than for adults.

In the 12 months ending September 2012, 83,700 (76.4 per cent) of PNDs were issued to males and 25,900 ( 23.6 per cent) to females. The four most common offences committed by males were:

- 'Drunk and disorderly' - 27,900 (33.3 per cent);
- 'Behaviour likely to cause harassment, alarm or distress' - 16,200 (19.3 per cent);
- 'Retail theft of goods' - 15,500 (18.5 per cent) and
- 'Possession of cannabis' - 14,900 (17.7 per cent).

The four most common offences committed by females were:

- 'Retail theft of goods’ - 13,700 (53.0 per cent);
- 'Drunk and disorderly' - 5,800 (22.3 per cent);
- 'Behaviour likely to cause harassment, alarm or distress' - 2,700 (10.6 per cent); and
- 'Wasting police time' - 1,000 (3.8 per cent).

In the 12 months ending September 2012, 76,100 (69.4 per cent) of PNDs were issued to white people, 2,000 ( 1.9 per cent) to black people, 5,500 ( 5.0 per cent) to Asian people, and 5,200 (4.7 per cent) to 'other' ethnicities. The remaining 20,900 (19.0 per cent) had ethnicity unknown. This split has remained fairly constant over the years for the high volume offences.

There were fewer PNDs issued in 38 of the 44 police force areas (including British Transport Police) in England and Wales compared with the 12 months ending September 2011.

The largest absolute decrease was in the Metropolitan Police Force area, where 14,300 PNDs were issued, a fall of 3,020 (17.4 per cent) since the 12 months ending September 2011. The largest proportionate decrease was in Greater Manchester, where 31.3 per cent fewer PNDs were issued, a fall from 6,048 to 4,155 . The police force area with the largest absolute increase was West Yorkshire, where 3,514 PNDs were issued, an increase of 1,024 ( 41.1 per cent) since the 12 months ending September 2011.

## Penalty Notices for Disorder payments, court hearings and related fines

Once a PND has been issued the recipient has 21 days, the Suspended Enforcement Period (SEP), in which to either pay the penalty or request a court hearing. No admission of guilt is required and by paying the penalty the recipient discharges liability for conviction for the offence. Rather than paying the penalty, PND recipients can request a court hearing. If a recipient fails to pay a PND or elect a court hearing within the SEP, a fine of one and half times the penalty amount is registered by the court.

During the 12 months ending September 2012, a number of forces have moved to a new system for reporting data on PNDs issued and their outcomes. Due to technical problems, for these forces, it is not possible to separate between those PNDs paid in full within 21 days and those paid in full outside the 21 day period. The issue is under investigation and is expected to be resolved ahead of the 2012 annual publication.

In the 12 months ending September 2012, 38.8 per cent of PNDs were paid in full within the SEP, 11.7 per cent were paid in full outside the SEP, and a further 2.8 per cent were paid before a fine was registered but with the payment timing unknown. The payment rate for PNDs has fluctuated only slightly since their introduction in 2004, between the 52 and 55 per cent marks.

The payment rate for juveniles (aged 16 and 17) in the 12 months ending September 2012 was 54.9 per cent, compared to 53.2 per cent for adults. The payment rate for juveniles has remained consistently higher than for adults since the start of the scheme.

Around one per cent of penalty notices have been contested at court in each year since PNDs were introduced. This figure is consistent among all age groups and offences.

In the 12 months ending September 2012, of the total number of PNDs issued, 36.9 per cent were registered with a fine (37.1 per cent for adults and 31.5 per cent for juveniles). The number and proportion of PNDs for which a fine was registered has declined year-on-year since 2007, from 92,900 (43.3 per cent of total issued) in the 12 months ending September 2007 to 40,400 (36.9 per cent of total issued) in the 12 months ending September 2012.

## Cautions

A caution can be administered when there is sufficient evidence for a conviction and it is not considered to be in the public interest to institute criminal proceedings. Additionally, an offender must admit guilt and consent to a caution in order for one to be administered. A formal caution may be given by, or on the instructions of, a senior police officer. Cautions have traditionally been mostly used for juvenile and first time offenders. A system of reprimands and final warnings replaced cautioning for juveniles in June 2000.

There were 206,000 cautions issued in the 12 months ending September 2012, 12.5 per cent fewer than in the 12 months ending September 2011, continuing a downward trend in the use of cautions since a peak in the 12 months ending September 2007. This coincided with the replacement in April 2008 of a target to increase offences brought to justice, with one placing more emphasis on bringing serious crime to justice.

Compared with the 12 months ending September 2011 there were decreases in cautions given for both indictable ( 14.3 per cent decrease) and summary offence types (10.4 per cent decrease).

In the 12 months ending September 2012 there were 206,000 offenders cautioned, including juveniles given a reprimand or final warning.

- This was 12.5 per cent fewer than the 235,000 cautions issued in the 12 months ending September 2011, and 44.0 per cent fewer than the peak of 367,000 cautions issued in the 12 months ending September 2007.
- The largest decrease compared with the 12 months ending September 2011 was in cautions issued for the indictable offence robbery which decreased by 31.3.
- Around four in every five cautions issued for indictable offences are for violence against the person, theft and handling or drug offences. Of the 108,000 cautions issued for indictable offences in the 12 months ending September 2012, 37.0 per cent were for drug offences, 33.4 per cent for theft and handling and 12.4 per cent for violence against the person.

The cautioning rate ${ }^{3}$ for the 12 months ending September 2012 was 20.9 per cent, this has declined from a peak of 31.6 per cent in the 12 months ending September 2007. This coincided with the replacement in April 2008 of a target to increase offences brought to justice with one placing more of an emphasis on targeting serious crime.

The cautioning rate varies across offence group and is typically higher for indictable offences than summary offences.

Within indictable offences, the cautioning rate is highest for drug offences (41.1 per cent), criminal damage (39.5 per cent) and violence against the person (26.5 per cent), and is lowest for robbery (2.1 per cent).

The cautioning rate for violence against the person in the 12 months ending September 2012 is the lowest in the eleven year period, at 26.5 per cent. There have been steady annual decreases from a peak of 57.7 per cent of offenders receiving a caution in the 12 months ending September 2006.

## Court proceedings

Virtually all criminal court cases start in a magistrates' court and less serious offences can be handled entirely within this court.

There were 1.47 million defendants proceeded against at magistrates' courts in the 12 months ending September 2012, a decrease of $7.1 \%$ from the 1.58 million proceedings in the 12 months ending September 2011.

The total proceedings figure can be split into two offence groups - summary proceedings, which cover the less serious offences such as TV license evasion and common assault, and indictable proceedings (including triable-either-way offences), which cover the more serious offences. Compared to the previous 12 months proceedings for both offence groups decreased in the 12 months ending September 2012 - a drop of 5.7 per cent for summary offences (from 1.16 million to 1.09 million) and a drop of 10.9 per cent for indictable offences (from 423,100 to 377,000 ).

Summary proceedings can be dealt with entirely within the magistrates' courts and make up around three quarters of all proceedings ( 74.4 per cent). Of the 1.09 million summary proceedings completed in the 12 months ending September 2012, just under half ( 516,100 , or 47.2 per cent) of these proceedings related to summary motoring proceedings, which include offences such as speeding, driving while disqualified and drunk driving.

The 5.7 per cent drop in proceedings for summary offences between the 12 months ending September 2011 and 2012 is not split evenly between summary motoring and summary non-motoring proceedings:

- Defendants proceeded against for summary motoring offences fell by 7.9 per cent from 560,400 to 516,100.
- Defendants proceeded against for summary non-motoring offences fell by 3.6 per cent from 599,900 to 578,200.

Over the past decade, defendants proceeded against peaked at 2.06 million in the 12 months ending September 2004. Compared to this peak there were 28.6 per cent fewer defendants proceeded against in the 12 months ending September 2012. This was made up of a 20.0 per cent decrease in those proceeded against for indictable offences, a 14.6 per cent decrease in those proceeded against for summary nonmotoring offences, and a decrease of 43.4 per cent decrease in those proceeded against for summary motoring offences.

The falling numbers in those proceeded against is reflected in all offence types over the past decade with the exceptions of sexual offences and drug offences that have seen increases. The largest decreases for indictable offences has been criminal damage, representing a 58.3 per cent decrease from 18,700 in the 12 months ending September 2002 to 7,800 in the 12 months ending September 2012. For summary offences, motoring offences have decreased by 33 per cent from 778,600 in the 12 months ending September 2002 to 516,100 in the 12 months ending September 2012.

Of the 1.47 million defendants proceeded against at magistrates' courts in the 12 months ending September 2012, 1.06 million were male. The number of males proceeded against has continued to fall from a peak in the 12 months ending 2004 of 1.69 million, representing a decrease of 37.3 per cent. However the number of female defendants proceeded against has been variable from a low of 322,500 in the 12 months ending September 2002 to a peak of 367,100 in the 12 months ending September 2010. This has led to a fall in the proportion of male defendants proceeded against compared to females from a peak of 82.3 per cent in the 12 months ending September 2003 to 71.9 per cent in the 12 months ending 2012.

## Remands

Police remands are the decisions made by a police officer on whether to detain or bail a defendant pending their first appearance in court or send a notice summoning them to appear in court. Court remands are the court's decision on whether a defendant charged with a criminal offence should be held in custody or released on bail during the period up to and including the trial, or while awaiting sentence.

Defendants are more likely to be remanded in custody for indictable offences than summary offences. As a result the proportion of defendants remanded in custody at the Crown Court is higher than at magistrates' courts.

## Police remands

In the 12 months ending September 2012, there were 1.54 million defendants directed to appear at magistrates' courts ${ }^{4}$, a decrease of 7.6 per cent compared with the 1.66 million in the 12 months ending September 2011. Of these, 30.6 per cent were granted bail by the police, 11.5 per cent were remanded in custody and the remaining 57.9 per cent directed to appear via summonses.

[^6]The proportion of defendants remanded in custody has increased every year since the 12 months ending September 2007, driven mainly by the rise in defendants remanded in custody for indictable offences.

The proportion of those remanded in custody varies by offence type:

- 28.9 per cent $(120,400)$ for indictable offences in the 12 months ending September 2012, 0.6 percentage points higher than in the 12 months ending September 2011 and 12.9 percentage points higher than in the 12 months ending September 2007;
- 7.4 per cent $(43,700)$ for summary non-motoring offences in the 12 months ending September 2012, 0.1 percentage points lower than in the 12 months ending September 2011 and;
- 2.2 per cent $(11,700)$ for summary motoring offences, 0.7 percentage points higher than in the 12 months ending September 2011.


## Magistrates' courts

In the 12 months ending September 2012, 1.54 million defendants, including those who failed to appear, were proceeded against at magistrates' courts. Of these it was estimated ${ }^{5}$ that:

- bail was granted to 27.4 per cent, 6.0 percentage points lower than in the 12 months ending September 2011. This decrease in the proportion granted bail is a reversal of the upward trend seen in previous years;
- 3.2 per cent were remanded in custody, 0.1 per cent lower than in the 12 months ending September 2011; and
- the remaining 69.3 per cent had their case concluded at the magistrates' courts without being remanded, 6.0 percentage points higher than in the 12 months ending September 2011.

The proportion of defendants remanded in custody at magistrates' courts has remained broadly consistent between 2.7 and 3.8 per cent since the 12 months ending September 2005.

The proportion of defendants remanded in custody by magistrates' courts by offence type in the 12 months ending September 2012 was 9.0 per cent $(37,700)$ for indictable cases, 1.7 per cent $(10,100)$ for summary non-motoring offences and 0.4 per cent $(2,100)$ for summary motoring offences.

## Outcomes of cases dealt with by magistrates' courts

Of the 1.06 million defendants not remanded by magistrates in the 12 months ending September 2012:

- a custodial sentence was given to 2.3 per cent $(24,300)$;
- 3.5 per cent $(37,500)$ were committed to the Crown Court for sentence or trial;
- those acquitted or not proceeded against accounted for 13.8 per cent $(146,700)$;
- a further 77.6 per cent $(826,400)$ were given a non-custodial sentence.

Of the 420,800 defendants remanded on bail:

- a custodial sentence was given to 3.0 per cent $(12,400)$;
- 11.8 per cent $(49,800)$ were committed to the Crown Court for sentence or trial;
- $\quad 18.2$ per cent $(76,400)$ were acquitted or not proceeded against;
- a further 59.5 per cent $(250,100)$ were given a non-custodial sentence.

Of the 49,900 defendants remanded in custody:

- a custodial sentence was given to 15.3 per cent $(7,600)$;
- a further 26.2 per cent $(13,000)$ were given a non-custodial sentence;
- 41.1 per cent $(20,500)$ were committed to the Crown Court for sentence or trial;
- those acquitted or not proceeded against accounted for 12.7 per cent $(6,300)$.


## Crown court remands

In the 12 months ending September 2012, the proportion of defendants tried at the Crown Court who were remanded on bail was 48.8 per cent. This represented a decrease of 2.5 percentage points from the 12 months ending September 2011 (51.3 per cent). Between the 12 months ending September 2011 and the 12 months ending September 2012, the proportion of defendants remanded in custody decreased by 0.2 percentage points from 34.4 per cent to 34.2 per cent.

## Outcomes of cases dealt with at the Crown Court

Of the 39,000 defendants remanded in custody by the Crown Court in the 12 months ending September 2012:

- a sentence was given to 86.5 per cent - 74.1 per cent of those remanded in custody received a custodial sentence $(28,900)$;
- those acquitted or not proceeded against accounted for 11.9 per cent $(4,700)$.

Of the 55,800 defendants remanded on bail by the Crown Court in the 12 months ending September 2012:

- a sentence was given to 73.5 per cent - of which 25.3 per cent received a custodial sentence $(14,100)$;
- those acquitted or not proceeded against accounted for 24.0 per cent $(13,400)$


## Failure to appear

Each year a proportion of defendants fail to appear in court having been summonsed to appear or granted bail. The court will issue the police with a warrant for the apprehension and detention of these defendants.

In the 12 months ending September 2012, approximately 63,800 defendants failed to appear to bail or summons at magistrates' courts; 4.2 per cent of those directed to appear in that period. In the 12 months ending September 2012, approximately 2,400 defendants failed to appear to bail at the Crown Court, 2.1 per cent of all defendants due to stand trial or to be sentenced at the Crown Court in the same period.

## Failure to Appear warrants (outstanding)

Failure to Appear (FTA) warrants are issued by courts when defendants do not attend court on a specified date having either been summonsed or granted bail at an earlier stage. Police forces attempt to execute warrants by locating and apprehending the defendant. These may relate to defendants who failed to appear at court during a different period.

The overall number of FTA warrants outstanding ${ }^{6}$ in England and Wales has been steadily decreasing, from 25,300 at the end of September 2008 to 16,800 at the end of September 2012, a 33.3 per cent fall.

The largest fall in FTA warrants was observed for Category ${ }^{7} \mathrm{C}$ warrants which decreased by 54.0 per cent, from just over 8,000 at the end of September 2008 to 3,700 at the end of September 2012. The corresponding decreases for the number of outstanding Category A and Category B warrants were 13.2 per cent and 26.9 per cent respectively over the same time period.

## Offenders found guilty

A conviction is where a person or a company is found guilty of a criminal offence at either the magistrates' courts or the Crown Court.

## Trends in convictions

There were 1.47 million defendants' proceeded against at magistrates' courts in the 12 months ending September 2012, resulting in 1.23 million offenders convicted and sentenced. This compares with 1.58 million proceedings ( 7.1 per cent decrease) and 1.32 million convictions ( 6.8 per cent decrease) in the 12 months ending September 2011.

In 12 months ending September 2012, there were:

- 377,000 prosecutions and 311,600 convictions for indictable offences - a decrease of 10.9 and 9.5 per cent respectively compared to the same period for the previous year. Prosecutions for indictable offences peaked at 512,800 in the 12 months ending September 2002 and have fallen by 26.5 per cent since, while convictions have remained broadly stable between 307,400 and 344,700.
- 578,200 prosecutions and 470,200 convictions for summary non-motoring offences - a decrease of 3.6 per cent and 4.0 per cent respectively since the 12 months ending September 2011.
- 516,100 prosecutions and 447,200 convictions for summary motoring offences a decrease of 7.9 per cent and 7.8 per cent respectively since 12 months ending September 2011, and a continuation of the falls in both prosecutions and convictions for summary motoring offences since 12 months ending September 2004.

Convictions for indictable offences accounted for 25.4 per cent of the total offenders found guilty in the 12 months ending September 2012. This proportion increased year on year from 20.5 per cent in the 12 months ending September 2005 to 26.1 per cent in the 12 months ending September 2011. In the 12 months ending September 2012, summary non-motoring offences accounted for 38.3 per cent, and summary motoring offences accounted for 36.4 per cent of all convictions respectively.

## Convictions by offence group

All ten indictable offence groups showed a decrease in number of convictions in the 12 months ending September 2012 compared to the 12 months ending September 2011.

## Conviction demographics

A total of 883,000 males were found guilty in the 12 months ending September 2012, accounting for 72.2 per cent of all persons convicted. This compares with 292,000 females found guilty, 23.9 per cent of all persons. The proportion of convictions accounted for by males has decreased by 10.0 percentage points from 82.2 per cent in the 12 months ending September 2003.

A total of 50,100 juveniles (those aged 10 to 17) were found guilty during the 12 months ending September 2012 (4.1 per cent of all persons found guilty).

In the 12 months ending September 2012, there were 310,900 persons found guilty of an indictable offence, of which 90.4 per cent were of a known ethnicity. This represents a 39.6 percentage point increase in known ethnicity since 2008, the year in which the LIBRA case management system was rolled out in magistrates' courts.

For all indictable offences, 10.3 per cent of offenders of a known ethnicity were black, though this varied by offence type - ranging from 5.0 per cent for Criminal damage to 26.5 per cent for Robbery.

## Conviction ratio

The conviction ratio is defined as the proportion of defendants proceeded against who were found guilty. In the 12 months ending September 2012, the conviction ratio for all offences was 83.5 per cent, an increase of 0.2 percentage points compared to the 12 months ending September 2011. The overall conviction ratio has risen by 9.9 percentage points since the 12 months ending September 2002.

Compared to the 12 months ending September 2011, in the 12 months ending September 2012, there was:

- an increase of 1.2 percentage points in the conviction ratio for indictable offences (82.6 per cent in the 12 months ending September 2012).
- a decrease of 0.3 percentage points in the conviction ratio for summary nonmotoring offences (81.3 per cent in the 12 months ending September 2012).
- an increase of 0.1 percentage points in the conviction ratio for summary motoring offences ( 86.6 per cent in the 12 months ending September 2012).

In the 12 months ending September 2012, the conviction ratio increased for nine of the ten indictable offence groups compared to the 12 months ending September 2011. Compared to the 12 months ending September 2002, conviction ratios have risen for all indictable offence groups. The largest increase has been for Violence against the person, which has increased by 25.4 percentage points from a conviction rate of 47.8 per cent to 73.2 per cent across the 11 year period.

## Sentencing

When someone is convicted of a crime, they will be given a sentence by a court which reflects the seriousness of the offence or offences committed by the offender. Sentences are generally time spent in prison, a community sentence, a fine or discharge.

In the 12 months ending September 2012, there were 1.23 million offenders sentenced following a criminal conviction, a decrease of 6.8 per cent from 1.32 million offenders sentenced in the 12 months ending September 2011. The public disorder of August 2011 had little impact on these figures as those convicted for the public disorder accounted for less than one per cent of offenders in the 12 months ending September 2012.

Compared to the 12 months ending September 2011, there was:

- a decrease of 5.9 per cent in offenders sentenced for summary offences ( 917,700 compared to 975,300 ) and a decrease of 9.5 per cent in offenders sentenced for indictable offences ( 310,200 compared to 342,800 ).
- a decrease of 6.7 per cent in offenders sentenced at magistrates' courts (1,134,100 compared to $1,215,300$ ) and a decrease of 8.7 per cent in offenders sentenced at the Crown Court ( 93,900 compared to 102,800 ).


## Sentence outcomes for all offences

Over the 11 year period, there has been an increase in the number of Suspended Sentence Orders (SSO) reflecting the change in legislation when it was introduced on 4 April 2005.

[^10]Although the SSO should only be used where the court is minded to pass a custodial sentence of less than 12 months, the increase in offenders sentenced with a SSO has not been offset by a similar decrease in offenders sentenced with a custodial sentence of less than 12 months.

## Custodial sentences

In the 12 months ending September 2012, there were 97,500 persons sentenced to immediate custody, a decrease of 4.7 per cent from 102,300 persons in the same period a year earlier and 12.6 per cent lower than the peak of 111,500 persons sentenced to immediate custody in the 12 months ending September 2002. In the latest period, 44,500 custodial sentences were imposed at magistrates' courts and 53,000 were imposed at Crown Courts, decreases of 5.3 per cent and 4.2 percent respectively compared to the same period a year earlier.

While absolute numbers of persons sentenced to immediate custody have decreased in recent years, the immediate custody rate (the proportion of those sentenced who are sentenced to immediate custody) has risen from a low of 6.6 per cent in the 12 months ending September 2007 to 8.0 per cent in the 12 months ending September 2012. This illustrates the fact that, since 2007, the overall number of offenders sentenced at court has decreased faster than the number of persons sentenced to immediate custody.

There were, 1,218 indeterminate sentences (either a life sentence or an Indeterminate sentence for Public Protection - an IPP) handed down in the 12 months ending September 2012, a 1.1 per cent decrease from 1,232 in the same period a year earlier. This continued the fall since the Criminal Justice and Immigration Act (CJIA) 2008 was introduced, which restricted the use of IPPs. However, within this group, over the last 12 months the number of life sentences has increased by 16.7 per cent ( 426 in the 12 months ending September 2012, compared to 365 in the same period a year earlier). The decrease in indeterminate sentences has coincided with an increase in longer determinate sentences. In the 12 months ending September 2012, there were 690 custodial sentences of over 10 years and less than life handed down, a 10.2 per cent increase from 626 in the same period a year earlier.

In the 12 months ending September 2012, the Average Custodial Sentence Length (ACSL) was 14.9 months, an increase of 0.6 months compared to the 12 months ending September 2011, and an increase of 2.5 months compared to the 12 months ending September 2002. The rise in ACSL has been driven by the change in the case mix of people getting custodial sentences and longer sentences for indictable offences:

- In the 12 months ending September 2002, summary motoring offences accounted for 15.3 per cent of immediate custodial sentences, with an ACSL of 3.4 months. By the 12 months ending September 2012, they accounted for just 3.0 per cent of immediate custodial sentences, with a reduction in ACSL to 3.1 months.
- In the 12 months ending September 2002, indictable offences accounted for 76.2 per cent of immediate custodial sentences, with an ACSL of 15.2 months. By the 12 months ending September 2012, they accounted for 83.2 per cent of immediate custodial sentences, with an increase in ACSL to 17.4 months. In particular, sexual offences saw a rise in ACSL from 41.8 months in the 12

At the magistrates' courts, the ACSL in the 12 months ending September 2012 was 2.6 months, the same as in the previous period, whilst at the Crown Court the ASCL increased by 1.0 months from the 12 months ending September 2011 to 25.6 months.

## Suspended Sentence Orders

In the 12 months ending September 2012, there were 44,400 Suspended Sentence Orders handed down, a decrease of 8.8 per cent from the same period a year earlier. Of these:

- 24,100 persons received their sentence at the magistrates' courts, a decrease of 9.2 per cent compared to the same period a year earlier. This type of sentence was given to 2.1 per cent of persons in a magistrate's court in the 12 months ending September 2012.
- 20,200 persons received their sentence at the Crown Court, a decrease of 8.4 per cent compared to the same period a year earlier. Just over one fifth ( 21.5 per cent) of persons were given a suspended sentence at the Crown Court, an increase from 10.6 per cent in the 12 months ending September 2006. Between the 12 months ending September 2002 and September 2005, less than three per cent of persons were given a suspended sentence at the Crown Court.


## Community sentences

There were 153,900 community sentences handed down in the 12 months ending September 2012, a decrease of 14.0 per cent from the same period a year earlier. Community Orders accounted for nearly all the community sentences given to adults (99.7 per cent), while for juveniles the Referral Order was still the most common sentence (accounting for 52.3 per cent of all juvenile community sentences). The Youth Rehabilitation Order (YRO), introduced in November 2009, accounted for a further 45.1 per cent of all juvenile community sentences in the 12 months ending September 2012. Of the 153,900 community sentences handed down:

- 138,700 persons received their sentence at magistrates' courts, a 13.7 per cent fall from the same period a year earlier. Over the past 11 years, the magistrates' court community sentence rate (the proportion of all offenders sentenced at the magistrates' court receiving a community sentence) has ranged between 11.8 per cent in the 12 months ending September 2004 and 13.9 per cent in the 12 months ending September 2009.
- 15,100 persons received their sentence at the Crown Court. This was a 16.3 per cent decrease from the same period a year earlier. The Crown Court community sentence rate decreased from a peak over the period of 30.4 per cent in the 12 months ending September 2003 to a low of 16.1 per cent in the 12 months ending September 2012.


## Fines

Fines continue to be the most common sentence due to the large volumes issued at magistrates' courts. In the 12 months ending September 2012, there were 816,600 fines handed down ( 99.8 per cent of these being issued at magistrates' courts), a decrease of 5.2 per cent from the same period a year earlier. Of the offenders receiving fines in the 12 months ending September 2012:

- The majority were issued for summary offences, with only 6.6 per cent issued for indictable offences.
- The fine rate for indictable offences at all courts was 17.4 per cent, a similar proportion to the previous two years. This has decreased from a peak over the last decade of 23.5 per cent in the 12 months ending September 2003.


## Other sentences

Other sentences comprise absolute and conditional discharges and 'otherwise dealt with' sentences. The latter category deals with a miscellaneous group containing: mental health disposals; ancillary orders; and other procedural disposals. There were 115,600 other sentences handed down in the 12 months ending September 2012. These comprised:

- 80,300 conditional discharges, a decrease of 7.4 per cent from the same period a year earlier and a fall of 18.6 per cent compared with the 12 months ending September 2002.
- 7,500 absolute discharges, a decrease of 8.1 per cent from the same period a year earlier and a fall of 57.1 per cent compared with the 12 months ending September 2002.
- 27,800 offenders 'otherwise dealt with', a decrease of 12.1 per cent from the same period a year earlier and a fall of 3.9 per cent compared with the 12 months ending September 2002.


## Sentence outcomes by age band

In the 12 months ending September 2012, there were 1.17 million adults (aged 18 and over) sentenced, a decrease of 5.9 per cent from the same period a year earlier and 19.6 per cent from the 12 months ending September 2004, when the highest number of adults were sentenced over the 11 year period ( 1.46 million).

The proportion of adult offenders receiving fines decreased by 3.1 percentage points over the 11 year period, from 71.9 per cent in the 12 months ending September 2002 to 68.8 per cent in the latest period.

In the 12 months ending September 2012, there were 50,000 juveniles (aged 10-17) sentenced, a decrease of 23.6 per cent from the same period a year earlier and 47.3 per cent from the 12 months ending September 2002.

The number of juveniles sentenced remained relatively stable between the 12 months ending September 2002 and 2007, but the number and proportion of community sentences for juveniles over the same period increased, from 50,900 to 65,800 over the period (up 29.3 per cent). While the number of juveniles sentenced has decreased by 48.6 per cent since the 12 months ending September 2007, the community sentence rate for juveniles has remained between 65.2 and 68.8 per cent.

The large increase in the community sentence rate for juveniles over the last 11 years has been offset by decreases in the fine rate, from 18.5 per cent in the 12 months ending September 2002 to 8.0 per cent in the latest period.

Figure 5.2 provides a breakdown of all the sentence outcomes for juveniles and adults, showing how offences committed by juveniles and adults are dealt with differently by the courts.

## Offenders sentenced by ethnicity

Data on the ethnicity of offenders is currently held for offenders who have been convicted of an indictable offence. In the 12 months ending September 2012, there were 309,500 persons sentenced for indictable offences, of which 90.5 per cent were of a known ethnicity.

- 74.7 per cent were White; 9.3 per cent were Black; 4.7 per cent were Asian; and 1.7 per cent were of 'other ethnicity'. The remaining 9.5 per cent were of unknown ethnicity.
- The immediate custody rate for indictable offences for all ethnicities was 26.2 per cent. This varied between ethnicities with: White offenders having a custody rate of 25.2 per cent; Black offenders having a custody rate of 29.5 per cent; Asian offenders having a custody rate of 32.0 per cent; and 'other' having a custody rate of 44.2 per cent.

These differences are likely to relate to a range of factors including variations in the offences committed and the plea entered by people from different ethnic backgrounds. For more information see the publication 'Race and the Criminal Justice System - Sentence outcomes and offence types by gender.'

In the 12 months ending September 2012, there were 882,300 sentences given to males and 292,000 to females. This represents a decrease for both males and females compared with the same period a year earlier ( 8.7 per cent and 2.5 per cent decreases respectively). While for males this represents the continuation of a decrease since the 12 months ending September 2004, for females this constitutes a third consecutive annual decrease after a broadly upward trend between 12 months ending September 2002 and September 2009 (a 24.8 per cent increase between these years).

## Offences

This chapter differs from the others in the publication by counting on an all offences basis, as opposed to a principal offence basis.

Courts and the police typically deal with defendants charged with more than one offence, for example in the 12 months ending September 2012 each convicted offender was convicted of an average of 1.4 offences.

This average rate of offences per convicted offender has decreased slightly year on year since the 12 months ending September 2003, when it stood at an average of 1.7 offences per convicted offender.

## Cautions (all offence basis)

In the 12 months ending September 2012, there were 231,200 cautions issued for all offences, a decrease of 11.7 per cent from 261,800 in the 12 months ending September 2011. This decrease continues the downward trend observed since the peak of 401,300 offences cautioned in 12 months ending September 2007.

There were 120,700 cautions for indictable offences in the 12 months ending September 2012, a 13.8 per cent decrease on the previous year. This continues the decreasing trend observed in the 11 year series since the peak of 226,500 cautions for indictable offence in the 12 months ending September 2007.

The remaining 110,600 cautions in the 12 months ending September 2012 were for summary non-motoring offences, a 9.2 per cent decrease on the previous year.

Indictable offences accounted for 52.2 per cent of cautions $(120,600)$ in the 12 months ending September 2012. This proportion has been broadly declining since a peak of 63.4 per cent in 12 months ending September 2002.

## Convictions (all offences basis)

In the 12 months ending September 2012, there were 1.72 million convicted offences, a decrease of 6.4 per cent from 1.83 million in the 12 months ending September 2011. Since a peak over the last 11 years of 2.58 million in the 12 months ending September 2004, there have been year on year decreases in total convicted offences, with an overall fall of 33.5 per cent when comparing the 12 months ending September 2012 total with the 12 months ending September 2004.

The decrease has been driven in the main by convictions for summary motoring offences, which have fallen by 56.3 per cent between the 12 months ending September 2004 and the 12 months ending September 2012 (from 1.35 million to 589,800 ).

Indictable offences accounted for 31.6 per cent of convicted offences in the 12 months ending September 2012. This represented a slight increase on the 12 months ending September 2011 ( 31.5 per cent) and a continuation of an increasing trend observed since the 12 months ending September 2004 ( 22.7 per cent) due to the decrease in summary motoring convictions.

Summary motoring offences accounted for 34.4 per cent of all offences in the 12 months ending September 2012, a series low over the last 11 years. In the series peak of the 12 months ending September 2004, summary motoring offences accounted for 52.3 per cent of all offences, with the proportion having fallen year on year since.

## Offences Brought to Justice (notifiable offences)

One measure of justice outcomes is Offences Brought to Justice (OBTJ). An offence is said to have been brought to justice when a 'notifiable offence, ${ }^{8}$ results in an offender being convicted, cautioned, issued with a Penalty Notice for Disorder (PND) or a cannabis warning, or having an offence taken into consideration at court.

In the 12 months ending September 2012, there were 1.12 million OBTJs, a decrease of 8.6 per cent from 1.22 million in the 12 months ending September 2011. Recorded crime totals fell by 7.1 per cent over the same period.

Offences brought to justice increased from 1.02 million in 12 months ending September 2002 to a series high of 1.45 million in the 12 months ending September 2007. The total has been steadily falling since the 12 months ending September 2008.

Cautions and convictions account for the vast majority ( 82.0 per cent) of all OBTJs in the 12 months ending September 2012.

The decline in the use of out of court disposals coincided with the replacement in April 2008 of a target to increase offences brought to justice, with one placing more emphasis on bringing serious crime to justice. The latter target was subsequently removed in May 2010.

Convictions accounted for 62.6 per cent of all OBTJs in the 12 months ending September 2012, similar to the proportion as in 12 months ending September 2011 ( 60.9 per cent). The proportion declined from a peak of 68.5 per cent in 12 months ending September 2003 to 48.8 per cent in 12 months ending September 2007, followed by a year on year increase to 12 months ending September 2012. This trend is driven by the patterns in the use of out of court disposals.

In the 12 months ending September 2012, the main offence groups which make up OBTJs were violence against the person (27.7 per cent), theft and handling stolen goods (25.4 per cent) and drug offences (19.9 per cent).

The proportion of all OBTJs accounted for by violence against the person has increased by 5.7 percentage points since 12 months ending September 2002. Similarly, drug offences have increased in proportion by 7.7 percentage points since the 12 months ending September 2002. However, over the same period, theft and handling stolen goods decreased by 8.5 percentage points.

## Offending histories

Information presented in this section differs from previous sections on convictions, cautions and sentencing, in that all information in this section is taken from the Police National Computer (PNC). The main difference is that the PNC does not include a range of less serious summary offences (such as TV licence evasion and a range of motoring offences) and so the figures reported are not comparable or match figures reported in the previous sections of this bulletin. The PNC is the police's administrative IT system, which as with any large scale recording system, is subject to possible errors with data entry and processing. The figures are provisional and subject to change as more information is recorded by the police.

This section provides an overview of the changing structure of the known offending population with information on the breakdown of offences committed by new offenders and repeat offenders, the trends in new entrants to the criminal justice system, and breakdowns of the criminal histories of cautioned and sentenced offenders.

Key points in the 12 months ending September 2012:

- There were 187,700 first time entrants to the criminal justice system (offenders who received their first conviction or caution). This is down 13 per cent from the year ending September 2011 and 44 per cent from the 332,800 first time entrants in the year ending September 2007.
- The reduction in the number of first time entrants seen over the last five years has been much sharper for juveniles, down 71.5 per cent since the year ending September 2007, than for adults, down 30 per cent in the same period.
- The rate of first time entrants per head of population has also fallen substantially amongst juveniles, down from a little over 2,000 per 100,000 population in the 12 months ending September 2007 to an equivalent figure of 595 in the most recent period. However, although the gap is narrowing, the rate still remains substantially higher for juveniles than for adults.
- Around 4 times as many juvenile first time entrants receive a reprimand or warning from the police than are convicted by a criminal court. Amongst adult first time entrants, the proportions receiving a caution and being convicted are roughly equal.
- 15 per cent of juveniles sentenced for indictable offences were first time entrants, while 65 per cent had between one and six previous convictions, reprimands or warnings and four per cent had over 15 previous convictions, reprimands or warnings. Amongst adults, nine per cent were first time entrants, while 36 per cent had 15 or more previous convictions or cautions.
- The proportion of juveniles sentenced for indictable offences with 15 or more previous convictions, reprimands or warnings has fallen slightly since the year ending September 2011, but is up around three percentage points over the last 10 years. Amongst adults, the proportion with 15 or more previous convictions or cautions has increased 14 percentage points over the last 10 years.
- 39 per cent of offenders sentenced for indictable offences with 15 or more previous convictions or cautions were sentenced to immediate custody while 20 per cent were given a community sentence. This compares to 26 per cent and 35 per cent respectively for those first time entrants sentenced.


## First offences and further offences

An offence is defined as a first offence if it results in the offender receiving their first reprimand, warning, caution or conviction - i.e. they have no previous criminal history recorded on the PNC. Offences resulting in further reprimands, warnings, cautions or convictions are known as further offences since the offender already has a recorded criminal history on the PNC.

In the 12 months ending September 2012, a total of $782,700^{9}$ first offences and further offences were recorded on the PNC, a decrease of 8.5 per cent compared with 855,500 recorded in the 12 months ending September 2011. Of these recorded offences:

- First offences accounted for 24.0 per cent $(187,700)$, a fall of around one percentage point compared with the 12 months ending September 2011;
- Further offences accounted for 76.0 per cent $(595,000)$, a rise of around one percentage point compared with the 12 months ending September 2011.

Figure 7.1 shows the breakdown of all proven offences recorded in the 12 months ending September 2012. The percentages in the diagram relate to the total number of offences committed in the top box of the figure.

- 16.8 per cent of first offences ( 31,600 out of 187,700 first offences) are committed by juveniles, compared to 9.1 per cent of further offences (54,100 out of 595,000 further offences);
- Juveniles received 17.0 per cent of cautions, reprimands and warnings compared to 8.8 per cent of convictions.

Figures 7.2 and 7.3 present the trends since 2002 of first and further offences as recorded on the PNC. Figure 7.2 shows the peak for juveniles in 2007 and the subsequent large falls in offending which are associated with the removal of a target in April 2008 to increase offences brought to justice and a move towards bringing more serious crimes to justice. Figure 7.3 shows a different pattern for adults, with first time entrants falling back after the peak in 2007, further offending continuing to rise until the end of September 2011 and slightly falling in the 12 months to the end of September 2012.

## First time entrants to Criminal Justice system

First time entrants to the criminal justice system are classified as offenders, resident in England or Wales, who received their first reprimand, warning, caution or conviction, based on data recorded by the police on the PNC. These PNC recorded offences exclude a range of less serious summary offences.

In the 12 months ending September 2012, there were 187,700 first time entrants (FTEs) to the criminal justice system as recorded on the PNC, a decrease of 12.8 per cent compared to the 12 months period ending September 2011, and 29.9 per cent when compared with the 12 months period ending September 2002.

- Juvenile first time entrants accounted for 16.8 per cent $(31,600)$ of all first time entrants, a fall of two percentage points compared with the 12 months ending September 2011, and 15 percentage points when compared with the 12 months ending September 2002. Of these:
o The rate per 100,000 of population has fallen 25.1 per cent from 794 to 595 over the last 12 months and 62.0 per cent from 1,566 when compared with the 12 months ending September 2002.
- Adult first time entrants to the criminal justice system in the 12 months ending September 2012 accounted for 83.2 per cent $(156,100)$ of all the new entrants, an increase of two percentage points compared to the 12 months ending September 2011, and an increase of 15 percentage points when compared with the 12 months ending September 2002. Of these:
o The rate per 100,000 of population has fallen 11.6 per cent from 400 to 353 over the last 12 months and 21.7 per cent from 451 when compared with the 12 months ending September 2002.
- The decline in the use of reprimands, warnings and cautions in dealing with FTEs is consistent with the reduction in the use of these disposals for all offenders and coincides with the increasing focus on more serious offending.


## Criminal histories

An offender is counted as having a criminal history if their PNC record shows that, at the time of receiving a reprimand, warning, caution or conviction, they had previously committed one or more offences that had resulted in one of these sanctions. The PNC data excludes a range of less serious summary offences, and therefore unlike the section on Offending Histories, this Criminal Histories section focuses on the criminal histories of offenders cautioned or sentenced for indictable offences only.

## Offenders cautioned ${ }^{10}$ for indictable offences on the PNC [Tables Q7.4, Q7.5 and Q7k]

In the 12 months ending September 2012, a total of 109,800 offenders received reprimands, warnings or cautions for indictable offences, a decrease of 14.7 per cent compared with the 12 months ending September 2011. Of these:

- 50.0 per cent $(54,900)$ have at least one previous convictions or cautions recorded compared to 48.4 per cent $(62,200)$ in 12 months ending September 2011.
- 4.0 per cent $(4,400)$ of offenders who received warnings/reprimands or cautions for indictable offences had 15 or more previous convictions or cautions an increase of around half a percentage point compared with the 12 months ending September 2011, and around three percentage points compared to 12 months ending September 2002.


## Offenders sentenced for indictable offences on the PNC [Tables Q7.4, Q7.5 and Q7I]

In the 12 months ending September 2012, a total of 311,300 offenders were sentenced for indictable offences, 5.3 per cent decrease compared with the 12 months ending September 2011. Of these:

- 9.9 per cent of all offenders sentenced for indictable offences had no previous convictions or cautions recorded against them, a fall of less than half a percentage point compared to the 12 months ending September 2011, and around two percentage points lower than in the 12 months ending September 2002;
- 33.1 per cent of all offenders sentenced for indictable offences had 15 or more previous convictions or cautions recorded against them, an increase of around two percentage points against the 12 months ending September 2011 and 14 percentage points compared with the 12 months ending September 2002.


## Criminal history by sentence type

The criminal history of offenders receiving different sentences varies by type of sentence, which can range from a reprimand, warning or caution to immediate custody, with custodial sentences associated with higher levels of previous convictions or cautions. In the 12 months ending September 2012:

- 46.9 per cent of adult offenders receiving immediate custodial sentences had 15 or more previous convictions or cautions, an increase of around two percentage point against the 12 months ending September 2011 and around 14 percentage points compared with the 12 months ending September 2002.
- 31.1per cent of adult offenders receiving a community sentence had 15 or more previous convictions or cautions, an increase of around three percentage points against the 12 months ending September 2011 and around 14 percentage points compared with the 12 months ending September 2002.
