# Open Data – is a new fuel of the XXI century



*The direct impact of Open Data on the EU27 economy was estimated at €32 Billion in 2010, with an estimated annual growth rate of 7%\**

## Open Data is:

- ◆ The basis for open government
- ◆ The basis of transparency of governments and civilian control
- ◆ The great value for economic growth
- ◆ The raw material for developing new services for citizens and businesses

*But government data is only part of the picture: data will deliver the greatest impact if it can be linked and compared to data held by a range of different private and public sector organisations.*

## Benefits to Government:

- ◆ Increased tax revenues through increased economic activities
- ◆ Increased service efficiency through open data
- ◆ New models of delivering public services
- ◆ Boost for entrepreneurship
- ◆ More efficient public services through transition to on-line delivery
- ◆ Quick response to citizens requests and claims

- ◆ Driving new business opportunities
- ◆ Creating new services and products
- ◆ Better decision making based on accurate information

# Open data in Russia: what has been done



According to Decree No. 601 issued by the President of the Russian Federation, 500 datasets will be open by July 2013 by the Federal ministries



Open Data Council, Open Data Concept and a road map

Creating legislative base for Open Data (the law signed one week ago)



Pilot model of Crime stats portal providing crime statistics for Russia



Launch of Portal for the Budgetary System of the Russian Federation



Contests for the mobile services developments

## Moscow city open data portal (results of the first 3 months):

- ◆ 160 datasets are open
- ◆ 7 applications for citizens
- ◆ 85 e-services on E-services portal
- ◆ > USD 10.6 mln paid through e-services portal
- ◆ 1, 3 mln requests from citizens through e-portal
- ◆ 1 mln users
- ◆ > 10 sms services for citizens (sms, ussd)

- Launch of Open Data Portal for the Russia Government
- Support Open Data School (Public lectures for various audiences)
- Create new applications and services based on open data for citizens
- Facilitate training courses relating to data disclosure for civil servants and municipal employees
- Promote data journalism and the use of open data by citizens
- Opening data plans of ministries and regions



Russia is ready to play an active role in the conference and to continue to develop Open Data initiatives in 2014

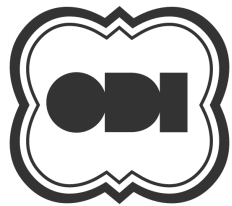

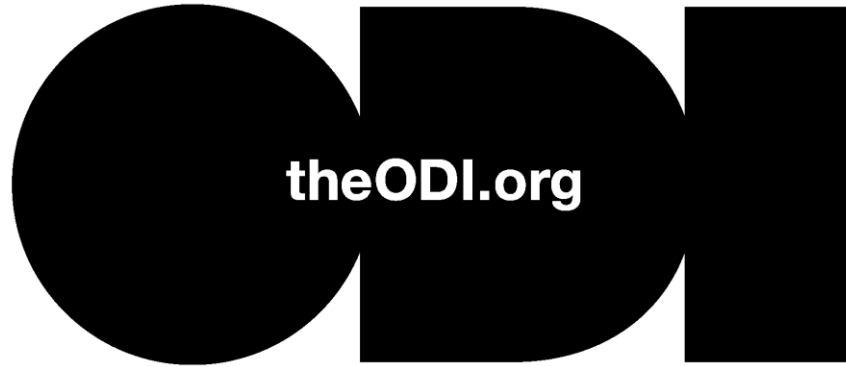
