

Financial Sanctions Notice

28/06/2013

Al-Qaida

Council Regulation (EU) No 596/2013

This notice is issued in respect of the restrictive measures directed against certain persons and entities associated with the Al-Qaida network.

- 1. With the publication of Council Regulation (EU) No 596/2013 of 24 June 2013 in the Official Journal of the European Union (O.J. L 172, 25.6.2013, p.1) on 25 June 2013, the Council of the European Union has amended Annex I to Council Regulation (EC) No 881/2002 ("the 2002 Regulation"), with effect from 26 June 2013.
- 2. Annex I to the 2002 Regulation lists the persons and entities subject to the freezing of funds and economic resources provisions contained in the 2002 Regulation.
- The amendment reflects the decision made on 21 February 2013 by the United Nations Security Council (UNSC) Committee established pursuant to Resolution 1267 (1999) to remove Usama Bin Laden from the UN Al-Qaida list.

- 5. Usama Bin Laden is no longer subject to the asset freeze imposed by the 2002 Regulation. However, specific conditions need to be satisfied when unfreezing funds frozen belonging to Usama Bin Laden. Please see the Council Regulation (EU) 596/2013 for these conditions. The link to the Regulation is provided below.
- 6. Details of the removal are set out in the Annex to this notice.
- 7. The Treasury's Consolidated List of persons subject to financial sanctions in effect in the UK, which is maintained on the Treasury website, has been updated to reflect the removal.
