

Financial Sanctions Notice

Al-Qaida

Commission Implementing Regulation (EU) No 632/2013

This notice is issued in respect of the restrictive measures directed against certain persons and entities associated with the Al-Qaida network.

- With the publication of Commission Implementing Regulation (EU) No 632/2013 of 28 June 2013 in the Official Journal of the European Union (O.J. L179, 29.6.2013, p.85) on 29 June 2013, the European Commission has amended Annex I to Council Regulation (EC) No 881/2002 ("the 2002 Regulation"), with effect from 30 June 2013.
- 2. Annex I to the 2002 Regulation lists the persons and entities subject to the freezing of funds and economic resources provisions contained in the 2002 Regulation.
- 3. The amendment reflects the decision made on 30 May 2013 by the United Nations Security Council (UNSC) Committee established pursuant to Resolution 1267 (1999) to amend the identifying information for one entry on the UN Al-Qaida list.
- 4. Details of the amendment are set out in the Annex to this notice.
- 5. The Treasury's Consolidated List of persons subject to financial sanctions in effect in the UK, which is maintained on the Treasury website, has been updated to reflect the amendment.

Reporting requirements

- 6. Relevant institutions and other persons are requested to check whether they maintain any accounts or otherwise hold any funds or economic resources for the persons set out in the Annex to this notice whose details have been added to or amended in Annex I to the 2002 Regulation. If so, they must freeze such accounts or other funds and, unless licensed by the Treasury, refrain from dealing with the funds or making them available to such persons.
- 7. Relevant institutions must report their findings to the Treasury, together with any additional information that would facilitate compliance with the 2002 Regulation.

8. Where a relevant institution has <u>already reported</u> details of accounts, other funds or economic resources held frozen for designated persons, <u>they are not required to report these details again</u>.
