Dear Colleague

Re: Integrated Drug Treatment System for Prisons (IDTS) allocations for 2010/11

I am writing to confirm the 2010/11 Department of Health (DH) allocation for IDTS for all adult prisons to progress the development of enhanced clinical services for prison drug treatment.

IDTS aims to not only increase the volume and quality of treatment available to prisoners, with particular emphasis on early custody, but also to improve integration between clinical and Counselling, Assessment, Referral and Throughcare Services (CARATs) and to reinforce continuity of care from the community into prison, between prisons, and on release into the community.

Annex A shows all adult prisons and First to Fourth Wave NHS Primary Care Trusts (PCTs) and Prisons by Government Office region.

The key elements of the IDTS are:

- better treatment for people in prison linked to DH Clinical Management of Drug Dependence in the Adult Prison Setting(2006), *Drug Misuse and Management UK Treatment Guidelines, 2007* and NICE guidelines ('Drug misuse: psychosocial interventions' (NICE clinical guideline 51) and 'Drug misuse: opioid detoxification' (NICE clinical guideline 52), offering a range of effective needs-based interventions, realistic treatment opportunities, including to remain drug free;
- improved clinical management with the provision of opioid stabilisation and options for detoxification or maintenance prescriptions, according to clinical need;
- intensive psychosocial support from CARATs during the first 28 days of clinical management, for all patients;
- greater integration of drug treatment generally, but a particular emphasis on clinical and CARAT services, with the objective of creating multi-disciplinary teams;
- better targeting of interventions to match individual need; and
- strengthening links to Community Services including PCTs, Criminal Justice Integrated Teams (CJITs), Drug Treatment providers etc.

The main features used to calculate 2010/11 funding for each prison were:

- A model of prison population and prisoner movements in all prisons in 2008, incorporating:
 - Unit treatment cost per prisoner.
 - Percentage of prisoners for each prison likely to require treatment for substance misuse; this is higher for women.
 - Length of time spent by individual prisoners in each prison: treatment is broken down into expected numbers requiring treatment for the first week, and then numbers expected for treatment in monthly increments thereafter for the next three months;
 - Anticipated re-presentations for treatment
- Elements of additional prison business cases that were approved by the business case review panel;

The funding for each prison has been calculated to provide sufficient resource for all treatment needs that may be anticipated for an establishment of its size and type. In all but the most extraordinary circumstances it will not be therefore be necessary to limit the number of patients received from other prisons. Funding has now gone out to all SHAs. The breakdown of funding by prison is at Annex D.

Local Drug Action Teams will also be integral to the planning and delivery of clinical drug treatment in prisons. IDTS commissioning plans are jointly agreed with these Partnerships. Additionally, such Partnerships oversee the

Drug Interventions Programme (DIP) and wider community-based provision, which need to be aligned to ensure continuity of care for drug users as they enter and leave prisons.

DH IDTS funding will be spent on the development of clinical drug treatment within prisons in the given Partnership area. IDTS clinical funding is subject to the same rules that govern use of the Pooled Treatment Budget: it should not be used to replace existing mainstream investments by PCTs, prisons and, in some cases, local drugs strategic partnerships. The funding is intended to provide additional resources that, combined with existing primary healthcare funding, will make it possible to deliver in-prison clinical treatment services consistent with IDTS standards and protocols.


It can also be spent on improving the community/custody interface to ensure continuity of treatment between custodial and community settings. It should not be spent on community services, aftercare or other areas of healthcare services.

As with community drug services, NHS commissioners and providers will be performance-monitored by the appropriate Strategic Health Authority (SHA); the performance of the DAT partnerships will be delivery-assured by the National Treatment Agency (NTA).


Although sent to PCTs via the SHA, the funding should be viewed as partnership money to be spent on enhanced prison clinical drug services, jointly agreed between the PCT Chief Executive, DAT Chairs and Prison Governor/ Director(s), all of whom are required signatories for the plans and whose funding streams also need integrating into this plan. The initial needs assessment and subsequent planning processes should be a partnership endeavour.

The NTA are responsible for the implementation of IDTS and support and advice will be available from IDTS Regional Development Managers employed by the NTA (see Annex B), and from Rehabilitation Services Group managers. Detailed guidance on implementation planning and preparation and on management and control of the implementation process is available. Implementation plans and progress will be assessed by regional IDTS Boards that include all relevant stakeholders.
