Public Expenditure 2008-09

Provisional Outturn

This White Paper reports provisional outturn figures for public spending in 2008-09 providing information on Departmental Expenditure Limits (DEL) and Annually Managed Expenditure (AME), including voted spending, near-cash and administration budgets. Outturn figures are reported for all departments as they were constituted at the end of 2008-09.

Totally Managed Expenditure	Spending by the public sector as a whole is known as Total Managed Expenditure (TME). Within TME there are two important aggregates. DEL covers spending for which departments are set firm three-year plans in the Spending Reviews. AME is subject to annual review as part of the Budget process.
Resource Accounting and Budgeting	With effect from 1 April 2001, Government spending moved from being accounted for on a cash basis to an accruals basis. This White Paper reports outturn for the main control aggregates and departmental control limits on an accruals basis and takes account of refinements to the budgeting system announced in Pre-Budget Report 2008 (<i>Cm7484</i>), that were introduced for control purposes from 2008-09. As noted above, the outturn figures are provisional and these may vary from departments' final audited accounts. In addition to this, the DEL and AME budgetary figures contain provisional outturn for Non-Departmental Public Bodies and Public Corporations, which are outside the scope of departmental resource accounts.
Consistency with other Publications	The White Paper reports outturn against the budgetary control limits on the basis of the definitions used for control purposes in 2008-09. This differs from the figures in Public Expenditure Statistical Analyses 2009 (<i>Cm 7630</i>) and in the National Statistics public expenditure outturn release being published today, both of which reflect changes to the budgetary framework introduced for control purposes from 2009-10.
Central government voted expenditure	Provisional outturn in 2008-09 for voted resource spending was £498.5 billion, £5.3 billion (1.1 per cent) more than final provision and for voted cash spending £501.7 billion, £14.8 billion (2.9 per cent) less than final provision. Table 1 shows outturn, original provision and final provision by Estimate and Request for Resources (RfR). There were two excesses.
Departmental Expenditure Limits	Provisional outturn for resource DEL in 2008-09 was £321.2 billion, £6.5 billion (2.0 per cent) less than the final departmental limits. The near cash element of resource outturn was £301.7 billion, £4.0 billion (1.3 per cent) less than final departmental limits. Provisional outturn for capital DEL was £48.1 billion, £1.6 billion (3.1 per cent) less than final departmental limits. Table 2 (resources), Table 3 (near-cash) and Table 5 (capital) show outturn against original and final limits by department/group. There was one breach of the resource limit, four breaches of the near-cash limit and three breaches of the capital DEL limit. Limits can change during the course of the year for a variety of reasons including the draw down of End Year Flexibility (EYF) entitlements, transfers between departments and classification changes. Comparisons between provisional outturn and original limits can therefore be misleading. The outturn figures form the basis of the calculations to determine departments' EYF entitlements for DEL shown in Table 6 .
Administration budgets	Provisional outturn in 2008-09 for administration budgets was £16.3 billion. This is £0.5 billion (3.2 per cent) lower than final limits. Table 4 shows outturn, original and final administration budget limits for departments subject to administration costs control.

- Breaches** Whenever a DEL breach occurs, corrective procedures will be applied. This includes an investigation into the causes of the breach, an examination of the financial procedures of the department or body concerned and, where appropriate, a reduction in the corresponding limit in the following year.
- End Year Flexibility** The DEL EYF scheme enables departments to carry forward all of their unspent DEL, including administration expenditure, with no upper limit. Eligible amounts are based on unspent DEL less, where appropriate, DEL Reserve claims plus any EYF entitlements from previous years not taken up. **Table 6** shows the amounts carried forward into 2009-10 for departments/groups. Subject to Parliamentary approval of any necessary Supplementary Estimates, DELs will be increased when carry forward is taken up. **Table 7** shows the movement in EYF stocks since the 2008-09 entitlements were announced in July 2008.
- Annually Managed Expenditure** Provisional outturn for AME in 2008-09 was £248.4 billion, 0.3bn (0.1 per cent) higher than the equivalent forecasts at the time of PESA 2009 (*Cm7630*). **Table 8** shows outturn for AME on the basis of the budgetary definitions in place during 2008-09.
