### **Company and Business Names**

The Company & Business Names consultation was published on 27 February 2013, as part of the Government's Red Tape Challenge: Company and business names: Red Tape Challenge - Consultations - GOV.UK. Regulation in this area aims to ensure that every company has a name easily differentiated from others and that the name does not misrepresent the company's position in the eyes of the general public.

The consultation sought views on the future of names regulations in general and invited comments on the options for improving and simplifying them. It considered the need to maintain the current regulations which, primarily, set out rules regarding "same as" names and "sensitive" words and expressions. The consultation was open for twelve weeks, closing on 22 May 2013.

#### **Government Response**

- The Government received 254 responses. The list of respondents is set out in Annex B. All responses agreed that there is a need for some regulation in this area to protect the public from possible harm. The majority of the responses agreed that there is room for simplification and for a reduction in the number of words and expressions on the "sensitive" list.
- 2. There was support for merging and simplifying the regulations. Therefore, we will move forward with proposals to merge the Company and Business Names Statutory Instruments with Trading Disclosures Statutory Instruments, so that all the requirements may be in found in one place.
- 3. Trading Disclosures regulations specify that a company must display their name, registration number and other company information on all correspondence and on signs at business premises. We will make them easier to follow and, therefore, to comply with e.g. the annexes will be set out in a clear table format.
- 4. Respondents encouraged the removal of particular words from the "sensitive" list and also supported the retention of particular words / expressions. "Co-operative", "Chamber of" and "Accredit" (& its listed derivations) were the subject of strong campaigns to support their retention and these will all remain on the "sensitive" list.
- 5. Following analysis of all comments, we are proposing to reduce the list of "sensitive" words and expressions by approximately one third. Annex A sets out which words we propose to retain and which we propose be removed from the "sensitive" list excluding their Gaelic & Welsh equivalents.
- 6. We gave the suggestion of removing 'National' words (e.g. England, Scottish, Cymru) and the word 'Sheffield' very careful consideration. There was support for both their retention and for their removal. The Government has now decided that these words should be retained and should continue to be afforded protection under Company Law. The Scottish Government, Welsh Government and Northern Ireland Executive were all consulted and responded in support of the retention of 'National' words.
- 7. Companies House has agreed to improve its internal systems and change the way in which sensitive names are dealt with administratively. This will include improved guidance, in order to ease the burden on businesses.
- 8. Currently, innocuous use of sensitive words is allowed but the regulations will no longer require automatic referral to specified bodies. Companies House will, instead, be given authority to apply appropriate approval criteria. This will reduce the number of registrants who have to seek permission to use a 'sensitive' word in their business name and speed up their registration process.
- 9. The "same as" names were also highlighted as an area where current regulations are producing unintended outcomes and causing problems. The "same as" legislation sets out all the words, expressions, signs and symbols which are to be disregarded when determining whether a proposed company name is the same as

another name already appearing on the registrar's index. However, businesses have told us that the rules are causing difficulties for both start up companies and for established companies wishing to change names or swap names within their group, as part of a restructuring process. This is causing increased costs and slowing down the system.

- 10. We will reduce the number of words (on the list of those to be disregarded) in the "same as" regulations to balance the need to prevent confusion and harm to the public with the freedom for a business to register their chosen name and for companies within a group to swap names. Those to be removed are Exports, Group, Holdings, Imports, International, Services (& Welsh & Gaelic equivalents).
- 11. These amendments will significantly reduce the number of 'same as' instances and increase the number of approved names. With the exception of the word 'company', the implementation of this proposal will result in the list only containing abbreviations and current domain endings.

#### **Summary of Responses**

# 1. Do you think all regulations relating to names should be repealed? Please give reasons for your answer.

There were 246 responses which supported the retention of names regulations. Only 8 respondents made no comment as to whether regulations should be repealed or retained. No respondents agreed that all regulations relating to names should be repealed.

We received a large number of brief email responses in support of particular "sensitive" words. As these were, in effect, in support of names regulations being retained they were included as "No" answers to this question.

# 2. Do you think regulations relating to names should be retained but reduced and simplified? Please give reasons for your answer.

The majority of responses, 152, did not answer this question. These responses supported the retention of names regulations but did not specify whether they should be reduced and simplified.

We received 83 responses which agreed to this suggestion and only 13 responses which opposed any changes being made to the current regulations.

An answer of "possibly" was given by 6 respondents.

# 3. Do you think the list of "sensitive" words should be reduced? If so, which words would you recommend for removal and why?

We received 38 responses which agreed to this question. Of those, 29 specified particular words and/ or expressions which they considered should be removed from the "sensitive" list.

We received 44 responses against the reduction of the "sensitive" words list. However, 24 of these responses were a campaign by 'Football Club United of Manchester Ltd' which was itself part of a larger campaign specifically supporting the retention of the word "cooperative".

The majority, 170 responses, did not specify whether or not they thought the "sensitive" list should be reduced, of these, 162 specified words which they considered important to retain. The campaign to retain the protections afforded to the word "co-operative" submitted 106 such responses. The campaign by the British Chambers of Commerce to retain protections afforded to "Chamber of" submitted 20 such responses.

There were 2 responses which answered "possibly" to this question.

## 4. Do you think the list of words on the "same as" list should be reduced? If so, which words would you recommend for removal?

The majority of responses, 175, did not answer this question.

Of those that did, 26 responses did not think the "same as" list should be reduced.

There were 54 responses in favour of reducing the "same as" list and 18 of these recommended specific words for removal.

#### **Next Steps**

We will draft regulations over the coming months and make these available for comment on the www.gov.uk website.
