

## Summary of changes to the non-domestic RHI

## **Changes to tariffs**

We are increasing the support available for renewable CHP, large biomass boilers (over 1MW), deep geothermal, ground source heat pumps, solar-thermal and biogas combustion. We are also introducing new support for air-water heat pumps and commercial and industrial energy from waste.

## **Budget Management**

The deployment assumptions used to inform our budget management policy are now based on refreshed market intelligence, rather than pre-scheme expectations. This will ensure that all technologies supported under the scheme have significant room for sustainable growth from current levels over the remainder of spending review period.

## Summary of Tariffs

\*These tariffs are subject to an inflation based increase in April 2014 (RPI linked) but may also be subject to degression before April 2014 in accordance with the current budget management policy.

\*\*CHP will continue to be eligible under the large biomass tariff, which includes the proposed increase from 21<sup>st</sup> January 2013, until it becomes eligible under the dedicated CHP tariff from the date of publication

Technologies included in the Early Tariff Review will have an eligibility date of 21<sup>st</sup> January 2013 (when the tariff review was announced), with changes to tariffs for the remaining technologies eligible from the date the Government response was published.
