Notes

- 1 The Government of the Republic of Cuba included in its instrument of accession the following declaration:
(translation) "The Republic of Cuba declares that the provisions contained in subparagraphs i) and ii) paragraph 3 of Article 1 of the North-East Atlantic Fisheries Convention referring to colonial territories are no longer applicable being contrary to the Declaration on the Granting of Independence to colonial Countries and Peoples (Resolution 1514) made by the General Assembly of the United Nations Organisation on 14 December 1960 proclaiming the necessity of bringing colonialism in all its forms and manifestations to a speedy and unconditional end."
- 2 In a Note dated 4 July 1977, Norway declared that their withdrawal would take effect on 1 January 1978. In a further Note dated 19 December 1977, Norway declared that their withdrawal would be deferred until 1 July 1978.
- 3 In a Note dated 16 December, 1981 Spain stated that the effective date of their withdrawal would be postponed until constitutional procedures to give effect to the denunciation had been completed.
