## Maternity

### **New NHS Information Service For Parents – Launched in May**

Parents can now sign up to the new NHS Information Service for Parents to get regular emails, videos and texts, about pregnancy, the first weeks of their baby's life and beyond. This new, free digital service for parents provides regular, tailored NHS and other quality assured advice for both mothers and fathers.

The emails include information from NHS Choices, the Pregnancy Care Planner and the online Birth to Five guide along with videos showing midwives demonstrating practical advice and parents discussing their own experiences. The service provides information covering a wide range of issues for parents including how a baby develops, finding antenatal preparation, improving their own health, breastfeeding and immunisations.

### **Publication: Maternity And Children's Data Set – Information Standard Notice**

The Maternity and Children's [Data Set](#), (which includes maternity services, children and young peoples services and child and adolescent mental health services). Information Standard Notice was published in May 2012. The data set has been developed as a key driver to achieving better outcomes of care for mothers, babies and children. The data set will provide comparative, mother and child-centric data that will be used to improve clinical quality and service efficiency; and to commission services in a way that improves health and reduces inequalities.

## Revised Policy For Screening For Congenital Hypothyroidism (CHT) In Preterm Babies

The UK Newborn Screening Programme has issued a revised policy for screening for CHT in preterm babies. This policy should be implemented in all UK countries on 1 April 2012. By targeting babies born before 32 weeks gestation and repeat testing at 28 days postnatal age, or at the time of discharge home, whichever is sooner; this policy will enable earlier identification of CHT.

## NPEU Study On Uterine Rupture

The results of an NIHR funded national study of uterine rupture were published in March. The study showed that although uterine rupture is associated with significant mortality and morbidity, even amongst women with a previous caesarean section planning a vaginal delivery, it is a rare occurrence.

For women with a previous caesarean section, risk of uterine rupture increases with number of previous caesarean deliveries, a short interval since the last caesarean section and labour induction and/or augmentation. These factors should be considered when counselling and managing the labour of women with a previous caesarean section.

## Child Health

### Unwarranted Variation In Child Healthcare

The full extent of variation in healthcare for children in England has been revealed in the first *NHS Atlas of Variation in Healthcare – Child Health*.

The Atlas maps 25 indicators at PCT level to identify unwarranted variation in children's services – highlighting opportunities to improve health outcomes and minimise inequalities.

It has been produced by the NHS QIPP Right Care team in collaboration with clinical specialists and the Child and Maternal Health Observatory.

### Local Authority Child Health Profiles 2012 Launched For England

## National Review of Asthma Deaths (NRAD) – Request For Help

You can support the NRAD in a number of ways:

- If you are aware of a death of a person possibly due to asthma between 1<sup>st</sup> February 2012 and 31<sup>st</sup> January 2013, please notify the NRAD team as soon as possible. Please note we will also be receiving notifications from ONS for case ascertainment purposes.
- If NRAD contact you to provide clinical information on one of your patients who has died and been notified to NRAD as possibly due to asthma, please do so as a matter of urgent importance.
- If you are aware that one of your patients may have died from asthma, please keep the health records of the person until you have heard from NRAD (this is to avoid delays later when you are asked to provide the information).

## Vulnerable Children

### Working Together To Safeguard Children

In response to a recommendation of the Munro review of child protection, on 12 June the Department for Education launched a consultation on the following revised statutory guidance: Working Together to Safeguard Children; Managing Cases: Framework for the Assessment of Children in Need and their Families; Learning and Improvement guidance (on draft revised arrangements for serious case reviews, reviews of child deaths and other learning processes led by Local Safeguarding Children Boards).

### Systematic Review of Models of Analysing Significant Harm

The aim of this review was to identify, critically appraise, and evaluate the potential role of all available tools for assessing/analysing data about the likelihood of significant harm to children.

It's aim was to identify the adequacy of these tools in terms of their consistency with the principles of the Assessment Framework (Department of Health, Department for Education and Employment and Home Office 2000), and their potential to be used as part of a process of Structured Professional Judgment and their rigour.

## **Safeguarding Children: A comparison of England's Data With That of Australia, Norway and the United States**

The Childhood Wellbeing Research Centre (CWRC) was commissioned by the Department for Education to undertake a study with the overarching aim of drawing together existing aggregate administrative data on safeguarding children and child protection and exploring the availability and comparability of these data as a tool for comparing England's performance against that of other countries.

The objective was to consider how different institutional and cultural approaches alongside different forms of provision and support may influence rates of abuse and neglect and the responses of public authorities

## **Young Children Suffering or At Risk of Suffering Significant Harm**

Since 2005, the Centre for Child and Family Research, Loughborough University has been tracing the decision-making process influencing the life pathways of a cohort of very young children who were identified as suffering, or likely to suffer, significant harm before they reached their first birthdays.

The overall objective of the research is to collect evidence which supports decisions concerning which children require permanent out of home placements (such as adoption) and those that can safely remain with their birth parents. A copy can be downloaded at

## **Costs And Impact of The Common Assessment Framework**

The Common Assessment Framework (CAF) is a standardised approach for the assessment of children and their families, to facilitate the early identification of additional needs and to promote a coordinated service response.

This report outlines the findings from an exploratory study to examine the costs and impact of the CAF. The research builds on a number of previous studies carried out by the Centre for Child and Family Research (CCFR) at Loughborough University as part of the ongoing costs and outcomes programme, most notably, the work to cost services and social care support provided to all Children in Need (CiN).

## **Care Placements Evaluation of MTFC-A**

This study, the Care Placements Evaluation (CaPE), has two components: a small randomised controlled trial embedded within a larger quasi-experimental observational study. The aim of the evaluation was to compare outcomes for two groups of young people with complex needs aged 10-16 years: those who enter treatment foster care placements within the MTFC model; and those in the other types of care placement usually available to this group of young people, including both foster and residential care.

## Ill and Disabled Children

### Children's Hospice and Hospice-at-Home Grant 2012/13

In the Coalition document *Our Programme for Government*, the Government committed to the continuance of £10m revenue funding annually to children hospices from 2011 and new per patient funding arrangements. The Department has recently notified the 40 children's hospices of the 2012/13 allocations for the Children's Hospice and Hospice-at-Home Grant.

### New Revenue Grant Funding For New Hospice Services

Up to £721,000 new revenue grant funding is being made available this year for new hospices in the sector. Applications will be open shortly to providers of new children's hospice services, who are not already in receipt of revenue funding from the existing Children's Hospice and Hospice at Home grant of £10m. ### New Capital Grant For Children's And Adult Hospices

On 29 May, the Government announced the new £60 million capital grants scheme for children's and adult hospices. The funding is being made available over 2012/13 and 2013/14 for projects to support improvements to the physical environment within hospices.

## Palliative Care Funding Pilots

New per patient funding arrangements for palliative care are expected to be in place in 2015 following the independent Palliative Care Funding Review, which reported in July 2011. The final report set out recommendations designed to create a fair and transparent funding system for palliative care for adults and children, which delivers better outcomes for patients and provides better value for the NHS. Eight palliative care funding pilots, including a children's consortium site, were launched March 2012 to collect the data on costs.

## New Audit Reveals Lack of Documentation on Children With Decreased Conscious Levels

A new audit which looks at whether guidance for assessing children with decreased conscious levels is being followed, has been launched.

['Care of Children and Young People Presenting to Hospital with a Decreased Conscious Level.'](#) published by the RCPCH, found that despite good levels of documentation in some key areas such as measurement of heart rate and oxygen saturation, 41.5% of the audited 53 NHS Trusts have not adopted all the guideline's recommendations. The audit measures criteria within eight main areas, including documentation of clinical history, observations, capillary blood glucose levels and information for parents and carers about the child's diagnosis or prognosis. The guidelines are being updated and disseminated to health professionals later this year.

The Department for Education has commissioned a two year programme, called Preparing for Adulthood, that will provide knowledge and support to local authorities and their partners (including families and young people) to ensure that disabled young people achieve better life chances as they move into adulthood. ## Children and Young People's Mental Health and Emotional Wellbeing

### Further Investment In Children and Young People's IAPT

Deputy Prime Minister, Nick Clegg has announced a further investment of up to 22 million pound over the next three years in Children and Young People's IAPT. This is in addition to the existing £32 million announced last year.

The new funding will be spent on:

- making treatment available to many more young people with mental health problems
- providing access to a wider range of psychological therapies including help to support families, or treatment for major health problems of adolescence including eating disorders, depression, self-harm, and conduct problems occurring with Attention Deficit Hyperactivity Disorder (ADHD)
- training to focus on extending the skills and experience of NHS clinicians and people who work with young people such as teachers, social workers and counsellors

## Transforming Challenging Behaviour

The Challenging Behaviour Foundation, a charity set up in 1997 to provide information, support and training to families and professionals, can currently provide subsidised training to multi-disciplinary teams supporting children and young people with severe learning disabilities and behaviour described as challenging, along with their families.
