



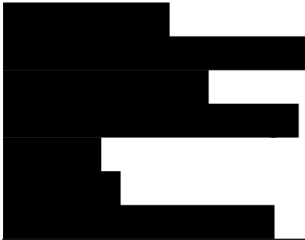

Thank you for your email of 20 November 2013 requesting the following information:

*I would like to make a request under the Freedom of Information Act to see any outstanding contracts between your department and the following companies, including the length and value of each contract:*

G4S  
Serco  
Capita  
Atos

I am treating your correspondence as a request for information under the Freedom of Information Act 2000.

A search for the information has now been completed within the Ministry of Defence (MOD), and I can confirm that we hold information in scope of your request. We have interpreted your request to mean that you would like details of what outstanding contracts the MOD has with the named companies, rather than copies of the actual contracts. Therefore, a list of the contracts that the MOD currently has with G4S, Serco, Capita, Atos and their subsidiaries is enclosed at Annex A. The analysis only includes agreements where contracts have been raised; it does not include miscellaneous payments.

Under Section 16 of the Act (Advice and Assistance), you may wish to note that under longstanding convention, the list includes contracts with AWE, a Government Owned Contractor Operated company in which Serco has a third share. The list does not include contracts where the named contractors provide goods and services under subcontract to other Defence suppliers. While some of the contracts have end dates in the past, they are still considered open as they have either had payments registered against them recently or they have been extended, but our records have not yet been updated to reflect this.

If you are not satisfied with this response or wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Deputy Chief Information Officer, 2nd Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail

[CIO-FOI-IR@mod.uk](mailto:CIO-FOI-IR@mod.uk)). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
