Agricultural waste special:

Exemptions – register now

Most farmers carry out [waste management activities](#) on their farm and many of these are covered by [exemptions](#).

Any agricultural waste exemptions you have previously registered will expire on 30 September 2013. Therefore you must register all your exemptions in the new system before this date.

This is required due to the new regulations that were introduced on 6 April 2010. The old waste exemptions have been replaced by a completely new list of exempt waste activities and since then there has been a transition period to enable you to move across to the new system.

You do not have to wait until the deadline to register. It's best to act sooner rather than later to ensure you're up to date and fully compliant. To help you register we have produced [guidance](#) which includes a table showing you how the old exemptions match the new ones. Some exemptions are almost identical to the old system, some are similar but with different conditions and some are completely new.



Recycling farm plastics

The quickest and easiest way to register your exemptions is to use our [online registration system](#), you will then receive a letter from us confirming your registration. To register by post call the Agricultural Waste Helpline on 0845 603 3113 and we'll send you an application form and copies of the guidance.

All exemptions are free to register and must be registered with us before you carry out the activity. You may add any new exemptions you need or ask for ones you no longer need to be removed at any time.

Landspreading – new guidance

Comprehensive new guidance has been released on [how to comply with your landspreading permit](#).

This guidance is relevant for businesses involved in spreading waste materials on land including:

- permit holders and their contractors
- waste producers
- land managers
- farmers on whose land waste is spread

An agricultural [benefit statement template](#) to use in deployment applications under landspreading mobile plant permits is also available.

Landspreading can beneficially add organic matter to soil and reduce your reliance on manufactured fertilisers and quarried soil conditioners. The new guidance explains whether a landspreading

operation is considered as recovery or disposal and how to ensure that it does not harm human health or the environment including soils, rivers, groundwater, animals and habitats.

Manures and slurries are not classed as waste when spread to farmland as a fertiliser. However they can cause pollution and you won't get the best out of them if they are not spread carefully. Refer to the [best practice guidance](#).



Hazardous farm waste

Hazardous farm waste

You will almost certainly produce [hazardous waste](#) on your farm at some point. These are wastes that pose more of a risk to human health and the environment and include: oil containers, lubricating oils, lead acid batteries, asbestos sheeting and roofing, and fluorescent light tubes.

We have produced guidance which lists the common hazardous wastes and explains how to deal with them, as there are special controls on their [handling](#), [transport](#) and disposal, even if you produce a very small quantity or you have it picked up by a contractor.

If you produce more than 500kg of hazardous waste on your farm in a 12-month period you must also register with us as a [hazardous waste producer](#).

There is a free national [directory](#) to find the nearest site that will recycle, treat or dispose of the agricultural waste you produce.
