When filled in, the application form is marked 'Restricted' in accordance with the Government Protective Marking System. It is for use only by those people within your organisation who need reasonable access to it, to ensure compliance with the conditions of the permit, and trusted contacts who advise you – such as your Radiation Protection Adviser.

- Do not copy it to other parties without consulting the Environment Agency.
- Lock it in a secure cabinet or container when it is not in use.
- Make those who access it aware of the marking and the need to protect the information from unauthorised disclosure and loss.
- If you move it around, use a sealed envelope and do not mark the envelope 'Restricted'. If you post it, use 'Royal Mail special delivery next day'.
- You should safeguard electronic copies of the data against unauthorised access. You should not email it.
