- 2 Guidance at ADM J2035 explains who a responsible carer is for the purposes of UC.

- 3 ADM J2103 provides guidance on which UC claimants are subject to a work-focused interview. The guidance at J2103 **1.** is now amended so that claimants who are the responsible carer for a child aged
 - 1. at least one and
 - 2. under three

are now subject to a work-focused interview only¹.

- 4 Guidance at ADM J2110 et seq explains which UC claimants are subject to a work preparation requirement. This guidance is now amended so that claimants who
 - 1. do not fall into the
 - **1.1** no work-related requirements group **or**
 - 1.2 work-focused interview requirement only group and
 - 2. have
 - **2.1** LCW or
 - **2.2** LCW or
 - 2.3 are the responsible carer for a child aged three or four

are now subject to a work preparation requirement¹.
