I suggest you include the following in your key messages, packaging no longer needs to be an elephant trap

- Tobacco use remains one of our most significant public health challenges and we must do all we can to reduce smoking rates. We have asked the eminent paediatrician Sir Cyril Chantler to carry out an independent review of the public health evidence on standardised tobacco packaging.
- The Government will introduce standardised tobacco packaging if, following the review and consideration of the wider issues raised by this policy, we are satisfied that there are sufficient grounds to proceed.
- The Government is taking regulation-making powers now so that we can act without delay if we decide to proceed.
