



ESF Programme Summary – Community Grants

Overview

For the ESF Programme in England, the Agency manages **Community Grants**. From 2014, this project will provide grants of up to £15,000 to allow small third sector organisations, which would not normally be able to access ESF, through simplified arrangements. These grants support a range of activities that help individuals in the hardest to reach communities to enter the labour market. Community Grants funding must not duplicate provision made available through mainstream ESF activity from the Agency.

A series of grant co-ordinating bodies administer Community Grants for the Agency on a regional basis. They publicise the availability of grants as well as providing support to successful applicants.

All of these contracts will end by 31 July 2015.
