Executive summary

Overview

Work Programme was launched throughout Great Britain in June 2011 and is part of a number of welfare to work reforms¹ aimed at getting unemployed people into lasting work.

The Work programme uses private and public companies, called providers to find work for claimants transferred to them from Jobcentre Plus at specified points in their claim². Providers are paid for outcomes related to lasting employment, in particular when an individual reaches six months in work, or three months for those expected to require more assistance. This is known as a Job Outcome payment. Overviews of Work Programme processes, terminology, official statistics and key measures can be found on pages 3 and 4.

Summary

Results against the Department's two key sets of measures for the Work Programme have improved since the start of the scheme.

Over 1.5 million people have joined the Work Programme to 31 March 2014, the majority of whom are still on the scheme. The numbers joining each month have generally been decreasing whilst the proportion expected to require more assistance to find and stay in employment has been around three times higher in those joining in the last year or so compared to the first 12-18 months of the scheme.

Jobseekers Allowance (JSA) claimants joining the scheme have shown increasing results over time, with levels around twice as high as those for Employment and Support Allowance (ESA) new claimants³. The most recent groups to spend a year on the programme show the highest proportions with a Job Outcome payment during that time. All 40 contracts achieved the contracted minimum performance levels in the third financial year of the programme.

Around 700 thousand individuals have completed their allotted time on the scheme to 31 March 2014. Approaching a quarter of these were still in employment at this point (or providers had received the final eligible payment). Around two thirds returned to Jobcentre plus.

Breaks in benefit for Work Programme participants show similar patterns to those with three or six months in work. DWP have been examining off benefit periods covered by employment using HMRC Real Time Information data for Work Programme participants. From this analysis we assess that around 26 thousand individuals satisfied the conditions for a Job Outcome payment to the end of December 2013 but no payment has been paid to providers by the end of March 20142. These are not contained in the Job Outcome payment statistics in this release.

Key findings

- Of those joining the scheme in January-March 2013 around 1 in 8 had three or usually six months in work after twelve months on the programme. This compares to less than 1 in 12 for those starting in the first three months of the scheme.
- For JSA claimants joining the scheme in January-March 2013 around 1 in 5 18-24 year olds and 1 in 6 for those aged over 25 had six months in work at the twelve month stage. For ESA new claimants³ joining over the same period, approaching 1 in 11 had three months in work after twelve months. This is approximately double the level for those joining from each of these groups at the start of the programme.
- Over 1 in 5 of those with sufficient time on the programme to do so have spent six months in work (or three for the harder to help) approaching 300 thousand individuals overall.
- All 40 contracts achieved the contracted minimum performance levels (MPLs). The contracted performance levels were calculated based on the expected volumes joining the Programme. As such, the measures and interpretation are vulnerable to fluctuations in the number joining within the year.




Work Programme: Official Statistics overview

Section A: Compare monthly intakes over time

Focuses on monthly intakes i.e. those referred to the Work Programme in a particular month.

Compares by volume, payment group makeup and tracks over time to compare outcome payments made and benefit status for intakes with the same duration of support.

Since Outcome Payments are paid following a defined period of employment, this approach avoids comparisons of total Outcome Payments with Referrals in the same period which would include those who have not had long enough to achieve an Outcome payment.



Key Measures

The Department publishes a range of measures to support transparency of public information.

For the Work Programme the **transparency indicator** is the proportion of claimants for whom providers were paid a job outcome payment at 12 months following referral, by monthly intake.


For example, for Referrals to the Work Programme in June 2011 this is the proportion of that intake for whom a Job Outcome payment was made by the end of June 2012. A 24 month equivalent is also published.

Section B: Examine all referrals to date

Examines all referrals to the Work Programme up to the reference date of the publication

Presents statistics regarding the current status of each referral (linked to the Work Programme overview on page 2). Time series of outcome payments to provider are given by month of payment.

Section B also includes information by contract, personal characteristics and geography. Note that information on contractual minimum performance levels are included in Section B only for publications relating to the end of a financial year and otherwise feature solely in supplementary table 2.16



Key Measures

The Department also uses measures, when working with providers, based on the number of Job Outcome Payments in a **financial year** in relation to Referrals.

Contractual minimum performance levels (MPLs) are set out that providers are required to deliver. These are based on the ratio of Job Outcome payments in a financial year to the **expected** Referrals in that year. They are calculated based on expected movement into employment in the absence of the Work Programme.

The contractual MPLs have limitations; notably that the Referrals considered will include those who have not had long enough to qualify for a Job Outcome payment and the impact of changes between expected and actual Referral patterns.

An <u>independent review</u> of Work Programme measures recommended that expectation be published alongside key measures. The Department is currently working through how these expectations should be derived and published and when decisions have been made users will be informed via the Official Statistics homepage.

Supplementary tables and further statistics

Each section described above includes key points followed by a more detailed discussion of the trends and components using charts or summary tables and accompanying commentary.

In addition, the tables underlying the charts are available via supplementary tables within this summary and also as excel tables via the <u>Work Programme statistics</u> page. The DWP tabulation tool and data visualisation tool enable users to examine many more tables and interactive charts in even greater detail than provided in this summary.

In this Summary

This Summary contains the latest Work Programme Official Statistics on Referrals, Attachments and validated Job Outcome and Sustainment payments to 31st March 2014 developed in accordance with the Code of Practice and supporting Principles.

Statistics are primarily sourced from data originally collected via administrative systems. To reflect any updates, the full historical statistical series is refreshed with each release and so previous figures may be updated based on new data².

Since Outcome Payments are paid following a defined period of employment, comparisons of total Outcome Payments with Referrals in the same period will include those who have not had long enough to achieve an Outcome payment. Hence the main focus of this summary (in section A) is comparing monthly intakes of Referrals that have had the same duration of support, an approach endorsed by the UK Statistics Authority.

Data in this release covers to the end of the third financial year of the Work Programme. Section B4 contains information on the contractual Minimum Performance Levels (MPLs).

To aid consistency of presentation throughout this summary and to reflect user needs and DWP contracts with providers, Payment Group (PG) 1 (JSA Claimants aged 18 to 24), PG2 (JSA Claimants aged 25 and over) are PG6 (ESA new customers) presented individually. From June 2014 in the Statistical Summary PG 6 are presented excluding 12 month prognosis claimants. These have been presented separately or grouped with PG 5, 7, and 8 and presented together as "Other ESA/IB". PGs 3, 4 and 9 are presented together as "other JSA".

Future Releases


The next release will be on 18th Sep 2014 and contain data to 30th June 2014.

Month of referral




Chart 1a: Referrals to the Work Programme by month: to end of March 2014

Key messages

- Monthly volumes of Referrals show a continuing downward trend.
- More recent intakes contain a higher proportion of individuals expected to require more support and assistance.

Chart 1a shows intake to the Work Programme generally decreasing each month since June/July 2011 (when Flexible New Deal participants were transferred to the Programme). This would be expected since individuals can only be referred to the scheme once. Between Oct 11 and Feb 12 there were a number of changes to access to the programme which saw an increase in intake.

Since individuals generally remain on the Work Programme for 104 weeks, the overall number being supported will have increased month on month until late May 2013. At which point the first intake began to complete the Programme.

There were 74,630 Referrals in June 2011, compared to 60,910 in March 2012, 34,720 in March 2013 and 21,870 in March 2014 (see Supplementary table 2.6 in Section C2 for full data). The series is affected by the number of working days in each month. For example, reduced Referrals in December 2011, 2012 and 2013 are a result of the public holidays in these months.


Chart 1b (see also Supplementary table 2.11) shows the Payment Group composition of each monthly intake. The change over time reflects the roll out activity, changes in access to the programme and JSA seasonality.

Monthly intakes since September 2012 include a higher proportion of individuals expected to require more assistance to find and stay in sustainable employment. 29% of the March 2014 intake fell into this category.


This reflects changes in access to the Programme, especially for ESA claimants including the introduction of information sessions for potential ESA volunteers, a Jobcentre Plus exercise to identify eligible ESA Claimants who had not been referred to the Programme and the immediate referral of people expected to be fit for work within 6 months from October 2011.


For example 3% of the June 2011 monthly intake were from an ESA 29% of the March 2014 group compared to intake.

Key messages

- Monthly intakes continue to attain Job Outcome payments the longer they spend on the Programme.
- Overall the proportion attaining a Job Outcome payment by the 12 month stage has improved since the start of the Programme although this has fluctuated in the last year.
- The proportion of intakes achieving a Job Outcome after 24 months is now steadily increasing after initially being stable.


When tracking Job Outcome payments for a particular monthly intake over time, it is important to note that support to find and stay in sustainable employment will continue to be required for previous intakes as well as for subsequent intakes joining the scheme.

Chart 2a tracks the proportion of monthly intakes achieving a Job Outcome payment over time. Every fourth monthly intake is presented, see **Supplementary table 2.1** for full data. Each monthly intake continues to show an increasing proportion of individuals attaining a Job Outcome payment the longer they are on the Programme. Over a quarter of the first intake in June 2011 attained a Job Outcome payment by March 2014, compared to less than one in twenty after nine months support.

Chart 2b (see also **Supplementary table 2.1**) presents the proportion of monthly Referrals for whom providers were paid a Job Outcome payment within the following 12 (and 24) months. Overall the proportion has increased since the start of the Programme although this has fluctuated in the last year. These fluctuations are likely to be the influence of the more complex cohort makeup shown in chart 1b.

The proportion of each intake to reach 24 months on the Programme achieving Job Outcome payments was initially steady but has been rising for the last 4 months. For the March 2012 intake this was 27.6%, compared to 22.3% for the June 2011 intake.

Key messages

- The proportion for ESA new customers³ achieving a Job Outcome payment after 12 months support was fairly constant up to May 2012 at 1 in 25 Referrals. Since May 2012 this has been increasing and at March 2013 stands at around 1 in 11.
- The proportion for the JSA 18-24 and JSA 25 and over payment groups, since the start of the programme has shown an increasing trend, with the latest intake achieving around double the proportion of the first intake. For those that joined the scheme in March 2013, this proportion was around 1 in 5 and 1 in 6 for the payment groups respectively.

Chart 3 (see also **Supplementary table 2.10** in Section C3) shows, for each monthly intake, the percentage of each Payment Group for whom providers were paid a Job Outcome payment within 12 months following referral.

The proportion of the Employment and Support Allowance (ESA) new customers intake group³ attaining a Job Outcome payment within a year was fairly constant up to May 2012, at around 1 in 25. Post May 2012 this proportion has been increasing with the last 4 months exceeding expectation and at March 2013 the proportion was around 1 in 11.

The proportion of the JSA payment groups, since the start of the programme has shown an increasing trend, with the latest intake achieving around double the proportion of the first intake. All of these payment groups show a dip in the November 2012 intake also reflected in Chart 2b. At March 2013 this proportion was around 1 in 5 and 1 in 6 for the payment groups respectively.

The proportion for the other ESA intakes was on a downward trend up to May 12, but this proportion has since stabilised. The proportion for the initial intake was around 1 in 14 and as at March 2013 this was down to around 1 in 33. However the numbers of Referrals to this group are 5 times higher than earlier intakes as shown in **Supplementary Table 2.11** and also make up a much bigger proportion of the total number of Referrals per month (see **Chart 1b**)

A4. Sustainment payments made to providers




Key messages

• Earlier intakes generally have a higher proportion attaining Sustainment payments and higher proportions with larger numbers of payments to providers, due to them having more time on the programme

The DWP consultation, which included future plans for Sustainment payment measures, has now closed and responses are being analysed. The outcome will be announced in a public response to the consultation. Future releases will incorporate developments resulting from the consultation, in particular around Sustainment payment measures.

Chart 4a (see also **Supplementary table 2.4** in Section C1) shows for each monthly intake, the proportion with at least one Sustainment payment up to the end of March 2014, broken down by the number of payments.

Earlier intakes have a higher proportion attaining Sustainment payments and higher proportions with larger numbers of payments than later intakes. This is intuitive as earlier intakes have had a longer period of support and more opportunity to attain Outcome payments.

Chart 4b (see also **Supplementary table 2.5** in Section C1) presents the proportion of each monthly intake that achieved all the Sustainment payments they could to the end of March 2014, broken down by the number of payments.

In each of the intakes, around 2/3rds, attained all possible Sustainment payments, following a Job Outcome, to the end of March 2014. Whilst the number of payments achieved is generally higher for earlier intakes, a lower overall proportion attained all the Sustainment payments compared to more recent intake. Again this is intuitive as earlier intakes have had more opportunity to attain Outcome payments than later intakes. They will also have had more time for a break in employment to occur.

Key messages

• Whilst more recent intakes to the programme spent more time off benefit, in the 12 months following Referral, than those referred in the early months of the scheme; for intake in the Programme's second 12 months this proportion has been decreasing.

Table 1.1 examines breaks in benefit for monthly intakes of Referrals who have received 12 months support on the Programme. The most recent monthly intakes have larger proportions with any break in benefit within those 12 months than the earliest intakes. For example compared with 50.2% of those referred in June 2011, the January, February, March 2013 intake of Referrals have 54.5%, 52.8% and 53.8% respectively. However, this proportion has decreased for successive intakes during the second 12 months of the Programme from a level of 61.7% for the April 2012 intake but has stabilised for the last 5 months to reach a year on the scheme. This decrease in the proportion with either a break in benefit in the first 12 months or who are off benefit 12 months after Referral is linked to the later intakes containing a higher proportion of harder to help claimants.

The proportion with a continuous break in benefit of 13 and 26 weeks within the 12 months is higher for the latest monthly intakes than the earliest intakes. For example for the March 2013 intake of Referrals 32.1% and 21.1% had a continuous break in benefit of 13 and 26 weeks compared with 25.8% and 16.3% for the June 2011 intake. Again, for successive intakes during the second twelve months of the Programme the proportions with 13/26 week breaks in benefit show a decrease from the levels of 34.3% and 21.7% for the June 2012 intake but are showing signs of stability in later months.

Up until the August 2012 intake, the proportion of monthly intakes that are off benefit at the end of the 12 month period was generally increasing month on month. However this proportion has dipped and levelled out in the last 2 quarters but is still above the early cohorts.

Whilst these figures represent evidence of movement off benefit, they do not, in isolation, provide direct evidence of movement into sustained employment or links with Job Outcome payments. This is because the breaks in benefit tables track continuous spells off benefit whereas providers can claim a Job Outcome payment based on the total time employed, irrespective of the number of spells.

DWP have been examining off benefit periods covered by employment using HMRC Real Time Information data for Work Programme participants where no Job Outcome payment has been paid².

Key messages

- Claimants referred up to the end of March 2012 spent more than a quarter of their allotted time on the programme off benefit.
- The average number of weeks off benefit for the first 7 months showed little variation however they has been an increase in the last quarter

Table 1.2 shows, for each monthly intake, the average number of weeks claimants spent off benefit in the 104 weeks on the programme. This shows that for the first seven intakes to have spent 24 months on the programme there is little variation from intake to intake, however intakes from the last quarter have on average over another month than the first 7. These findings are consistent with the results of the proportion of each intake which achieved a Job Outcome payment after 24 months, where all proportions of intakes to have reach 24 months on the programme were broadly the same until the last 3 months.

Key messages

- To date approaching 74 thousand claimants have stayed in sustained employment long enough to qualify for the maximum number of Sustainment payments possible.
- To date 477 thousand claimants returned to Jobcentre Plus after completing 104 weeks on the scheme, with 35 thousand of these finding sustained employment for 3 or 6 months during the 104 weeks.

The large majority of the Referrals to the programme, around 850 thousand, are still on the scheme as most Participants have not completed their allotted time on the Programme.

Almost 74 thousand claimants (10.5% of all those that have left the scheme) achieved the maximum number of Sustainment payments allowable on the scheme. A proportion of these achieved this within 104 weeks of referral and left the scheme, with the others remaining in employment after the 104 week point. It is worth noting that to achieve the maximum number of Sustainment payments takes a year and a half in employment as a minimum.

Just over 94 thousand claimants completed the 104 weeks of support and are still in employment, with their providers still receiving Outcome payments. Eligibility to further payments for these individuals will cease following a break in employment.

3 thousand claimants left the programme early, either due to being referred to another scheme or in a minority of cases due to death.

477 thousand claimants, who completed 104 weeks of support on the programme, were on benefit at that point and returned to Jobcentre Plus. **Supplementary table 2.6** in section C shows the proportion of each monthly cohort by status at March 2014. Note that due to the time taken to receive benefit information after the event the data presented for more recent intakes may be revised in subsequent releases⁸.

A further 47 thousand claimants were not on benefit after completing 104 weeks of support but did return to benefit after this point, without achieving the maximum number of Sustainment payments.

Out of the 705 thousand people who are no longer supported by the programme and who did not complete early, 1.4% (9 thousand) never attached to a provider in the 104 weeks from Referral.

This will include people referred up till the 3rd April 2012 as claimants are on the programme for 104 weeks, slightly less than 2 years.






Chart 5b: Numbers of Sustainment payments paid to providers by month:

Key messages

- Numbers of Job Outcome payments generally increase month on month till September 2012 and fluctuate thereafter.
- Numbers of Sustainment payments made to providers each month have generally increased since the start of the scheme.

Chart 5a (see also **Supplementary table 2.7** in Section C2) shows the number of Job Outcome payments made to Work Programme providers each month.

In total up to 31st March 2014 providers have received over 295 thousand Job Outcome payments. In the month of March 2014 there were 15 thousand Job Outcomes payments made to providers.

The month of payment is affected by the number of working days in each month. This is likely to explain the reduction in monthly Job Outcomes payments in December (and corresponding increase in January) as a result of the public holidays. The month of payment is also affected by Operational activity during the schemes infancy. The spike in September 2012 was due to around 8,000 Job Outcomes which were released for payment having initially failed automated checks and been subject to further validation.

Chart 5b (see also **Supplementary table 2.7** in Section C2) shows the number of Sustainment payments paid to providers each month, broken down by first and subsequent payments attained by an individual.

The number of Sustainment payments paid steadily increased from when they could first be paid in September 2011. By March 2014 there had been 2.35 million Sustainment payments made to providers, with 274 thousand individual Participants attaining at least one Sustainment payment.

Monthly fluctuations in the Sustainment payment time series can also be attributed to the same effects that affect the Job Outcome time series.

B3. Outcome payments paid to providers: Further Sustainment analysis


- Over 70% of Referrals who achieve a Job Outcome payment go on to claim 5 or more Sustainment payments: to end of December 2013.
- Just under two thirds of claimants went on to achieve the maximum possible number of Sustainment payments in the period covered by this release.


Table 1.4 (see also **Supplementary table 2.8** in Section C2) shows the breakdown by numbers of Sustainment payments achieved by individuals. 71% (196 thousand) of the individuals that achieve at least one Sustainment payment attained five or more by end of March 2014.


Table 1.5 shows the number of individual Referrals who achieve the maximum number of Sustainment payments that they could up to the end of March 2014, broken down by number of Sustainment payments.

Overall, for all Referrals with sufficient time following a Job Outcome payment, 65% of individuals attained the maximum possible number of Sustainment payments they could by 31^{sr} March 2014. Of those 139 thousand Referrals who had the opportunity to attain 13 or more Sustainment payments following a Job Outcome payment, over half (61.1%) did so.

B4. i) Contracts: Contractual Minimum Performance Levels







Key messages

- In the third financial year of the Work Programme, all contracts achieved the minimum performance levels for JSA 18-24, JSA 25 or over and ESA new customers³
- This compares to the second financial year where 16 contracts achieved the minimum performance level for JSA 18-24, 18 for JSA 25 and over. No contract achieved the minimum performance level for ESA new customers³. The contractual MPLs have limitations as noted on page 4.


Chart 6a, 6b and 6c (see also **Supplementary table 2.16** in Section C4) show the performance levels for JSA 18 to 24, JSA 25 or over and ESA new customers³ broken down by contract for the 2^{nd} and 3rd financial years of the Work Programme. The bars in the chart represent the proportion of in year Job Outcomes against Referrals by each Contract in year 2 and year 3 of the Work Programme. The blue and red lines indicate the Minimum Performance Levels for year 2 (33.0%, 27.5% and 16.5%) and year 3 (44.0%, 33.0% and 16.5%) respectively

Work Programme contracts are assessed in financial years. Provider performance is measured on an annual basis as the ratio of in year Job Outcomes to Referrals for three groups of Participants. This measure is assessed against Minimum Performance Levels which are set out in contracts. These contractual measures include people referred in the period who would not have been on the programme long enough to achieve a Job Outcome but allow a timely assessment of performance; the levels set were necessarily based on historic data.

The contractual minimum performance levels were built using expected numbers of Referrals to the scheme. Since provider performance is the ratio of Job Outcome payments to Referrals, changes in actual referral patterns can impact on the comparison with Minimum Performance Levels. The measures above should be considered against a pattern of declining Referrals leading to percentages that are above 100% for JSA 18-24 payment groups in some contracts.

An independent review of Work Programme measures recommended that expectation be published alongside key measures. The Department is currently working through how these expectations should be derived and published.

B4. ii) Contracts: Referrals with 12 months support



Key messages

• Over 1 in 10 Referrals of all Referrals who had a least 12 months support achieved a Job Outcome payment.

Chart 6d (see also **Supplementary table 2.17** in section C3) shows the proportion of all Referrals who have received at least 12 months of support on the Work Programme and have achieved a Job Outcome payment within 12 months.

There is a distinct variation across contracts ranging from 8.0% to 14.4% across providers.

For all monthly intakes of Referrals who have received at least 12 months support on the Work Programme, 10.9% have achieved a Job Outcome payment within a year of Referral.



Key messages

- The gender, age, ethnicity and regional split of claimants being referred to the Work Programme are broadly in line with the benefits from which claimants are referred.
- The proportion of Work Programme claimants who achieve a Job Outcome payment split by gender, ethnicity and region are broadly in line with those referred to the scheme. However a higher proportion of younger claimants go on to achieve a Job Outcome compare to those that are referred.

Chart 7a (see also **Supplementary table 2.12** in section C3) shows the proportion of referrals and Job Outcome payments broken down by age and gender.

Just under two thirds of Work Programme Referrals and just over two thirds of Job Outcome payments are for male claimants. This is a similar proportion to those claiming JSA. A little over half of ESA claimants are male.

Around half of Referrals are under the age of 34 which is consistent with the proportion of JSA claimants as a whole. A little over a quarter of ESA claimants are under 34. Comparatively more younger people achieve a Job Outcome payment than are referred. For example 27% of all Referrals are aged 18-24 but the same age range is responsible for 36% of all Job Outcome payments paid to providers.

Table 1.6 shows the ethnicity summary breakdown Work Programme Referrals and Job Outcome payments. Almost 8 in 10 of Referrals are from Participants who view their ethnicity as "white"; roughly 1 in 15 as "Black/Black British" and just over 1 in 20 as "Asian/Asian British". These proportions are consistent with the proportion of JSA claimants as a whole.

The proportion of Job Outcome payments achieved across the ethnicity groups is consistent with the proportion of Referrals from each of these groups. For example the largest proportion of Job Outcomes payments was achieved by participants who viewed their ethnicity as 'White' which was comparable with the proportion of Referrals in this group.




Chart 7b (see also **Supplementary table 2.13**in Section C3) shows the proportion of the total Referrals to the Work Programme and Job Outcomes payments since the start of the scheme by region.

The highest proportion of Referrals to the Work Programme (3 in 20 referrals) were in the London region followed by North West (slightly less than 3 in 20 referrals) then West Midlands and Yorkshire and the Humber (both slightly over 2 in 20 referrals). This is comparable with the proportions of all JSA and ESA claimants in these regions.

The proportion of Job Outcome payments achieved across all regions is relatively consistent with the proportion of referrals.

These Claimants will be given the option of accessing the Work Programme and taking part on an entirely voluntary basis from their eligible entry point. They do not have a separate Opportunity/Claimant Group or Payment Group (PG) on PRaP.

2.6.8. Profiles

The Office of Budget Responsibility produces an independent aggregate Claimant count projection that is the basis of the Department's forecasting of Jobseeker's Allowance. The Department produces inflow and off-flow projections consistent with this overall projection, including splits into over and under 25 age groups, using assumptions based on trends in historical data.

Indicative Claimant volumes attaching to the Work Programme from the jobseeker's allowance (JSA) 18-24 group are profiled by applying an assumption about the rate of attachment of eligible Claimants to the Department's forecast volumes of JSA 18-24 year olds that reach the 9 month threshold stage of their claims.
