Notes

1. All figures are for 2012 and are derived from a sample of data for England and Wales.
2. Sample sizes have been rounded to the nearest 10 and consumption to the nearest 100kWh.
3. Only households with valid gas consumption (between 100 kWh and 50,000kWh) in 2012 have been included in the gas tables.
4. Only households with valid electricity consumption between (100 kWh and 25,000kWh) in 2012 have been included in the electricity tables.
5. Households with suspected estimated gas or electricity readings have been excluded.
6. Property attribute information is based on data from the Valuation Office Agency, floor area is in square metres.
7. Household information (tenure, household income and number of adults) is based on modelled data from Experian.
8. The following symbols are used in the tables:
 - x not shown in order to protect confidentiality (i.e. less than 30 records in the sample for this category).
 - .. not applicable (i.e. no households in sample for this category).
9. Column headings start with the prefix "N_" for number of households in sample, "Mean_" for mean consumption (kWh) and "Median_" for median consumption (kWh).
10. County, region and country totals are also included in the tables. The relevant names and codes are included in the LAName and LACode columns.
