

STATEMENT TO MEMBERS ISSUED IN CONNECTION WITH THE UNION'S ANNUAL RETURN FOR THE PERIOD ENDED 31 DECEMBER 2013 AS REQUIRED BY SECTION 32A OF THE TRADE UNION AND LABOUR RELATIONS (CONSOLIDATION) ACT 1992

Income and Expenditure

The total income of the union for the period was £32,490. This amount included payments of £5,626 in respect of membership of the union. The union's total expenditure for the period was £68,662

Salary paid to and other benefits provided to the General Secretary

The General Secretary of the union was paid £34,582 in respect of salary and £5,559 in respect of benefits (pension costs).

Irregularity Statement

A member who is concerned that some irregularity may be occurring, or have occurred, in the conduct of the financial affairs of the union may take steps with a view to investigating further, obtaining clarification and, if necessary, securing regularisation of that conduct.

The member may raise any concern with such one or more of the following as it seems appropriate to raise it with; the officials of the union, the trustees of the property of the union, the auditor or auditors of the union, the Certification Officer (who is an independent officer appointed by the Secretary of state) and the police.

Where a member believes that the financial affairs of the union have been or are being conducted in breach of the law or in breach of the rules of the union and contemplates bringing civil proceedings against the union or responsible officials or trustees, he should consider obtaining independent legal advice.

AUDITORS' REPORT TO THE MEMBERS OF

We have audited the financial statements of the National Union of Mineworkers [Leicester Area] for the year ended 31 December 2013 as set out on pages 3 to 11 in accordance with approved auditing standards.

We conducted our examination in accordance with the appropriate standards for reporting accountants issued by the Auditing Practices Board. This examination consisted of comparing the financial statements with the accounting records kept by the Union and making such limited enquiries of the Union's officers as we considered necessary for the purposes of this report. The examination was not an audit conducted in accordance with Auditing Standards. Accordingly, we do not express an audit opinion on the financial statements. Therefore, our examination does not provide any assurance that the accounting records and the financial statements are free from material misstatement.

Opinion

In our opinion, the financial statements give a true and fair view of the state of the Union's affairs as at 31 December 2013 and of its transactions and source and application of funds for the year ended 31 December 2013 and have been prepared in accordance with the requirements of the Trade Union and Labour Relations [Consolidation] Act 1992.
