


Income and Expenditure

The total income of the union for the period was £52,739. This amount included income of £51,933 from members in respect of membership of the union. The union's total expenditure for the period was £48,279. The union does not maintain a political fund.

Salary paid to and other benefits provided to the General Secretary, President and members of the Executive

The General Secretary of the union was paid £13,390 in respect of an honorarium and no benefits. The Treasurer of the union was paid £8,394 in respect of an honorarium and no benefits. The President and other members of the Executive Council were not paid any amounts in respect of salaries or benefits.

Irregularity statement

A member who is concerned that some irregularity may be occurring, or have occurred, in the conduct of the financial affairs of the union may take steps with a view to investigating further, obtaining clarification and, if necessary, securing regularisation of that conduct.

We have audited the financial statements of the Guild of Professional Teachers of Dance, Movement to Music and Dramatic Arts for the year ended 31st December 2012, which comprise the Income and Expenditure account, the balance sheet, and the related notes. In preparing those financial statements, the executive committee is required to:

- Select suitable accounting policies and apply them consistently;
- Make judgements and estimates that are reasonable and prudent;
- Prepare the financial statements on a going concern basis unless it is inappropriate to presume that the union will continue in business.

The executive committee is responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the union and to enable them to ensure that the financial statements comply with the Trade Union and Labour Relations (Consolidation) Act 1992 (as amended). They are also responsible for safeguarding the assets of the union and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Our responsibility is to audit and express an opinion on the financial statements in accordance with applicable law and International Standards on Auditing (UK and Ireland). Those standards require us to comply with the Auditing Practices Board's (APB's) Ethical Standards for Auditors.



- (d) we have not obtained all the information and explanations necessary for the purposes of our audit.


