Applicants must be internationally recognised as world leaders in their field. The specified documentary requirements are set out below:

Competent body endorsement and supporting documents to send with your initial entry clearance application:

For initial Tier 1 (Exceptional Talent) is a two stage process. Applying for endorsement from a competent body is stage one and applying for your visa is stage two. If you have already obtained your endorsement, you should submit a copy of your letter from the Home Office confirming your endorsement with your VAF 9.
