## Introduction

This official statistics release reports on early years and childcare inspections that occurred between 1 September 2008 and 30 June 2011 under Section 59 and 60 of the Childcare Act 2006.

Data for inspections carried out between 1 September 2008 and 31 March 2011 are final. Data for inspections carried out between 1 April 2011 and 30 June 2011 are provisional and subject to change. Ofsted will release final statistics for the period 1 April to 30 June 2011 on 8 December 2011.

## Key findings

### Latest quarter

- Ofsted carried out 5,194 inspections of childcare provision between 1 April 2011 and 30 June 2011. Most (91%) were inspections of providers on the Early Years Register who deliver the Early Years Foundation Stage. .
- Of the 4,738 Early Years Register inspections carried out, just under three quarters (77%) resulted in a judgement of good or outstanding for overall effectiveness and almost all (97%) were at least satisfactory. Three per cent were judged inadequate.
- A higher proportion of childcare providers on non-domestic premises were judged to be good or outstanding for overall effectiveness compared to the childminders inspected, at 81% and 74% respectively. However, a similar proportion of both types of provision were found to be inadequate (3% in both cases).
- The proportion judged good or outstanding in the three months between April and June 2011 was broadly similar across the four key judgements. The outcomes for children in the Early Years Foundation Stage was the most positive with 79% of providers inspected judged good or outstanding.
- Of the 4,738 Early Years Register inspections carried out, 4,181 (88%) also monitored the provider's compliance with the requirements of the compulsory part of the Childcare Register, while 4090 (86%) monitored compliance with the requirements of the voluntary part of the Childcare Register. Eighty-eight per cent of providers inspected met the requirements of the compulsory part, while 12% were set actions to meet the requirements. Compliance with the requirements of the voluntary part of the Childcare Register followed the same pattern, with providers meeting the requirements in 88% of inspections, and being set actions in 12% of inspections. Enforcement action relating to the requirements of the compulsory part of the Childcare Register was initiated after one inspection.
- Of the 439 providers inspected for their compliance with the requirements of the Childcare Register only, three quarters (75%) met the requirements. Just over a third of the 224 home childcarers inspected (who are on the voluntary part of the Childcare Register only) did not meet requirements, compared to 16% of providers on the compulsory part of the Childcare Register.

### Active providers inspected (1 September 2008 to 30 June 2011)

- As at 30 June 2011, 53,654 active early years registered providers had received an inspection since the introduction of the framework in September 2008. Two-thirds (66%) of these providers were childminders.
- At their most recent inspection, 72% of childcare providers were judged as good or outstanding for overall effectiveness and almost all (99%) were judged to be at least satisfactory. One percent was judged inadequate. A higher proportion of childcare providers

on non-domestic premises were judged to be good or outstanding for overall effectiveness compared to the childminders inspected, at 75% and 69% respectively.

- For 48,270 of these providers compliance with the requirements of the compulsory part of the Childcare Register was also monitored at their most recent inspection, while for 45,177 compliance with the requirements of the voluntary part of the Childcare Register was checked. Eighty-seven per cent met the requirements of the compulsory part, and 88% met the requirements of the voluntary part.
- Regionally, the East of England has the highest quality of early years registered provision, with 76% of active providers judged good or outstanding at their most recent inspection, followed by the South East with 75%. The North East and North West has the lowest quality, with 66% of active providers found good or outstanding at their most recent inspection.
- Since the introduction of the Early Years Foundation Stage, 6,009 early years providers have been inspected and were no longer active at 30 June 2011. Of these providers, 11% were inadequate at their last inspection.

#### Actions and recommendations

- Inspectors raise actions to ensure statutory requirements of the Early Years Foundation Stage are being met. An action that is raised where provision is overall satisfactory or better will be for failure to meet some or all of a welfare requirement that has limited impact on the quality of the provision or outcomes for children. Providers are given a short timescale to put things right. One or more actions to meet the statutory requirements of the early years register were set in 24% of Early Years Foundation Stage inspections carried out between 1 April 2011 and 30 June 2011. Most actions were set against welfare requirements, with one or more safeguarding and welfare requirement actions set at 11% of inspections.
- Since the Early Years Foundation Stage was introduced in September 2008, one or more actions to meet statutory requirements of the Early Years Register were set in 28% of the Early Years Foundation Stage inspections. Most actions were set against welfare requirements with one or more safeguarding and welfare requirements actions set at 13% of inspections. Fewest actions were set against learning and development requirements, with 1% of inspections resulting in actions here.
- The highest proportion of recommendations set between 1 April 2011 and 30 June 2011 (42%) was against the organisation requirement, which requires providers to plan and organise their systems to ensure that every child receives an enjoyable and challenging learning and development experience that is tailored to meet their individual needs. This was followed by the three learning and development requirements, where 30% of inspections received one or more recommendations surrounding educational programmes and 18% of inspections received one or more recommendations on the early learning goals and assessment arrangements.

## Methodology

1. The data in this release are from inspections undertaken between 1 September 2008 and 30 June 2011.
2. Statistics relating to inspections undertaken in the most recent quarter are provisional and include inspections in the period where the inspection report was published within one month of the end of the quarter. If exceptionally, an inspection report is published later than one month after the end of the quarter in which the inspection took place, it will be included in the final release of the statistics.
3. Statistics relating to the most recent inspection outcome of providers include inspections up to the end of the period, where the inspection report was also published at that date. This means that where the most recent inspection outcome of a provider took place during the period, but the report was not published at the end of the period, it will be excluded from the analysis. Where there is one, the outcome of the next most recent inspection will be included in the analysis instead.

6. Early years and childcare providers are allocated to local authority areas according to their postcode, using the National Statistics Postcode Directory. For a small number of providers, local authority and region information is not available at the time of the analysis. These are categorised as "Local authority not recorded" and "Region not recorded" in the Excel format tables.
7. A small proportion of early years registered providers are inspected as part of a school. The inspection outcomes from these providers are not included in this release, but will be covered within Ofsted's official statistics on maintained schools inspection and outcomes (already available) and independent schools inspections and outcomes (to be released for the first time by the end of September 2011).

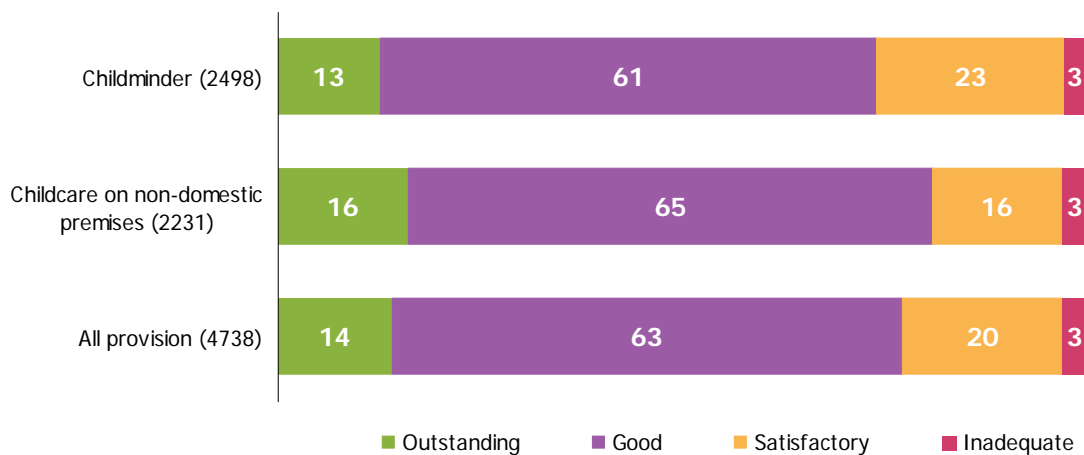

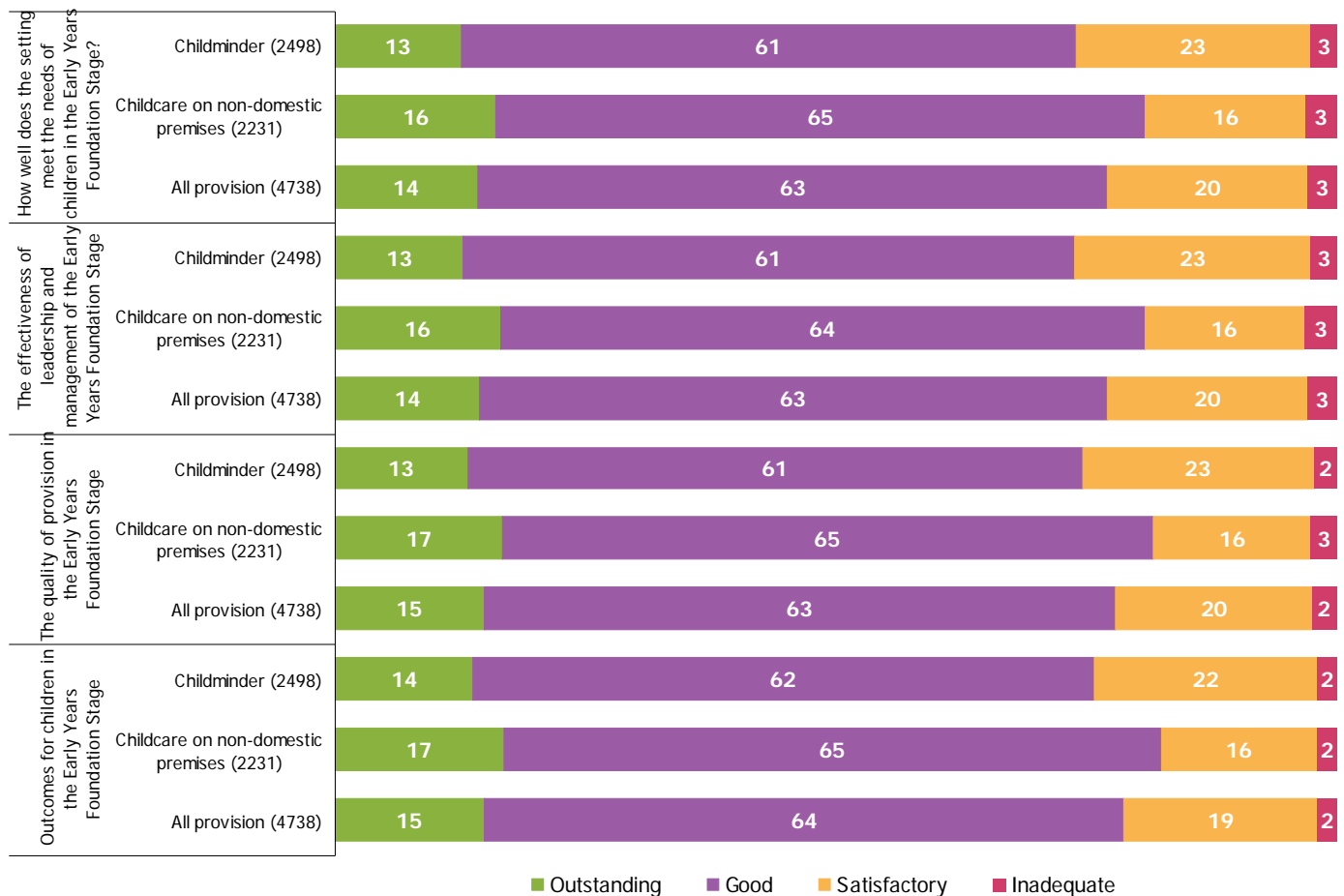

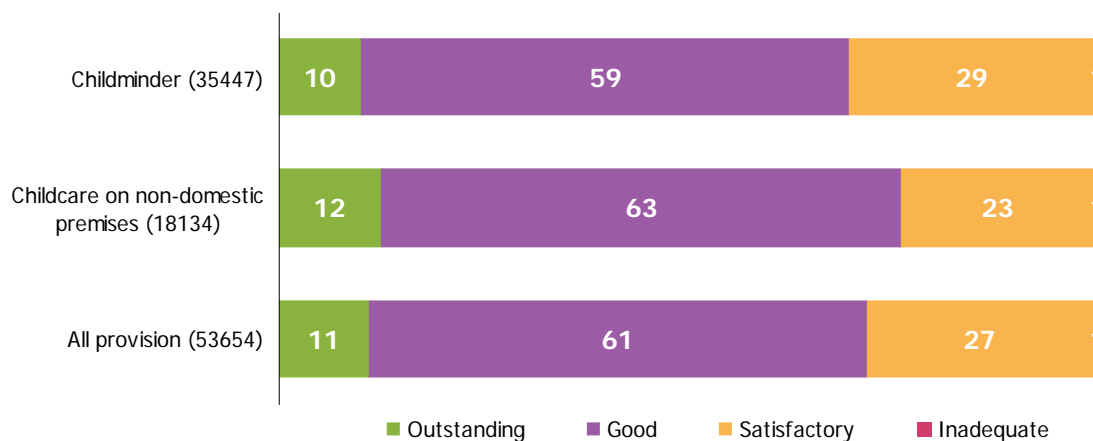

**Chart 4: Key inspection judgements of active early years registered providers at their most recent inspection as at 30 June 2011<sup>1 2</sup>**

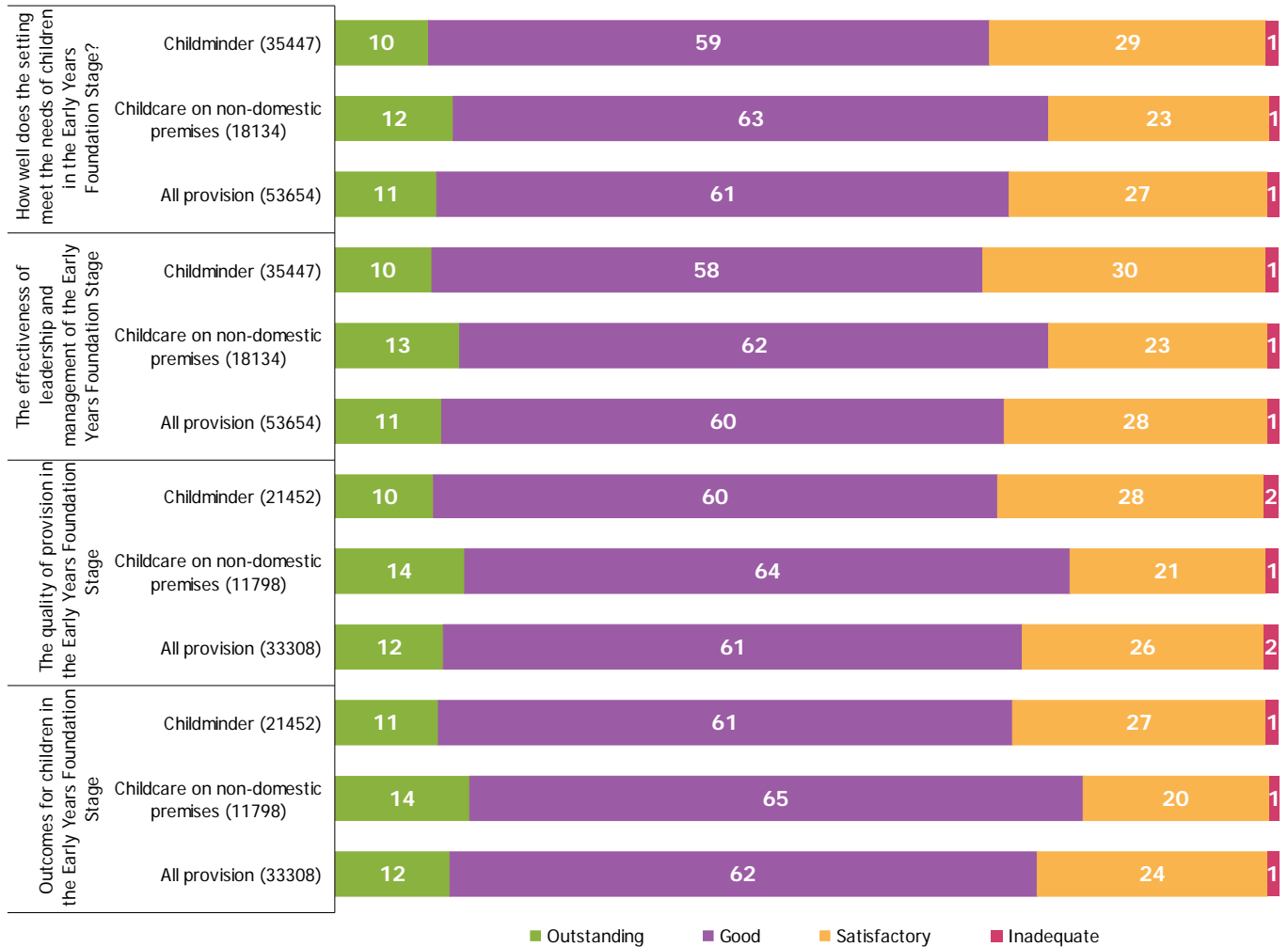

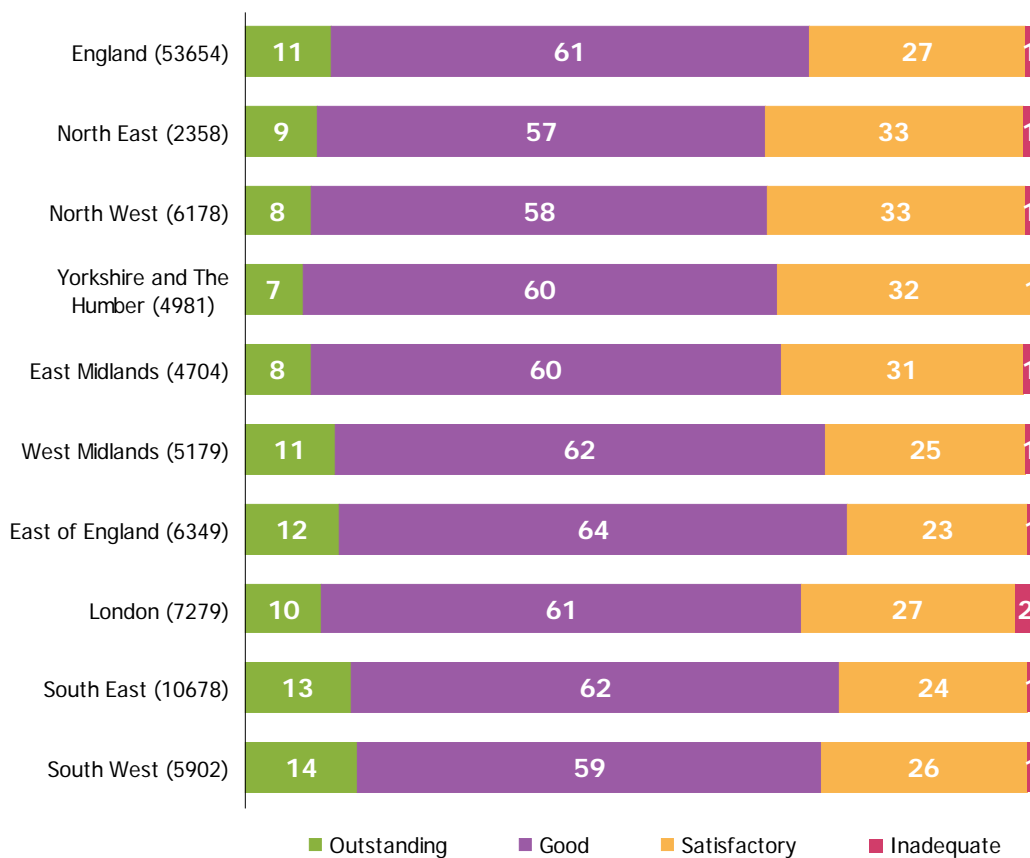

## **Glossary**

### **Actions**

Inspectors raise actions to bring about compliance with the statutory requirements of the Early Years Foundation Stage where these are not met at inspection. Usually actions result in one or more judgements being inadequate. In some cases where a specific requirement or part of a requirement is not met but the inspector considers that the overarching general legal requirement is met, the provider has a history of compliance and the impact on children is not significant, then the inspector may judge the relevant judgement to be 'satisfactory' or, on very rare occasions, 'good'. Providers are given a short timescale to put things right.

### **Childminder**

This is a person who is registered to look after one or more children, to whom they are not related, for reward. Childminders work with no more than two other childminders or assistants.

They care for:

- children on domestic premises that are not usually the home of one of the children, unless they care for children from more than two families wholly or mainly in the homes of the families
- at least one individual child for a total of more than two hours in any day. This is not necessarily a continuous period of time.

### **Childcare providers**

Childcare providers care for at least one individual child for a total of more than two hours in any day. This is not necessarily a continuous period of time. They must register to care for children under the age of eight, unless they are not required to do so; and can choose to register to care for older children. The early years and childcare sector comprises four main categories of provider: childminders, childcare providers on non-domestic premises, childcare providers on domestic premises and home childcarers. A childcare provider may be inactive because they have resigned or they have had their registration suspended or cancelled by Ofsted.

#### **Childcare providers on domestic premises**

These are people providing care on domestic premises with at least three other people. They can provide the care directly or employ people to work with them. The difference between childminding and childcare on domestic premises is the number of people involved; if four or more people look after children at any time they are providing childcare on domestic premises, not childminding.

## **Childcare providers on non-domestic premises**

These are people or organisations providing care for individual children in premises that are not someone's home. These premises can range from converted houses to purpose built nurseries.

## **Childcare Register**

The Childcare Register has providers who care for children from birth to 17 years. It has two parts:

- **the compulsory part**

Providers must register if they care for one child or more from the 1 September following their fifth birthday until they reach their eighth birthday for a period of more than two hours in any day.

- **the voluntary part**

Providers who are not eligible for compulsory registration may choose to register here. These are mainly people looking after children aged eight and over, or providing care in the child's home like a nanny.

Ofsted inspects a random 10% sample of providers who are registered only on the Childcare Register, and not on the Early Years Register, each year.

## **Early Years Foundation Stage**

The Early Years Foundation Stage (EYFS) is a comprehensive statutory framework introduced in September 2008 that sets the standards for the learning, development and care of children from birth to five.

## **Early Years Register**

The Early Years Register records providers who look after children from birth to school age (that is 31 August after the child's fifth birthday). It is compulsory for such providers. Providers on this register must meet the requirements of the Early Years Foundation Stage. Ofsted inspects all providers on this register at least once in a 47-month period to judge each provider's overall effectiveness.

## **Home childcarers**

Home childcarers are usually nannies who care for children of any age up to their 18th birthday wholly or mainly in the child's own home, and care for children from no more than two families. They are not required to register with Ofsted but may choose to do so on the voluntary part of the Childcare Register.

## **No children on roll inspections**

If an inspection is scheduled and there are no children on roll at the time of the inspection it should be deferred and the no children on roll letter EYL 409 sent to the provider. This letter explains to the provider that the inspection is being deferred as there are no children on roll. The provider must inform Ofsted when they start to care for children. The only exceptions to this are:

- if it is towards the end of a provider's prescribed period for inspection and an inspection needs to be carried out for Ofsted to fulfil its regulatory role
- it is a reinspection of those judged inadequate for overall effectiveness at their last inspection and it has reached the trigger point for the reinspection
- if the provider is scheduled for inspection as part of the 10% Childcare Register inspections because they are only registered on that register. In these cases the inspection is not carried out unless the provider is selected as part of the random selection in future or because there is a complaint about the provider relating to the requirements for registration.

## **Recommendations**

Inspectors make recommendations to improve the quality of the provision. These recommendations relate to the principles, practice guidance and statutory guidance of the Early Years Foundation Stage.
