

Financial Sanctions Notice

27/01/2015

Ivory Coast (Cote d'Ivoire)

Introduction

1. Council Regulation (EC) 560/2005 ("the Regulation") imposing financial sanctions against Ivory Coast has been amended so that an asset freeze no longer applies to the person listed in the Annex to this Notice.

- 2. The following entry has been <u>removed</u> from the consolidated list and is no longer subject to an asset freeze.
 - DJEDJE, Alcide (Group ID:11777)

Legislative details

- 3. On 27 January 2015 Council Implementing Regulation (EU) No 2015/109 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L 20, 27.1.2015, p.4) by the Council of the European Union.
- 4. The Amending Regulation amended Annex I to the Regulation with effect from 27 January 2015
- 5. The Amending Regulation reflects the decision made on 20 November 2014 by the United Nations Security Council (UNSC) Committee established pursuant to Resolution 1572 (2004) to remove one individual from the UN Ivory Coast list.
