

General Notice of Final Designation Amendments

13/02/2015

Terrorism and Terrorist Financing

Introduction

1. Information for a designated person has been amended under the Terrorist Asset-Freezing etc. Act 2010.

The reason for this Notice

2. The Treasury has made amendments to the information held on the consolidated list in respect of HIZBALLAH MILITARY WING with effect from 13 February 2015.

What you must do:

- 3. You must
 - i. check whether you hold any accounts, funds or economic resources for, or provide financial services to, the person set out in the Annex to this notice.
 - ii. freeze such accounts or other funds
 - iii. suspend the provision of any financial services to that person
 - iv. refrain from dealing with such funds or making them available to such person unless licensed by the Treasury.
 - v. report any findings to the Treasury, together with any additional information that would facilitate compliance with the Act

- vi. provide any information concerning the frozen assets of designated persons that the Treasury may request. Information reported to the Treasury may be passed on to other regulatory authorities or law enforcement.
- vii. if you have <u>already reported</u> details of accounts held frozen for designated persons, you are not required to report these details again.
- 4. Failure to comply with financial sanctions legislation is a criminal offence.
- 5. Some dealings with funds and economic resources that would otherwise contravene the Act, can be licensed by HM Treasury. You can find out about applying for a licence, as well as information about General Licences, in our FAQs:

- 6. The Terrorist Asset-Freezing etc. Act 2010 implements the terrorist asset freezing requirements of UN Security Council Resolution 1373 (2001) and Council Regulation (EU) No 2580/2001 in the UK.
- 7. The Treasury's Consolidated List of persons subject to financial sanctions in effect in the UK, which is maintained on the Gov.uk website, has been updated to reflect the Amendment.
