

Thank you for your email of 7 May, requesting the following information:

"The information I am seeking to obtain is:

- 1. The total number of RAF personnel who are subject to AIP recovery action?
- 2. The total number (to date) of RAF personnel who have submitted their first Objection Against Recovery Action or Request for Non Standard Repayment (Appendix 1) and who Objected to Recovery?
- 3. The total number of RAF personnel who were successful (to date) in their first objection?
- 4. The total number (to date) of RAF personnel who have submitted their second Objection Against Recovery Action or Request for Non Standard Repayment (Appendix 1) and who Objected to Recovery?
- 5. The total number of RAF personnel who were successful (to date) in their second objection?"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD), and I can confirm that all the information in scope of your request is held in the table below.

However, some of the information held falls entirely within the scope of the absolute exemptions provided for at Section 40 (Personal Data). Section 40(2) has been applied to some of the information in order to protect personal information as governed by the Data Protection Act 1998. This is also in line with Defence Statistics rounding policy. Section 40 is an absolute exemption and there is therefore no requirement to consider the public interest in making a decision to withhold the information.

Please note the numbers provided are as at 22 May 2015.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
