Introduction

1. Council Regulation (EU) 36/2012 ("the Regulation") imposing financial sanctions against Syria has been amended so that an asset freeze no longer applies to the person listed in the Annex to this Notice.

2. The following entry has been removed from the consolidated list and is no longer subject to an asset freeze.
 - AL-ASSAD, Fawwaz (Group ID: 11904)

Legislative details

3. On 23 June 2015 Council Implementing Regulation (EU) No 2015/961 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L 157, 23.6.2015, p.20) by the Council of the European Union.
4. The Amending Regulation amended Annex II to the Regulation with effect from 24 June 2015.
