### REQUEST FOR INFORMATION: NEONICOTINOIDS

Thank you for your request for information, which we received on 29 July 2015. You requested that we provide the agenda, minutes and list of attendees for the meetings held in the week preceding your request in relation to the proposed use of neonicotinoid seed treatments during the autumn 2015 planting season. As you know, we have handled your request under the Environmental Information Regulations 2004 (the EIRs).

We have interpreted your request to refer to meetings held during the week commencing Monday 20 July 2015, being the week immediately preceding your request, and relating to the recent issue of emergency authorisations for the use of pesticides containing neonicotinoids. However, please let me know if we have misinterpreted your request.

There was one meeting in the week commencing 20 July 2015, which was held on 21 July 2015 to discuss applications for emergency authorisations for the use of pesticides containing neonicotinoids.

There was neither an agenda nor any minutes for this meeting. Therefore, this information is not held by Defra.

With regard to the information relating to the attendees that you have requested, we can disclose the names and roles of the Minister and officials in the Senior Civil Service (SCS) and the roles of non-SCS staff who attended the meeting. However, we are withholding the names of the non-SCS staff.

The names of the non-SCS staff who attended the meeting are being withheld under regulation 12(3) read in conjunction with regulations 13(1) and 13(2)(a)(i) of the EIRs, as the information constitutes personal data relating to persons other than you. These regulations provide that personal data relating to other persons is exempt information if disclosure would breach any of the data protection principles in the Data Protection Act 1998 (DPA). We consider that disclosure of this information is likely to breach the first data protection principle in Schedule 1 to the DPA, which relates to the fair and lawful processing of personal data. Disclosure would not constitute 'fair' processing of the personal data because the information relates to non-SCS members of staff who are not public-facing officials and who would not expect their names to be publicly disclosed.


