Introduction

On 29 September 2014 Natural England submitted a coastal access report relating to the stretch of land between Hopton- on-Sea and Sea Palling ("the coastal access report") to the Secretary of State for Environment, Food and Rural Affairs under section 51 of the National Parks and Access to the Countryside Act 1949 ("the 1949 Act"), pursuant to its duty under section 296(1) of the Marine and Coastal Access Act 2009 ("the 2009 Act").

A person was appointed under paragraph 4(2) of Schedule 1A to the 1949 Act, inserted by Schedule 19 to the 2009 Act ("the Schedule"), for the purpose of considering whether the proposals in the coastal access report failed, in the respects specified in the objections received by Natural England under paragraph 3 of that Schedule in relation to that report, to strike a "fair balance" as a result of the matter or matters specified in those objections ¹.

In reaching her determination under section 52 of the 1949 Act the Secretary of State has considered:

- a. Hopton- on-Sea to Sea Palling Natural England's coastal access report submitted to the Secretary of State on 29 September 2014;
- b. in accordance with paragraph 16(1)(a) of the Schedule, the objections which the appointed person determined to be admissible objections;
- c. in accordance with paragraph 16(1)(b) of the Schedule, Natural England's comments on the admissible objections which it sent to the Secretary of State;
- d. in accordance with paragraph 16(1)(c) of the Schedule, the reports given to the Secretary of State by the appointed person in respect of the objections which the appointed person determined to be admissible objections; and
- e. in accordance with paragraph 16(1)(d) of the Schedule, representations made by a person within paragraph 2(2)(b) to (f) of the Schedule, and the summary of other representations made, and Natural England's comments on those representations which it sent to the Secretary of State on 31 March 2015.

In this notice -

(a) "objection" means an objection about the coastal access report which is made under paragraph 3 of the Schedule; and

¹ A "fair balance" means a fair balance between the interests of the public in having rights of access over land, and the interests of any person with a relevant interest in the land, as set out in section 297(3) of the 2009 Act and paragraph 1(b) of the Schedule. A person has "a relevant interest in the land" if he is the owner of the land, holds a term of years absolute in the land, or is in lawful occupation of the land: see section 55J(2) of the 1949 Act.

(b) "representation" means a representation about the coastal access report which is made under paragraph 7 of the Schedule.

Secretary of State's approval of coastal access proposals

The Secretary of State has determined to approve the proposals set out in the coastal access report so far as they relate to those parts of the route (and associated coastal margin) in relation to which no objections or representations were made.

In the respects specified in the objections set out at **Annex A** to this notice, the Secretary of State determines that the proposals set out in the coastal access report **do not fail** to strike a "fair balance" as a result of the matters specified in the objection. She therefore approves the proposals set out in the coastal access report, so far as they relate to that part of the route (and associated coastal margin) to which those objections relate.

The conclusions and observations of the Secretary of State in relation to the representations are set out in **Annex B** to this notice.

Secretary of State notes the representation and that Natural England has statutory obligations in respect of sites and features. As such Natural England has undertaken an Access and Sensitive Features Assessment in line with the Habitat Regulations to ensure there is no likely significant effect resulting from its proposals, alone or in combination on the Natura 2000 site, or on the sensitive species and habitats along this stretch of coast including protection of the grey seal. The Secretary of State also notes that management measures have been identified as part of this assessment which will ensure no negative effects on the grey seals when the new access arrangements are introduced. These measures include continued wardening by Friends of Horsey Seals during the seal breeding season with areas of the beach cordoned off. She approves route sections HSP-S008 to S013.

Secretary of State's conclusion and observation:

Secretary of State notes the representation and that walkers are encouraged to follow the Countryside Code when exercising their coastal access rights, which includes keeping dogs under effective control and cleaning up after them. Where necessary, signs may be installed reminding walkers of their responsibilities. She further notes that the ongoing maintenance and management of the coastal route will be the responsibility of the local Access Authority, and Natural England will put a rolling agreement in place with them to meet these requirements. She further notes that Natural England investigated five other alignment options along this stretch of coast and that the reasons for not proposing any of these options are explained at paragraph 5.2.2 of its report to the Secretary of State. She approves route sections HSP-5-S012 to S014.

Secretary of State notes that the representation and the suggestion that the coastal route should follow the cliff top. She further notes that Natural England investigated the option for trail alignment between the cliff top and the seaward boundary of the Holiday Village but was unable to propose this alignment option because the public footpath shown on the map along the top of the cliff was no longer safe or convenient to follow due to erosion. She also notes that when the main route may not be available to walkers due to tides and severe weather Natural England has proposed an optional alternative route be made available to walkers, part of which is through Hopton Holiday Village. She approves route sections HSP-1-S003 to S004 and HSP-1-A001 to A006.

She further notes that management measures have been identified as part of this assessment which will ensure no negative effects on the interest features/ sensitive features of the site. She asks Natural England to continue to prioritise working in partnership with RSPB and other local partners to ensure the little terns' long-term future on this section of coast and that should the current programme of activities become unsustainable at any point in the future, it should use its powers under Chapter II of the Countryside and Rights of Way Act 2000 to put in place restrictions or exclusions on coastal access rights on nature conservation grounds. She approves route sections HSP-2-S002 to S003, HSP-3-S001 to S006 and HSP-4-S004 to S009.
