## General Notice of Revocation of Final Designation

### Terrorism and Terrorist Financing

#### Introduction

1. One designation has been revoked under the Terrorist Asset-Freezing etc. Act 2010 ("the Act").

#### The reason for this Notice

2. The Treasury revoked the final designation made in respect of Bilal ABDULLAH with effect from 10 December 2015.
3. This means that Bilal ABDULLAH is no longer a designated person for the purposes of the Act and is no longer subject to financial sanctions imposed by the Act.

#### Other information

4. The Act implements the terrorist asset freezing requirements of UN Security Council Resolution 1373 (2001) and Council Regulation (EU) No 2580/2001 in the UK.
5. The Treasury's Consolidated List of persons subject to financial sanctions in effect in the UK, which is maintained on the Gov.uk website, has been updated to reflect the removal of Bilal ABDULLAH, listed in the Annex.
