Thank you for your correspondence of 29 May 2012. You have requested the following information:

*Further to DECC's reply (11/1037) of 2 September 2011 from Employee Engagement and Workforce Planning, to my FOI request, please could you update the data provided in your response.*

*I should be grateful for a list indicating the number of all secondments a) from DECC to outside of Government b) from outside Government into DECC, since 2 September 2011.*

*It would be helpful to know for each secondment, the names of the outside organisations and the offices within DECC that people were being seconded to or from, and the length of time of each secondment.*

*I should make it clear that I am not asking for the names of individual secondees.*

#### Freedom of Information Act 2000
