

Based on the outcome of our Public Consultation on the Department's Draft Statistics Plan for 2011/12 and our Response to that consultation

Introduction

On 13th April 2011, the Department published its 'Draft Statistics Plan for 2011/12' for public consultation. This Plan described our proposals for collecting and publishing official statistics over the period April 2011 to March 2012. The original closing date for the consultation was 16 May but this was later extended to 3rd June in response to requests from a number of our users. In the documentation which accompanied the Plan we asked potential respondents to the consultation to address the following issues:

- their views on the extent to which our planned deployment of resources would meet their needs for official statistics from DCLG;
- their reactions to our proposals for either retaining; realigning; re-engineering; or terminating our portfolio of statistical products;
- their ideas for the development of any new statistics, products or services;
- their suggestions for any further reductions in the amount of data we collect and publish beyond those already incorporated in the Plan, or submitted in the context of the Department's published 'Single Data List';
- the range of uses to which they tend to put our statistics.

Statistics Plan – Summary of Contents

The main body of the Draft Statistics Plan for 2011/12 consisted of a set of seven Annexes which classified each of the 62 statistical products normally published by the department under one of the following statistical 'Themes':

- Local Government Finance

- Housing and Homelessness
- Planning Performance and Land Use
- Deprivation
- Communities and Citizens
- Fire and Rescue
- Other Business Areas

Within each Annex we described our detailed proposals for either retaining; re-aligning; re-engineering; or terminating each of the statistical products listed within that Theme.

In this respect the consultation which accompanied the Plan differed conceptually from DCLG's earlier public consultation on the 'Single Data List' (SDL). The SDL focused exclusively on the mandatory 'data collections' which government departments and their arms-length bodies require from Local Authorities, whereas the main focus of the Statistics Plan was on the end-products derived from those data collections.

In broad terms, our Statistics Plan invited users' reactions to our proposals to retain 36 (i.e. 58%) of the 62 official statistics products listed in the Plan, modify 9 (i.e. 15%) of them, and close down the remaining 17 (27%).

Outcome of Public Consultation

In response to our public consultation we received over 60 individual submissions from a wide spectrum of organizations, both public and private. A complete list of respondents to the consultation, classified by type, is shown in **Appendix A**.

Overarching Issues raised by respondents

A summary of the overarching or more strategic issues raised by respondents to the consultation is given in **Appendix B** along with the Department's overall response to the issues raised.

Specific issues raised by respondents

The majority of respondents to the consultation focused on the second of the questions we posed in our consultation document, namely the degree to which they either supported or rejected our plans for each of the 62 statistical products listed in the Plan. Copies of each of the individual responses to the consultation can be provided on request (unless the respondent specifically requested anonymity). The individual submissions are summarized, anyway, in **Appendix C**, where they have been grouped by individual product and by type.

Our formal ‘Response to the Public Consultation’

The Department’s proposals for addressing the more specific issues raised with respect to each of the 62 products listed in the Statistics Plan are described in **Appendix D**. This constitutes the Department’s formal response to the public consultation on our Statistics Plan and, as such, meets the requirements set out in the Government’s *Code of Practice on Consultation*.

Looking to the Future

We are committed to user engagement and anticipate publishing Statistical Plans on a regular basis – possibly on a multi-year, rolling basis. This will ensure that users continue to have opportunities to comment on our proposed statistical collections and products.

In the meantime, and until such time as we have published a further Plan, the product portfolio set out in Appendix D forms the basis of our planned statistical work program from April 2012 onwards

Summary of overarching comments on the Draft Statistics Plan

The vast majority of respondents to our public consultation directed their attention to our detailed proposals for the future management of the 62 individual products listed in the seven Annexes to the Draft Statistics Plan.

In so doing, however, a number of respondents took the opportunity to offer their views on a range of wider issues such as the consultation exercise itself; the Statistics Plan in its entirety; or DCLG's whole approach to the collection and publication of official statistics. Where a particular issue attracted a number of complementary comments from consultation respondents, we have described that issue below, along with our response to the points raised.

Overarching issues raised by a number of respondents	DCLG response
A number of respondents, particularly those with an interest in DCLG's Housing statistics, registered their concern at the short duration of the consultation (a little over six weeks), pointing out that it overlapped with a series of public holidays and did not follow the recommended norm of 12 weeks.	We deemed it important to ascertain the user community's views sufficiently early in the financial year to allow us to react accordingly. We also extended the duration of the consultation to cater for respondents' requests for more time. We recognize, however, that the timetable for this consultation was too hurried for some users. In future, we intend to give stakeholders more time to consider our proposals.
On behalf of some sections of the Housing Statistics Network, their Chair went further and criticized the whole basis of the consultation and particularly the fact that, in the opinion of some members, it lacked any strategic basis.	We reject the suggestion that our Statistics Plan lacked any connection with the Department's overall strategic objectives. As the Foreword to the Draft Plan indicates, it was drawn up in the context of the Department's published Business Plan for the years 2011-15, and with reference to the Department's earlier public consultation on the 'Single Data List' where the emphasis was on the Department's own, and other public bodies', data collections. Furthermore, the published 'Rationale' for each of our planned actions was directly linked to the strategic aims described in the Department's Business Plan.

Overarching issues raised by a number of respondents	DCLG response
<p>Several respondents declared that the Plan contained too little information to allow for a considered response, and requested further details about our proposals relating to a number of specified products. Others requested meetings with the relevant Statisticians in order to clarify what was intended in the Plan.</p>	<p>Some stakeholders may have been left with the mistaken impression that our consultation on the Plan was our last word on the subject. In many cases the ideas incorporated in the Plan were simply the first iteration of a set of proposals intended to become the subject of a more comprehensive consultation planned for a later date.</p> <p>In other cases our proposals were developed on the basis of earlier and more detailed consultations – all of which were listed in the published consultation document.</p>
<p>A few respondents suggested that DCLG should consider the possibility of outsourcing either its data collection activities, or its dissemination/publication processes</p>	<p>DCLG has recently reviewed its data collection activities in some areas and concluded that outsourcing was not viable either on cost/benefit grounds or for other reasons. Further reviews of other areas are planned this year. We continue to investigate new ways of disseminating our statistics and underlying data (subject to the necessary confidentiality constraints) and will work with others in the Government Statistical Service to support the government's wider 'Transparency' agenda.</p>
<p>A number of respondents raised issues that were not germane to the questions posed in the consultation document.</p>	<p>Where appropriate, we have replied directly and separately to the correspondent concerned.</p>
