How to pay

DO NOT SEND CASH TO DVLA.

You can use a cheque or postal order, payable to 'DVLA, Swansea'.

Please write your digital tachograph driver card number, GB driver number or your full name, address and date of birth on the back of the cheque or payable order.

We cannot accept damaged or altered cheques. If you send us a damaged or altered cheque, your application will be rejected and returned to you.

You must sign, date and write the amount on the cheque or your application will be returned. We do not accept post-dated cheques.



When will you receive your digital tachograph driver card?

Your tachograph driver card will be sent to your home address. Replacement driver cards will be issued within 8 working days of receiving a valid application.

First applicants and renewal driver cards should be received within 15 working days from the day we receive your application. It might take longer if we have to check your personal details. If your card does not arrive in this time, you can contact us in any of the following ways:

 Monday to Friday, and between 8am and 2pm on Saturdays

You will need to give your digital tachograph driver number, your GB driving licence number or your full name and date of birth.



Driving without a digital tachograph driver card

Tell us immediately if your card is lost, stolen, damaged or is malfunctioning. Phone us on $0300\ 790\ 6109$.

You must apply for a replacement card within seven days.

You can **only** drive without a card for up to 15 calendar days (or longer if it is necessary for the vehicle to return to its premises), as long as you can prove that you could not use the card during this period. **During this time you must keep records using Vehicle Unit (VU) Printouts.**

You cannot drive if your card has expired.

Replacement

If your card has been lost or stolen, you must apply for a replacement card within seven days. You can either:

Apply on-line at www. gov.uk/apply-driver-digital-tachograph-card or Phone 0300 790 6109 (between 8am and 7pm Monday to Friday, and between 8am and 2pm on Saturdays) to complete this form.

We only accept payments by Visa, Mastercard or Delta over the phone. A replacement card will be issued within eight working days of receiving a valid application.

Malfunctioning and damaged cards

Before applying make sure you try the card in another vehicle unit (VU) to make sure it is the card, not the VU, that is faulty. Check the VU manual to make sure that it is a card error.

Return your malfunctioning or damaged card to us.

If your card is malfunctioning and you do not return it, we will treat it as being lost and you will have to pay a fee for a replacement. You need to pay for a replacement if the card is lost, stolen or has been damaged. You should attempt to download data from your card before returning it to DVLA.

Renewing your card

Make sure you apply to renew your card at least 15 working days before it expires. Failure to do so will mean you will not be able to record information. Once the card expires it can only be used to display, print or download the data held on it. Expired cards do not need to be returned and should be kept for 28 days after expiry. Data must be downloaded from expired cards before they are disposed of. You as the driver are responsible for making sure your digital tachograph driver card is renewed before its expiry.

If your digital tachograph driver card has expired for more than 5 years

This record will have been deleted (to comply with UK General Data Protection Regulation (GDPR) guidelines).

To get a new card you need to reapply (as a first application) and pay the appropriate fee.

Change of name, gender, lost or stolen applications only

Do not return your digital tachograph card with this application.

When you receive your new card you will also be sent a confirmation of receipt letter which must be filled in and returned to DVLA.

Change of address

Do not return your digital tachograph card with this application.

If you are a GB driving licence holder you will only need to update the address on your driving licence as this will automatically update your digital tachograph record. You can do this online at www.gov.uk/change-address-driving-licence (to change address only).

Please note, no digital tachograph card will be issued. **Exchange**

Please do not return your digital tachograph card with this application. When you receive your new card you will also be sent a confirmation of receipt letter which must be filled in and returned to DVLA together with the card that is being exchanged.

Proof of your UK address

We cannot issue you with a digital tachograph driver card unless you normally live in the UK.

If you have lived in the UK for less than 185 days in the last 12 months, you must provide evidence which confirms your UK address.

We accept:

- a tenancy agreement
- a gas, electricity, water or phone bill issued within the last three months
- a bank statement dated within the last three months
- a tax code notice from HM Revenue & Customs
- a letter from your employer/employment agency
- a work permit

You must provide at least two of these documents as proof.

Buying a vehicle?

The tax is no longer transferable so you must tax it before you use it.



Your information is processed in accordance with the law on drivers' hours and tachographs. It may be shared with government organisations and law enforcement agencies in and outside the UK to check your application, to process the Driver Certificate of Professional Competence and for any other lawful reasons.
