Extinguishment Order 2015

Notice is hereby given that the above referenced Orders have been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Orders.

The **start date** for the above Orders is 01 March 2016.

Consideration of the Orders will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to divert the length of Public Footpaths described in Part 1 of the Schedule hereto to the line described in Part 2 of the said Schedule.

### SCHEDULE

#### PART 1

##### Description of site of existing paths

That length of footpath GNE 106 that runs from a point south west of Okle Clifford Farm at OSGR SO7460/2562 in a north easterly direction for 270 metres to a point south west of Okle Clifford Farm at OSGR SO7468/2587.

That length of footpath GNE 108 that runs a point north east of Okle Clifford Farm at OSGR SO7511/2577 in a north easterly and then westerly direction for 279 metres to a point north east of Okle Clifford Farm at OSGR SO7484/2577.

That length of footpath numbered GNE 109 that runs from a point north east of Okle Clifford Farm at OSGR SO7491/2589 in a south westerly direction for 139 metres to a point north east of Okle Clifford Farm at OSGR SO7484/2577.

##### Description of paths to be extinguished

That length of footpath GNE 106 that runs from a point south west of Okle Clifford Farm at OSGR SO7431/2562 in a south easterly direction for 296 metres to a point south west of Okle Clifford Farm at OSGR SO7460/2562.

That length of footpath GNE 108 that runs a point north east of Okle Clifford Farm at OSGR SO7511/2577 in a south westerly, southerly and then south westerly direction for 251 metres to a point west of Okle Clifford Farm at OSGR SO7463/2568.

That length of footpath numbered GNE 110 that runs from a point south west of Okle Clifford Farm at OSGR SO7457/2556 in a north easterly direction for 75 metres to a point south west of Okle Clifford Farm at OSGR SO760/2562.

That length of footpath numbered GNE 112 that runs from a point south east of Okle Clifford Farm at OSGR SO7471/2546 in a north westerly direction for 215 metres to a point south west of Okle Clifford Farm at OSGR SO760/2562.

## PART 2

### Description of site of new paths

A length of footpath that runs from a point north east of Okle Clifford Farm at OSGR SO7468/2587 in a south westerly direction for 240 metres to a point south west of Okle Clifford Farm at OSGR SO7457/2556.

A length of footpath that runs from a point north east of Okle Clifford Farm at OSGR SO7511/2577 in a south westerly direction for 330 metres to a point south east of Okle Clifford Farm at OSGR SO7496/2548.

A length of footpath that runs from a point north east of Okle Clifford Farm at OSGR SO7491/2589 in a south westerly direction for 358 metres to a point north west of Okle Clifford Farm at OSGR SO7458/2575.

Please Note: This extinguishment order together with the diversion order of some paths will take the footpaths from the immediate farmyard and buildings.

### **Timetable for sending in statements of case and comments**

#### **Within 2 weeks of the start date [by 15 Mar 2016]**

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

#### **Within 8 weeks of the start date [by 26 Apr 2016]**

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to

the Authority, everyone who has made an objection or representation and any other person who has written to us in respect of the Order.

**Within 14 weeks of the start date [by 07 Jun 2016]**

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order(s) must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.
