***FREEDOM OF INFORMATION***

Thank you for your e-mail to the Scotland Office of 20 March 2012.

You asked for the following information under the Freedom of Information Act 2000:

Please could you provide an itemised list of every time your department has used an official government car since Jan 2011.

Please can it be provided in an excel document with the following fields:

- date
- passengers (e.g. 'NAME OF MINISTER and special advisor', or 'NAME OF MINISTER and wife', or 'RED BOX ONLY' etc etc)
- travel from (POSTCODE or FULL ADDRESS)
- travel to (as above)
- cost

I am writing to confirm that the Scotland Office has now completed its search for information and the journeys are listed below.

The Scotland Office contract with the Government car service to provide Ministerial cars ceased during January 2011. Details of the journeys undertaken while the contract was in operation were not centrally recorded and are therefore not held for the purposes of the Act.

Cancelling the contract produced a significant reduction in cost but it was nevertheless necessary to use the Government Car Service on four occasions when the use of other transport was not appropriate. As requested I attach an excel spreadsheet detailing the information available with regards to the four journeys undertaken by Scotland Office Ministers using an official government car since January 2011.

I hope you find this helpful.
