

**Evaluation Report Title: Evaluation of the Long-term Development Cooper  
Between the UK and Vietnam**

**Response to Evaluation Report (overarching narrative)**

We are in agreement with the overall positive assessment about DFID Vietnam's performance. The reports have been comprehensive and thorough. They document well the breadth and depth of DFID support to Vietnam over the last 20 years. We also noted the caveats; short-comings; and the evaluators' cautious language in some of its conclusions, as this is a complex evaluation and a rare one of its type, and, therefore, there is a scope for further testing and improving the evaluation methodology.

We also noted that the Landell Mills synthesis report, while positive overall does not always draw out key findings from the subsidiary reports (the MDG Interim Report and the DFID Historical Overview). It is also somewhat contradictory in parts. This appears to be due to the different styles and areas of interest of the report's various authors and how purist they are in terms of evidence. On balance, this does not detract from the final document, rather it reflects the challenges of development and the attribution of results. It may also explain why some of the lessons and recommendations feel familiar (even perhaps generic) and could be applied elsewhere (as the reports notes).

We have shared the evaluation findings and lessons learnt broadly with the Government, development partners, think-tanks, civil society organisations; and with DFID internally.

For the main dissemination events we had the participation of the evaluation Team Leader to respond to donors’ questions.</p> <p>We also discussed with the Ministry of Planning and Investment and shared the documents with government agencies, particularly those who are in charge of drafting the new ODA strategic policy documents for Vietnam for 2016-2020.</p>

We also had follow-up sessions with them individually to share DFID lessons and approach including on graduation.</p>
<p>For the Government of Vietnam: [these could be applied elsewhere]:</p> <ul style="list-style-type: none"> <li>• Have a clear plan to improve systems and be willing to learn and pilot new systems based on international best practice.</li> <li>• Harmonise and promote coherence between government agencies. And between central and local levels.</li> </ul> <p>And two specific to Vietnam:</p> <ul style="list-style-type: none"> <li>• strengthen the capacity of sub-national government.</li> <li>• provide effective additional support to those provinces most in need and, in particular, ethnic groups with the lowest levels of development achievements.</li> </ul>	<p>Accepted</p>	<p>We have worked closely with the Government on this evaluation including during the dissemination phase. The Government has used the lessons and recommendations from the evaluation in their discussions on further cooperation for the period 2016-2020 with bilateral and multilateral donors. They also use the recommendations to improve their new ODA Strategic Framework and ODA related legal and policy documents.</p>
