- Q5. How many arrests and of those how many convictions were made in connection to any of the drug seizures in the past 5 years?
- A5. The majority of the Royal Navy's Counter narcotic operations happen as part of Atlantic Patrol Tasking (N). Under this construct we work with US Coast Guard Law Enforcement Detachments, which means that all arrests and prosecutions happen under their jurisdiction. As such we would not be privy to the outcome of any interdictions in the form of arrest and/ or prosecution within another State.
- Q6. What is the total cost of operations for Royal Navy ships deployed in counter narcotic operations in the last 5 years?
- A6. The Royal Navy Finance Department does not routinely analyse and collate the costs of the involvement of RN assets in exercises such as this. Output costing methodologies and processes are not in place within the Department to provide this information and there is currently no requirement for costs to be reported for this type of defence activity.
