

# **NOTICE OF ORDER**

## **HIGHWAYS ACT 1980 SECTION 119**

Essex County Council  
Public Path Diversion Order 2015 Footpath 62 Felsted in the District of  
Uttlesford

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is 30 June 2016.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to divert Footpath 62 in the parish of Felsted in the District of Uttlesford under section 119 of the Highways Act.

It is proposed that a part length of Footpath 62 Felsted starting from grid reference 56780, 21991 where it connects with Footpath 61 Felsted and running in a south easterly direction along the field edge for 150 metres to grid reference 56790,21980 then continuing in a north westerly direction along the side of the property known as 'Beazleys' for a distance of 50 metres to grid reference 56795,21983 where it terminates at the Chelmsford Road the B1417, should be diverted to a new route, 2metres in width commencing from the same above point and running in a north easterly direction across the field for a distance of 60 metres to grid reference 56785,21995 where it terminates at the Chelmsford Road, the B1417.

**Timetable for sending in statements of case and comments**

### **Within 2 weeks of the start date [by 14 July 2016]**

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

### **Within 8 weeks of the start date [by 25 August 2016]**

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, everyone who has made an objection or representation and any other person who has written to us in respect of the Order.

### **Within 14 weeks of the start date [by 6 October 2016]**

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

**In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.**

This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of the path should be diverted.


The landowner has agreed to defray any expenses which are incurred in the order making and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Uttlesford District Council have been consulted and have consented to the making of the Order as required by section 120(2) of the 1980 Act.

**BY THIS ORDER:**

1. The public right of way over the land situate west of Chelmsford Road in the Parish of Felsted known as Footpath 62 Felsted and shown by a bold continuous line on the map numbered FEL 62A contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 60 days from the date of confirmation of this Order.

2. There shall at the end of 60 days from the date of confirmation of this Order be a public footpath over the land situate west of Chelmsford Road in the Parish of Felsted known as Footpath 62 Felsted described in Part 2 of the Schedule and shown by a bold broken line on the map numbered FEL 62A contained in this Order.



## **SCHEDULE**

### **[PART 1]**

#### **DESCRIPTION OF SITE OF EXISTING PATH OR WAY**

A part length of Footpath 62 Felsted of unknown width shown by a bold continuous line on the Order Map commencing from point **A** at grid reference 56780,21991 where it connects with Footpath 61 Felsted running in a south easterly direction along the field edge for a distance of approximately 150 metres to point **B** at grid reference 56790,21980 then continuing in a north easterly direction along the side of the property known as 'Beazleys' for a further distance of approximately 50 metres to point **C** at grid reference 56795,21983 where it terminates at the B1417 Chelmsford Road.

### **[PART 2]**

#### **DESCRIPTION OF SITE OF NEW PATH OR WAY**

A footpath being 2 metres in width shown by a bold broken line on the Order Map commencing from the aforementioned point **A** running in a north easterly direction across the field for a total distance of approximately 60 metres to point **D** at grid reference 56785,21995 where it terminates at the B1417 Chelmsford Road.
