1. How many vacancies, part-time and full-time, were available to be filled for the role of 'Driving Examiner' in your most recent recruitment campaign in 2011?

There were vacancies at 80 driving test centres (DTCs) with some centres having more than one vacancy. It is estimated that there are in excess of 100 vacancies. It is not possible to supply the number of part and full time vacancies as the working pattern of the successful candidate would be discussed and agreed with the Test Centre Manager of their designated driving test centre.

2. Of those vacancies how many were filled by 'internal' candidates already working within the DSA?

Three internal DSA candidates have either taken up post as a driving examiner or are in the process of training to take up this post.

3. Of those vacancies how many were filled by external candidates?

18 external candidates have either taken up post as a driving examiner or are in the process of training to take up this post. An additional 12 candidates are currently waiting a date to begin training for the post.

4. Please provide me with a list of the vacancies, area by area and driving centre by driving centre?
