Shingles immunisation programme from 1 September 2016

This letter provides information about the fourth year of the shingles immunisation programme.

From 1 September 2016 shingles vaccine should be offered to:

- patients aged 70 years on 1 September 2016
- patients aged 78 years on 1 September 2016

In addition, patients who were eligible for immunisation in the first three years of the programme but have not been vaccinated against shingles remain eligible until their 80th birthday. These cohorts are:

- patients aged 71 to 73 on 1 September 2016
- patients aged 79 on 1 September 2016

Until 31 August 2016, GPs should continue to offer shingles vaccine to all those who were aged 70 or 78 on 1 September 2015.

Any individual who reaches their 80th birthday is no longer eligible for the vaccination due to the reducing efficacy of the vaccine as age increases. This reflects the recommendation^[1] made by the Joint Committee on Vaccination and Immunisation for the shingles immunisation programme.

Vaccine supply

Zostavax® [can be ordered online via the ImmForm website](#) and, it is recommended that practices hold no more than two weeks' worth of stock. Unused stock on 31 August 2016 may, of course, be used to immunise those requiring immunisation from 1 September 2016 if the vaccine remains in date. Please make sure that stocks of vaccine are rotated in fridges so that that wastage is minimised.


