Notice is hereby given that the above referenced Orders have been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the OrderS.

The **start date** for the above Orders is **19 July 2016**.

Consideration of the Orders will take the form of a public local inquiry.

The Inquiry will be held at **Committee Rooms 1&2, Middlesex Floor, Civic Centre 1, Station Road, Harrow, HA1 2XY** on **17 January 2017** at 10.00am.

The effect of the Orders, if confirmed without modifications, will be to:-

(1) Create a public footpath from point C adjacent to the south east corner of the southernmost tennis courts in a north easterly direction for a distance of 110m to point D, then in a north east direction along the line of the brook for 92m to point F as shown on the Order Map

(2) Create a public footpath from point C adjacent to the south east corner of the southernmost tennis courts in a north easterly direction for a distance of 110m to point D, then north along the tarmac path for 60m to point E as shown on the Order Map

(57) Divert part of the line of footpath 57 running from point A in a south direction for a length of 326m to point B on the Order Map, onto a new line commencing from point A in a north-east direction along footpath 59 for a distance of 30m to point J then in a south direction adjacent to the tennis courts for a distance of 312m to point C, then in a south west direction for a distance of 91m to Point B as shown on the Order Map.

(58) Divert footpath 58 running from point A in a south easterly direction for a length of 482m to point G, onto a new line commencing from a point A in a north-east direction along footpath 59 for a distance of 166m to point H then in a southerly direction along the tarmac path for a distance of 236m to point E and then in an easterly direction for a distance of 240m to point G as shown on the Order Map.

### **Timetable for sending in statements of case and proofs of evidence**

#### **Within 8 weeks of the start date [by 13 September 2016]**

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to everyone who has made an objection or representation and the applicant and any other person who has written to us in respect of the Order.

#### **Within 14 weeks of the start date [by 25 October 2016]**

Everyone who has made an objection or representation and anyone who wishes to give evidence at the Inquiry must ensure their statement of case<sup>1</sup> is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies to the Authority, the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents, although these will be available to view at the Authority's offices).

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy to the Authority, everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents, although these will be available to view at the Authority's offices).

#### **4 weeks before the date of the inquiry [by 20 December 2016]**

The Authority, everyone who has made an objection or representation, the applicant (if applicable) and anyone who wishes to give evidence at the Inquiry must ensure their proof of evidence (together with any summary) is


received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of:

- i) the Authority's proof of evidence to everyone who has made an objection or representation, the applicant and anyone who has submitted a statement of case (excluding copies of any supporting documents – although none should be submitted with a proof of evidence);
- ii) the applicant's proof of evidence to the Authority, everyone who has made an objection or representation and anyone else who has submitted a statement of case (excluding copies of any supporting documents – although none should be submitted with a proof of evidence); and
- iii) all other proofs of evidence to the Authority, the applicant, everyone who has made an objection or representation and anyone else who has submitted a statement of case (excluding copies of any supporting documents – although none should be submitted with a proof of evidence).

All parties must keep to the timetable set out above and ensure that statements of case and proofs of evidence are received by the Secretary of State on time. Late documents will be returned.



**THIS ORDER** is made by the London Borough of Harrow ("the Council ") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Council that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of the Order it is expedient that the line of the footpath should be diverted.

Harrow School has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new footpath into a fit condition for use by the public.

**BY THIS ORDER**

1. The public rights of way over the land situate at Harrow School playing fields and shown by a bold continuous blue line on the map attached to this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 7 days from the date of confirmation of this Order.
2. Notwithstanding this Order the National Grid Gas, UK Power Networks, Thames Water and Affinity Water (or such other Statutory Undertaker as shall for the time being have statutory powers in that respect) shall have the following rights over the land referred to in paragraph 1 namely to open up the land referred to in paragraph 1 to install maintain or alter their apparatus and shall continue to have the same rights in respect of such apparatus as they had prior to the making of the Order.
3. There shall at the end of 7 days from the date of confirmation of this Order be a public footpath over the land situate at Harrow School playing fields described in Part 2 of the Schedule and shown by a bold broken blue line on the Map contained in this Order

**THIS ORDER** is made by the London Borough of Harrow ("the Council") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Council that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of the Order it is expedient that the line of the footpath should be diverted.

Harrow School has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new footpath into a fit condition for use by the public.

**BY THIS ORDER**

1. The public rights of way over the land situate at Harrow School playing fields and shown by a bold continuous dark grey line on the map attached to this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 7 days from the date of confirmation of this Order.
2.
