Transitional Arrangements

There is no transitional period. The new fees must be used from 25/07/16.

The following guidelines apply:

- If the application is received before 25/07/2016 in a fit state to issue, then the old fee will apply even if it is issued after the fee increase.
- Any applications date stamped as received on or after 25/07/16 will be dealt with under the new fee order.
- Any applications received prior to the new fee order but returned because there was an error and then subsequently resubmitted after the fee increase will attract the new fee and customers should be informed of this.
- Amnesty days to allow the old fee charges to be processed on IFAS and Fee Account have been arranged as follows: **25.7.16 to 5.08.16**.
