I hereby apply to the Home Office for a VRS Assisted Return to my home country for myself and any dependents listed in this form. The information I have given in this form is complete and is true to the best of my knowledge.

I confirm that if, before this application is decided, there is a material change in my circumstances or those of any dependants, or new information relevant to this application becomes available, I will inform the Home Office.

I understand that all information provided by me to the Home Office will be treated in confidence; that it may be disclosed to other government departments, agencies, local authorities, the police, foreign governments and other bodies for VRS Assisted Return and other immigration purposes or to enable them to perform their functions; and that, if such bodies provide the Home Office with any information about me which may be relevant for immigration purposes, it may be used in reaching a decision on my application.

I understand that if I make a false statement in signing this form, the Home Office may terminate reintegration assistance at any time.

I understand that documents provided in support of this application will be checked for authenticity; and that false documents will be retained and may result in my application being refused and in my prosecution and subsequent enforced removal from the United Kingdom.

I understand that if I am informing the Home Office that I have changed my gender, these details may in certain circumstances be shared with other Home Office colleagues. I consent to this, where necessary and understand that this information will only be shared in limited circumstances relating to identity and security in line with Section 22 of the Gender Recognition Act. I am aware they will otherwise be treated in confidence and that my rights under the Equality Act 2010, Data Protection Act 1998 and Article 8 of the European Convention on Human Rights will be unaffected

I understand that the Home Office may take action to enforce my return in the event that I do not return by VRS Assisted Return within a reasonable timescale, as agreed with the Home Office.

I understand that, in applying for and/or returning under VRS Assisted Return I will be required to withdraw any and all outstanding claims or applications I have made to stay in the UK.

I understand that under UK law I may be subject to a re-entry ban for to the UK for between two and five years.

I understand that, if my application for a VRS Assisted Return is accepted, the Home Office will assist me to return home. I understand that I will not be allowed to stop over in any transit country, except where there is no direct flight to my home country.

Please note

Under UK law, the Home Office may discuss your details with medical services, social services or the police if it believes there is a real danger that you may harm yourself or other people, or there is a real risk of harm to children or vulnerable adults. In these situations it is not necessary to obtain your consent before discussing your details with these organisations.
