**FREEDOM OF INFORMATION ACT 2000 REQUEST REF: 0968-16**

Thank you for your email of 13 October 2016 asking for information under the Freedom of Information Act (FOIA) 2000. You asked:

1. *In November 2015, David Cameron pledged £6.6million to support Sri Lanka from the cross-Government Conflict, Stability and Security Fund (CSSF), previously called the Conflict Pool. Here is the announcement:*

*Please can you disclose:*

- a) *How much of this £6.6million was spent by October 13, 2016.*
  - b) *The names of each project funded by the money spent by October 13, 2016, how much went to each project, a description of what the money has been used for, names of recipient groups and names of other agencies, NGOs, charities or businesses worked with on each project.*
  - c) *The names of each project planned to be funded by the money from October 13, 2016, how much is planned to be spent on each, a description of what the money will be used for, names of planned recipient groups and names of any other agencies, NGOs, charities or businesses planned to work with on each project.*
2. *How much money from the cross-Government Conflict, Stability and Security Fund (CSSF) – or the Conflict Pool – was spent on Sri Lanka in each of the following financial years:*

I can confirm that the Foreign and Commonwealth Office (FCO) does hold information relevant to your request.

a) The total amount spent by 13 October 2016 was £525,477. Please note that the announcement by the former Prime Minister in November 2015 referred to funding over a three year period beginning in FY 16/17.

3. The Department for International Development (DFID) is the government department responsible for reporting Overseas Development Aid (ODA) spend. The figures for UK "aid" (ODA) spend are collated and published by the Department for International Development (DFID). Therefore, this information is exempt under section 21 of the Freedom of Information Act – Information accessible to the applicant by other means.

The figures for 2015/16 have not yet been published. Therefore, this information is exempt under section 22 of the FOIA – Information intended for future publication.

4. As noted in section 3 above, cross-HMG ODA data is collated and published by the Department for International Development. As well as the FCO, other Government Departments including DFID, DEFRA and the MOD, have programme funding in Sri Lanka on both a bilateral and multilateral basis. The information regarding the total amount of all aid pledged or expected to go to Sri Lanka is not held by this department.

The FCO is able to give projected aid spend from the Conflict, Stability and Security Fund which is:

Other FCO-administered ODA spend for Sri Lanka for FY 2016/17 is estimated at £346,245.

FCO programme funds are agreed and allocated year-by-year and therefore information about future years (including 2017/18 and 2018/19) is not yet available. It is anticipated that future allocations during these years will remain at a similar level to FY 2016/17.
