

## **Serious incident, M1 J16 message from Peter Adams**



"I am afraid I have a very tragic incident to share with you.

On Monday morning, 10 October, we lost a supply chain colleague, Robert English.

Robert was helping us convert a stretch of the M1 into a smart motorway. He was the supervisor for a gang upgrading the drainage, so that in the future, what was the hard shoulder will be kept clear of rain water.

We do not yet know the full details and an investigation has been launched. However, what we do understand is that a front loading dumper truck passed the area where Robert was working and struck him. Despite the air ambulance arriving soon after, Robert sadly passed away at the scene.

On hearing this devastating news, I left London to join the team on site near Rugby.

I was joined by the programme director for smart motorways, members from his team, and by the managing directors / chief executives of Costain and GallifordTry. Our point of going to site was to give our support to the team.

On arriving, the emotional impact on so many people was very apparent. We stressed the importance of taking the time they need to come to terms with the emotional trauma, both for them as individuals and for their teams, and that this was more important than thinking about restarting works on site. All construction work on site was stood down following the incident. Professional counselling support is being provided.

We also met with the owner of the company who was undertaking the drainage work as a sub-contract to the Costain and GallifordTry joint venture, for whom this loss had come as a devastating shock.

Our thoughts turned to supporting Robert's family. As I understand, Robert was 47 and leaves behind a wife and three young girls. And it is this fact that makes this tragedy even more personal to me. I am a year younger than Robert. I have two boys of a similar age. When I got home on Monday night and talked to my boys about what had happened, both were moved by just how quickly and dramatically all our lives could change when things just do not go the way they should.

So for me, the smart motorway team, our suppliers, and I hope for you too, we all still need to work together and find ways to prevent these tragic incidents from happening again.




## Occupational Cancers – Raising The Bar 33

The institute of occupational safety and health report that cancer caused by work claims 666,000 lives a year worldwide, this equates to one death every 47 seconds.

Cancer can be caused by a variety of harmful substances, some are widely publicised, for example asbestos, whilst others may be less obvious – stone dust, coal tar, pitches, diesel fumes, solar radiation, metalworking fluids, mineral oils, pesticides, varnishes, paint spraying or some forms of MDF. Recent research shows that even particular circumstances at work can cause cancer – for example, several studies suggest a link between breast cancer and women who do certain types of shift work for many years. The following table provides examples of some occupational cancers and UK deaths in 2005.

Duty of Care experts Turner Kenworthy will be presenting one of their unique mock trials for senior managers and directors of contractors in the Highways England supply chain. If you've seen a mock trial before, it won't have been like this!

This bespoke presentation was originally created for M25 contractor Connect Plus Services, for use as a training tool across the business to illustrate the importance of safe decision making, correct briefing and following safe working practices correctly. Connect Plus Services have kindly given their permission for this presentation to be shown at Highways UK 2016.

Over 90 minutes, starting at 11.30am, the cast of professional actors mixed with real magistrates and barristers, will recreate what can happen when poor decision making on a network maintenance project leads to the death of a repair operative and life changing injuries to a road user.

The fictitious scenario centres around a shared closure with multiple contractors working a night shift.

A number of simple but common mistakes by supervisors, operatives and subcontractors combine with an incursion to produce an outcome which is the nightmare of many an employer in the highways services sector. The presentation will show the events leading up to the incident with video reconstructions, details of the subsequent police investigation, and the prosecution itself – all building towards a verdict by the court jury.

If you are a director or senior manager of a contractor operating in the Highways England supply chain, this is not a presentation you will want to miss.
