

# **NOTICE OF ORDER**

## **WILDLIFE AND COUNTRYSIDE ACT 1981 SECTION 53**

North Lincolnshire Council  
Definitive Map Modification (Restricted Byway 30, Saxby All Saints)  
Order 2015 (1)

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **31 January 2017**.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to modify the Definitive Map and Statement for the area by adding to them a 970 metre long restricted byway from Land Drain at SE98151679 to Saxby All Saints Bridge at SE97241644 via North Carr Lane.

### **Timetable for sending in statements of case and comments**

#### **Within 2 weeks of the start date [by 14 February 2017]**

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

#### **Within 8 weeks of the start date [by 28 March 2017]**

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

**Within 14 weeks of the start date [by 09 May 2017]**

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order(s) must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the "County of Lincoln, Parts of Lindsey (Glanford Brigg)" definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) – namely, the discovery by the authority of evidence that (when considered with all other relevant evidence available to them) shows that a right of way that is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a restricted byway – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 14 October 2015.
2. The "County of Lincoln, Parts of Lindsey (Glanford Brigg)" definitive map and statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is confirmed and may be cited as the "Definitive Map Modification (Restricted Byway 21, Saxby All Saints) Order 2015(1)".

### PART I

#### Modification of Definitive Map

##### *Description of path or way to be added*

*A – B, as indicated on the map:* a 970-metre-long restricted byway of a width of between seven metres and thirty metres, as shaded grey on the order map, commencing at a point along North Carr Lane, this being the eastern end of the bridge over Land Drain at grid reference SE98151679, and proceeding over said bridge to continue westwards along the course of North Carr Lane to a point on the eastern bank of the River Ancholme (New Cut) adjacent to Saxby All Saints Bridge at grid reference SE97241644.

### PART II

#### Modification of Definitive Statement

##### *Variation of particulars of path or way*

A 970-metre-long restricted byway of a width of between seven metres and thirty metres, as shaded grey on the order map, commencing at a point along North Carr Lane, this being the eastern end of the bridge over Land Drain at grid reference SE98151679, and proceeding over said bridge to continue westwards along the course of North Carr Lane to a point on the eastern bank of the River Ancholme (New Cut) adjacent to Saxby All Saints Bridge at grid reference SE97241644.
