BYE-LAWS

Made by His Majesty's Principal Secretary of State for the War Department under the provisions of the Military Lands Acts, 1892 to 1903, with the consent of the Board of Trade and the Wareham and Purbeck Rural District Council, for regulating the use of the above-named ranges.

1. The land (hereinafter called the "land area") situate in the Parishes of East and West Lulworth and the foreshore and sea abutting thereon (hereinafter called the "sea area") within the limits hereinafter mentioned and described, which together constitute the danger area of the Range, shall be closed to all persons to allow of firing from the Range while the warning signals are hoisted in accordance with Bye-law 6.

2. The land area lies to the South-West of East Lulworth, and to the East of West Lulworth. The area is quadrilateral in shape, with its seaward base (about a mile and a quarter long) on the line of High Water and its inland base (about 1,700 yards long) about 1 mile inland.

Each side of the land area is marked by two triangular-shaped Beacons, more particularly referred to below, which are painted white to make them as conspicuous as possible:

By a line commencing at a point on High Water Mark just below a triangular-shaped Beacon, painted white, on the west side of Arish Mell Gap, and running in a North-Westerly direction for a distance of about 1,370 yards, through the aforementioned triangular-shaped Beacon and a second triangular-shaped Beacon, also painted white, erected just South of Maiden Plantation, until a point is reached on the War Department Boundary on the West side of Broom's Plantation about 580 yards South-East of the East-West Lulworth Road; thence—

A flagged pole is sited at the highest point of Bindon Hill, and a Look-out is established at this point. Two other Lookouts are situated :-

(a) On the East side of Bindon Hill, by Arish Mell.

(b) On the West side of Bindon Hill, where the War Department boundary line passes over the hill. Other flagged poles are sited as follows:-

(a) About the middle of the Northern boundary of the Range.

(b) On the East of the Range, by Sea Vale Farm.

(c) On the East of the Range, by Arish Mell.

(d) On the West of the Range, where the War Department boundary line passes over Bindon Hill.

(e) On the West of the Range, near West Lulworth Reservoir.

- (g) Where the Roman Road from West Lulworth over Bindon Hill first touches the War Department area.

- 4. The sea area, which extends out to sea for about 4,000 yards from High Water Mark, is a prolongation of the Eastern and Western boundaries of the land area.

East of Lulworth Cove 360° (N. 13° 42' E. Mag.)

Note.—An observer at sea will be outside the sea area if he keeps about 2½ miles from High Water Mark.

NOTICES.

5.—(a) No firing will take place on this range on Saturdays, Sundays and Bank Holidays. Firing will normally be carried out daily from Monday to Friday, between the hours of 10 a.m. and 3.30 p.m.

- (d) In order to avoid the possibility of accident due to the miscarriage or loss of the programme of firing, or the amendments thereto through unforeseen circumstances, the land and sea areas shall be deemed to be closed during such time as the signal flags are hoisted in accordance with Bye-law No. 6 subject to the issue of the notices referred to in sub-clauses (b), (c) and (e).
- (e) Firing may, if necessitated by exceptional military requirements, take place at other times than those laid down in (a)

13. In the event of any vessel or aircraft being from any cause within the sea area while closed, the Master or Pilot or other person in charge thereof shall use his utmost endeavours to pass out of the sea area without loss of time.

14. No person shall trawl, dredge, or search for, or otherwise interfere with any shot, shell or other projectile, or portions thereof, within either the land area or the sea area at any time, or take or retain, or be in possession of any such shot, shell or other projectile, or portions thereof, found within the said land area or the sea area.

Any person who, when trawling, dredging, or in any manner whatsoever, shall come into possession of any such shot, shell or other projectile, or portions thereof, within the sea area, shall not retain them, but shall immediately return them in their then condition, and without tampering with them, into the water.

Provided nevertheless that this Bye-law shall not apply in the case of persons who recover projectiles under written instructions from the local Military Authority.

 - (ii) To remove from the land area or the sea area any vehicle, animal, vessel, aircraft or thing found therein in contravention of any of these Bye-laws, and any such vehicle, animal, vessel, aircraft or thing shall be liable to forfeiture as mentioned in the aforesaid Acts.

16. Any person doing anything prohibited by or otherwise contravening any of the preceding Bye-laws, numbered 7, 8, 9, 10, 11, 12, 13 and 14 respectively, shall be deemed to commit an offence against the same, and is, under the said Acts, liable on conviction to a fine not exceeding Five Pounds.

- 6. The signal that the land and sea areas are closed will be given by hoisting red flags on the flagstaffs at the following places:—

 - (3) On the Eastern side of the Danger Area, near Sea Vale
 - (4) On the Western side of the Danger Area, near West
 - (5) On the East of the Range, by Arish Mell.
 - (6) On the West of the Range, where the War Department boundary line passes over Bindon Hill.
 - (7) Near the Barn, South of Bindon Hill. authorior adl' di
 - (8) Where the Roman Road from West Lulworth over Bindon Hill first touches the War Department area.

- 7. During the time the land and sea areas are closed as aforesaid all footpaths within the land area will be stopped up and no person shall enter or remain within either area, nor bring, take nor suffer to remain therein any vehicle, animal, vessel, aircraft or thing except as provided in Bye-laws 8 and 19, and except that any fishermen's gear may be allowed to remain therein, at the owner's risk.
- 8. No person, without the authority of the Commanding Royal Engineer, Wessex Area (East), R.E. Office, Milldam Barracks, Portsmouth, shall use the said land area for the purpose of grazing any horse, cow, sheep or other animal.
- 9. No vessel shall be employed in fishing in any part of the sea area while closed.
- 10. No pleasure boat shall cruise in any part of the sea area while closed.
- 11. No vessel shall anchor or remain anchored in or ground on any part of the sea area while closed.
- 12. No aircraft shall alight on, remain in or travel upon the sea area while closed.

GENERAL.

- 17. While any vessel or aircraft is within the sea area all firing will cease, and a second red flag will be hoisted below the first flag on the pole at the Look-out on the top of Bindon Hill to notify the Master or Pilot or other person in charge of the vessel or aircraft that he is within the Danger area.
- . 18. If any vessel or craft from the Admiralty Torpedo Range, flying a red flag, is seen in or near the danger area, all firing will at once cease, and will not be re-opened until the said craft has been seen to haul down the red flag and leave the vicinity.
 - 19. These Bye-laws shall not apply to :-
 - (a) Any vessel entering or passing through the sea area in the ordinary course of navigation.
 - (b) Any vessel compelled to enter or unable to quit the sea
 - (c) Any vessel employed in tending, placing or replacing any of the mark buoys or other aids to navigation within the sea area.
 - (d) H.M. Ships of War, H.M. Aircraft or any vessel or aircraft employed under Admiralty or Air Council Authority.
 - (e) Any aircraft compelled to alight on or unable to quit the
- 20. "Vessel" in these Bye-laws includes ship, yacht, lighter, boat and craft of every kind, and whether navigated by steam, motor, sail, oars, or otherwise.
- 21. "Aircraft" in these Bye-laws includes all balloons whether fixed or free, kites, airships, aeroplanes, seaplanes, flying boats and other flying machines.
- 22. Copies of these Bye-laws can be obtained, and a plan showing the danger area of the range can be inspected, at the Offices of the Commanding Royal Engineer, Wessex Area (East), R.E. Office, Milldam Barracks, Portsmouth, and the D.C.R.E., R.E. Office, Bovington Camp, Wool, Dorset (Postal address, Bovington Camp, near Wareham), the Mercantile Marine Offices at Weymouth and Poole, and at the Coastguard Stations at Kimmeridge, Osmington, Portland Bill, St. Albans Head, Swanage and Weymouth.
- 23. These Bye-laws shall come into force on the First day of September, One thousand nine hundred and twenty-nine, and shall remain in force until the termination or expiry of the lease of lands at Lulworth granted by Mr. Humphrey Joseph Weld (by his Committee) to His Majesty's Principal Secretary of State for

the War Department, dated the thirteenth day of October, One thousand nine hundred and twenty-seven. The aforesaid lease will terminate on the thirty-first day of August, One thousand nine hundred and thirty-four, but may be terminated by the Lessor or the said Secretary of State either on the thirty-first day of August, One thousand nine hundred and thirty-three, or the thirty-first day of August, One thousand nine hundred and thirty-two.
