# **Democratic People's Republic of Korea**

### Introduction

1. Council Regulation (EC) 329/2007 ("the Regulation") imposing financial sanctions against the Democratic People's Republic of Korea has been amended.

# Notice summary (Full details are provided in the Annex to this Notice)

# What you must do

- 4. You must:
  - i. check whether you maintain any accounts or hold any funds or economic resources for the persons set out in the Annex to this Notice;
  - ii. freeze such accounts, and other funds or assets;

- iii. refrain from dealing with the funds or assets or making them available to such persons unless licensed by the Office of Financial Sanctions Implementation (OFSI);
- iv. report any findings to OFSI, together with any additional information that would facilitate compliance with the Regulation;
- v. provide any information concerning the frozen assets of designated persons that OFSI may request. Information reported to OFSI may be passed on to other regulatory authorities or law enforcement.
- 5. Where a relevant institution has <u>already reported</u> details of accounts, other funds or economic resources held frozen for designated persons, <u>they are not required to report</u> these details again.
- 6. Failure to comply with financial sanctions legislation or to seek to circumvent its provisions is a criminal offence.

### Legislative details

- 7. On 13 June 2017 Commission Implementing Regulation (EU) No 2017/993 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L 149, 13.6.2017, p.67) by the Council of the European Union.
- 8. The Amending Regulation amended Annex V to the Regulation with effect from 14 June 2017.
