

NOTICE OF ORDER

HIGHWAYS 1981 SECTIONS 118 & 119

East Riding Of Yorkshire Council
(Woodmansey Footpath No. 12); Public Path Diversion Order 2016; &
(Woodmansey Footpath No. 19); Extinguishment Order 2016

Notice is hereby given that the above referenced Orders have been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Orders.

The **start date** for the above Orders is **20 June 2017**.

Consideration of the Orders will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Orders, if confirmed without modifications, will be to:

- **divert** a section of Woodmansey Footpath No. 12 some 440 metres in length commencing west of Park Grange Farm at Grid Reference TA 0448 3775 and leading south-easterly then easterly around the southern side of The Old Granary for some 255 metres then north-easterly to join a track turning easterly along the track for some 35 metres then leading east-north-easterly for some 133 metres across the drain then north-easterly for some 17 metres to Grid Reference TA 0487 3778 **to a line** some 460 metres in length commencing west of Park Grange Farm at Grid Reference TA 0448 3775 leading easterly along a track for some 250 metres turning northerly for some 45 metres then easterly for some 140 metres to a bridge across the drain then south-westerly for some 10 metres to Grid Reference TA 0487 3778, as shown on the Order map; &
- **extinguish** the full length and width (1.5 metres) of Woodmansey Footpath No. 19 commencing on Footpath No. 12 west of Park Grange Farm at Grid Reference TA 0451 3773 and leading south-easterly for some 575 metres to Grid Reference TA 0484 3727 west of Ivy House, as shown on the Order map.

Timetable for sending in statements of case and comments

Within 2 weeks of the start date [by 04 July 2017]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Orders.

Within 8 weeks of the start date [by 15 August 2017]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Orders.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Orders (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within 14 weeks of the start date [by 26 September 2017]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Orders must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Orders must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.







This Order is made by The East Riding of Yorkshire Council ("the Authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the owner or occupier of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of the way should be diverted.

Woodmansey Parish Council have been consulted and have consented to the making of the Order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situated at Woodmansey in the East Riding of Yorkshire and shown by a bold continuous line on the map contained in this Order and described in **Part 1** of the Schedule to this Order shall be stopped up after seven (7) days from the date of confirmation of this Order.
2. There shall at the end of seven (7) days from the date of confirmation of this Order be a public footpath over the land situate at Woodmansey described in **Part 2** of the Schedule and shown by a bold broken line on the map attached to this Order.





SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A section of Woodmansey Footpath No. 12 some 440 metres in length commencing west of Park Grange Farm at Grid Reference TA 0448 3775 (Point A on the Map) and leading south-easterly then easterly around the southern side of The Old Granary for some 255 metres then north-easterly to join a track turning easterly along the track for some 35 metres then leading east-north-easterly for some 133 metres across the drain then north-easterly for some 17 metres to Grid Reference TA 0487 3778 (Point B on the Map). Width of 2 metres between points A and G and 1.5 metres between points G and B.

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

A section of footpath some 460 metres in length commencing west of Park Grange Farm at Grid Reference TA 0448 3775 (Point A on the Map) leading easterly along a track for some 250 metres turning northerly for some 45 metres then easterly for some 140 metres to a bridge across the drain then south-westerly for some 10 metres to Grid Reference TA 0487 3778 (Point B on the Map).

Width of new path or way


The new footpath will have a width of 3 metres between points A and H and 2 metres between point H and B.
